










#### Dimensional Drawing <sup>8)</sup>







#### Tape and Reel <sup>9)</sup>



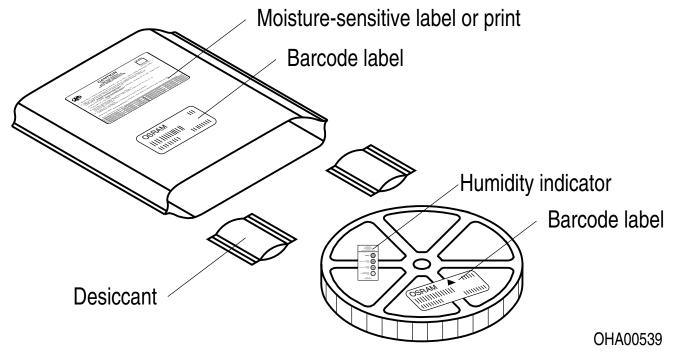
