



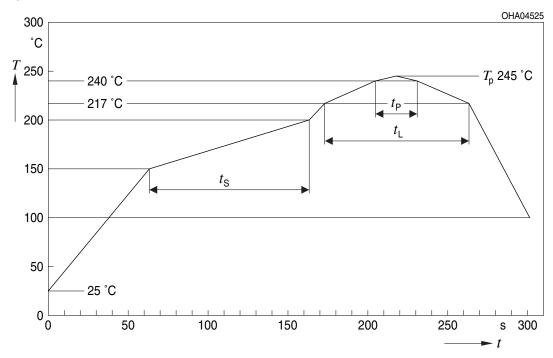
Component Location on Pad
