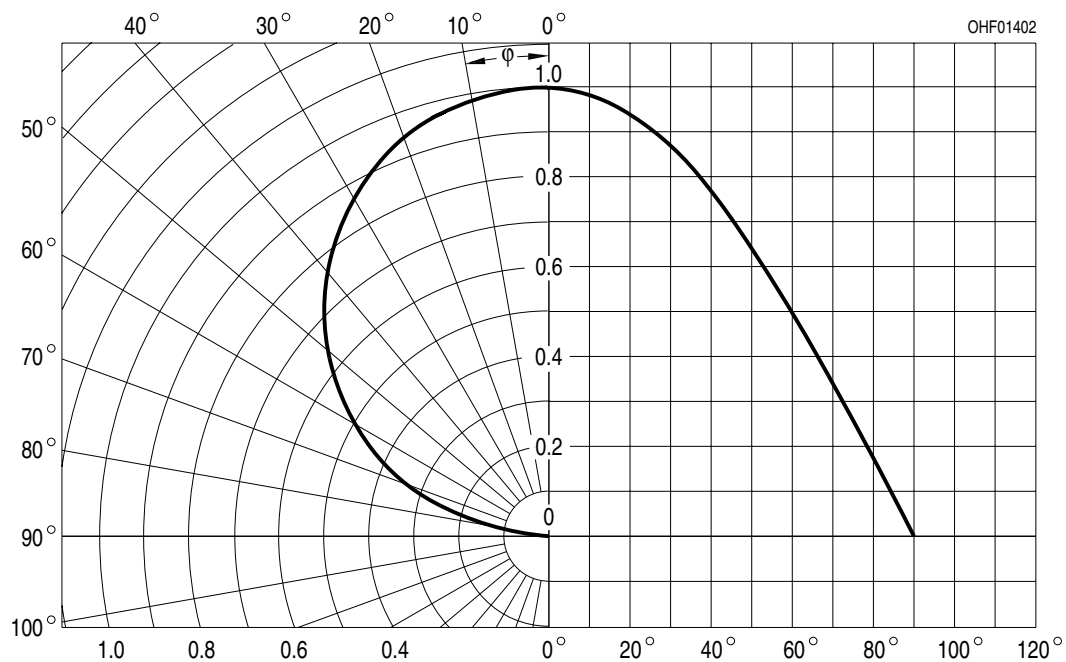

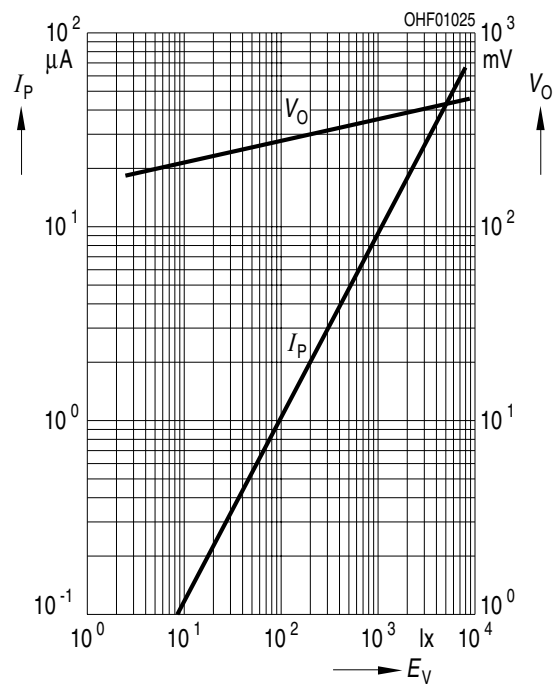

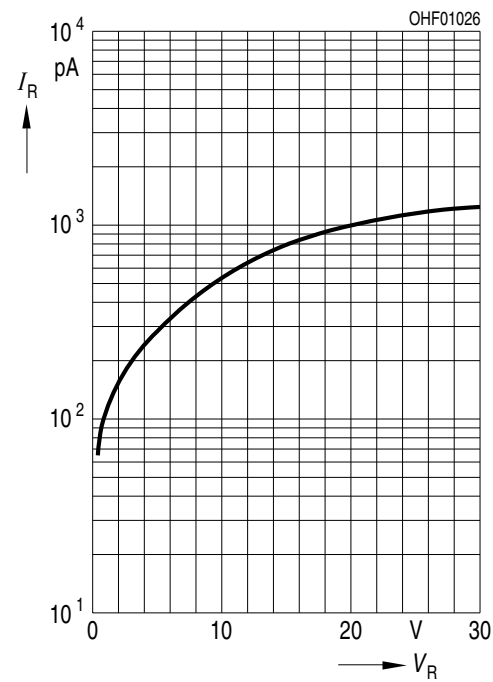

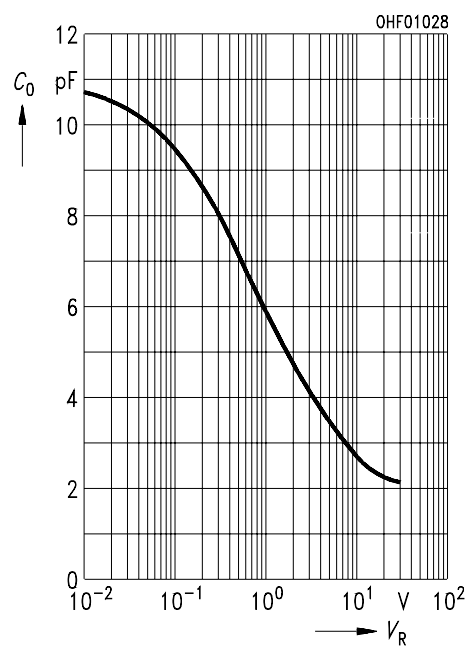

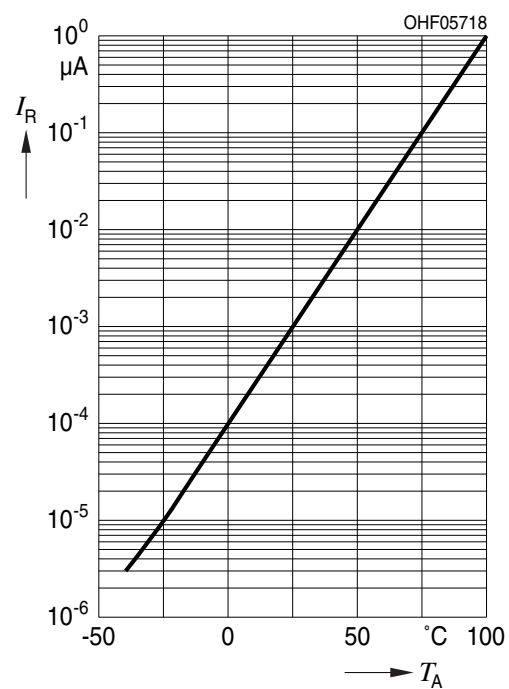

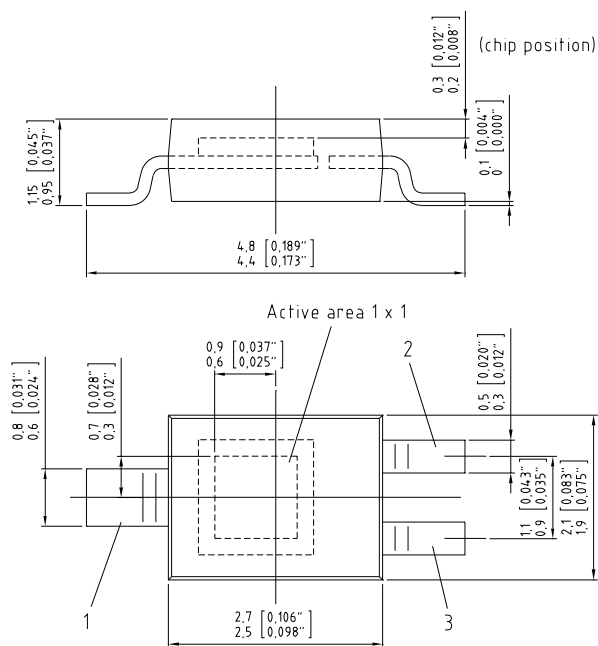

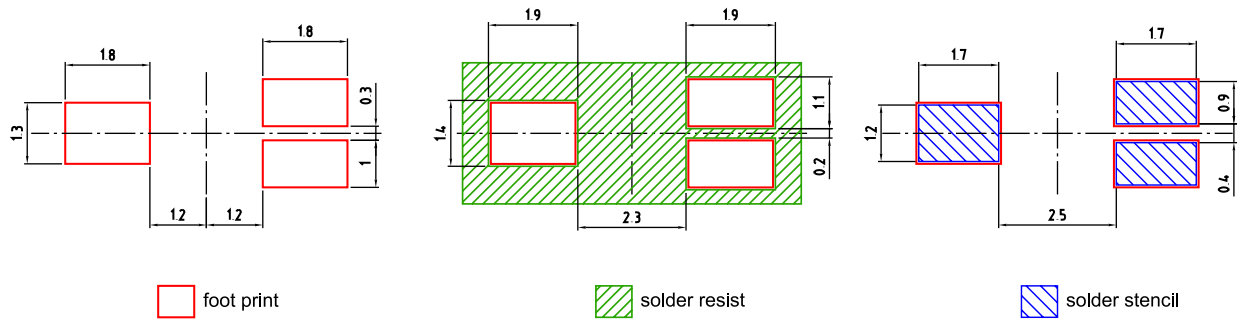

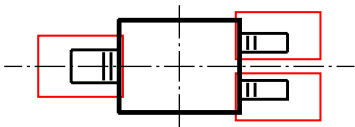

## Notes
