


Relative Spectral Emission⁶⁾






Relative Luminous Flux ^{6), 7)}




Forward Voltage ⁶⁾




Dominant Wavelength ⁶⁾




Max. Permissible Forward Current

Permissible Pulse Handling Capability



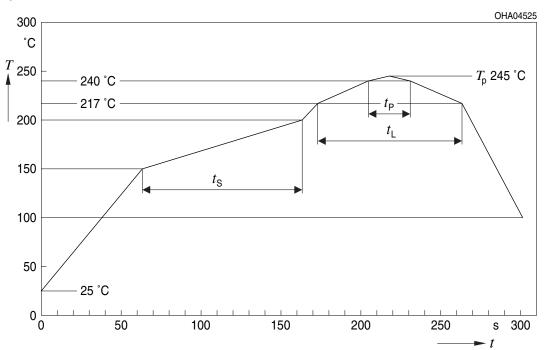





- ³⁾ Wavelength: The wavelength is measured at a current pulse of typically 25 ms, with an internal reproducibility of ±0.5 nm and an expanded uncertainty of ±1 nm (acc. to GUM with a coverage factor of k = 3).
