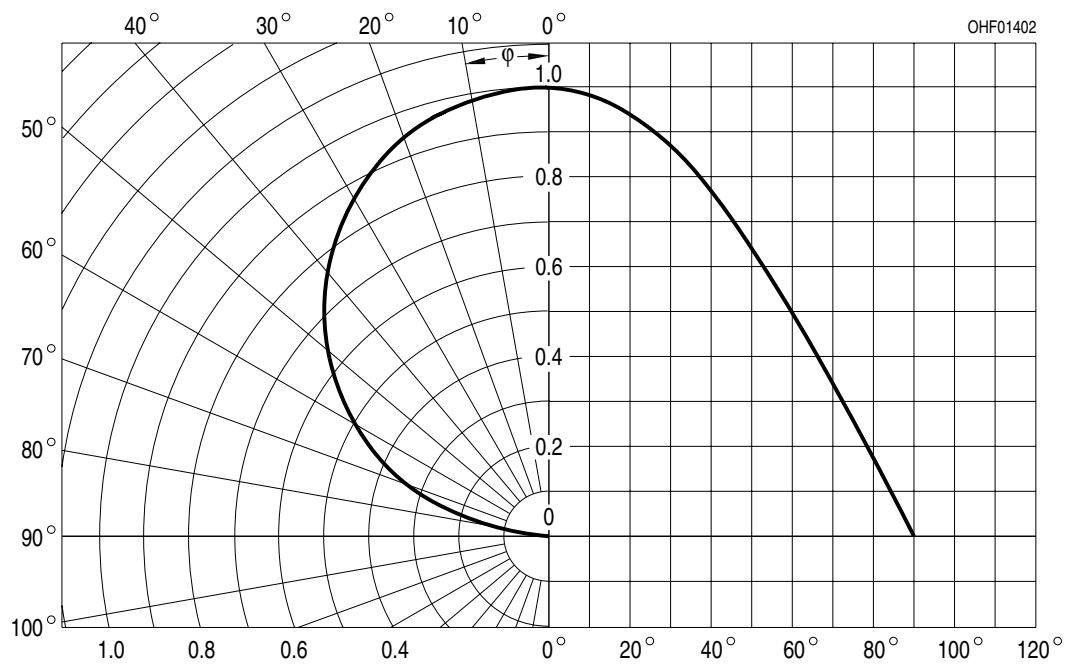

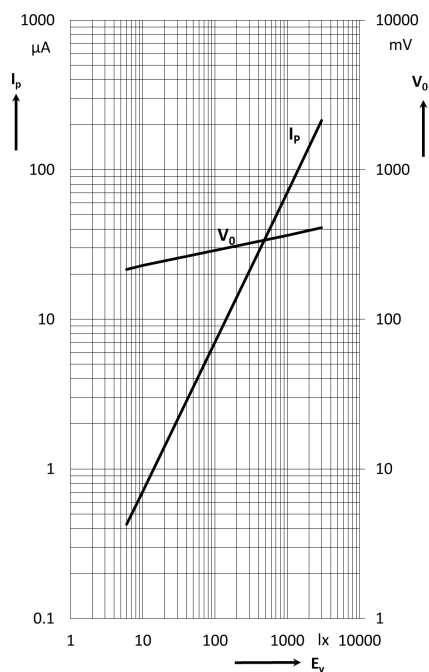

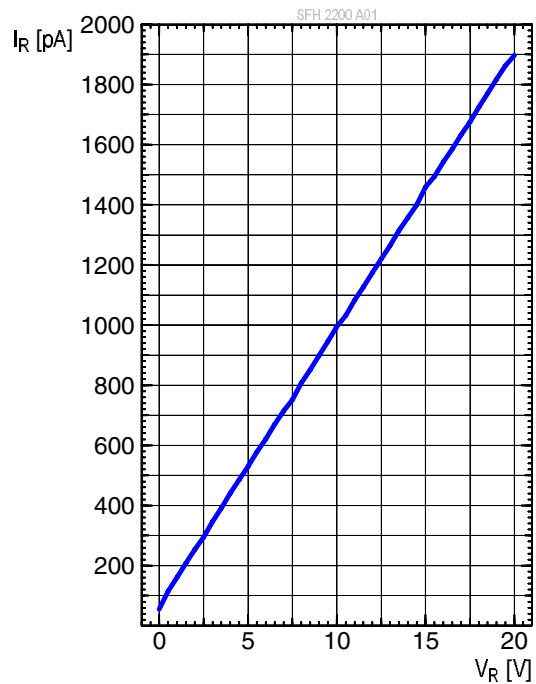

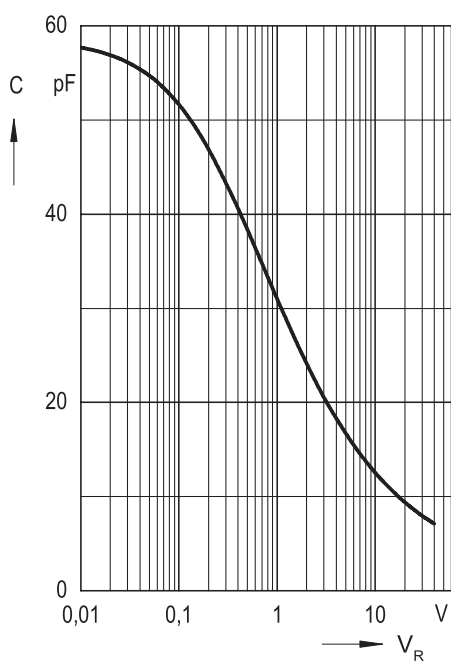

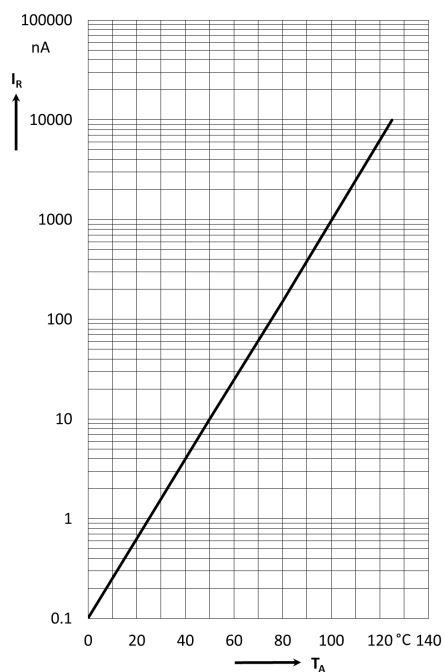

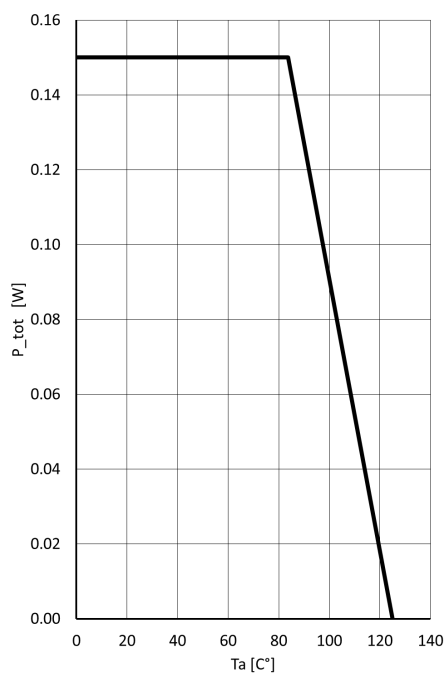

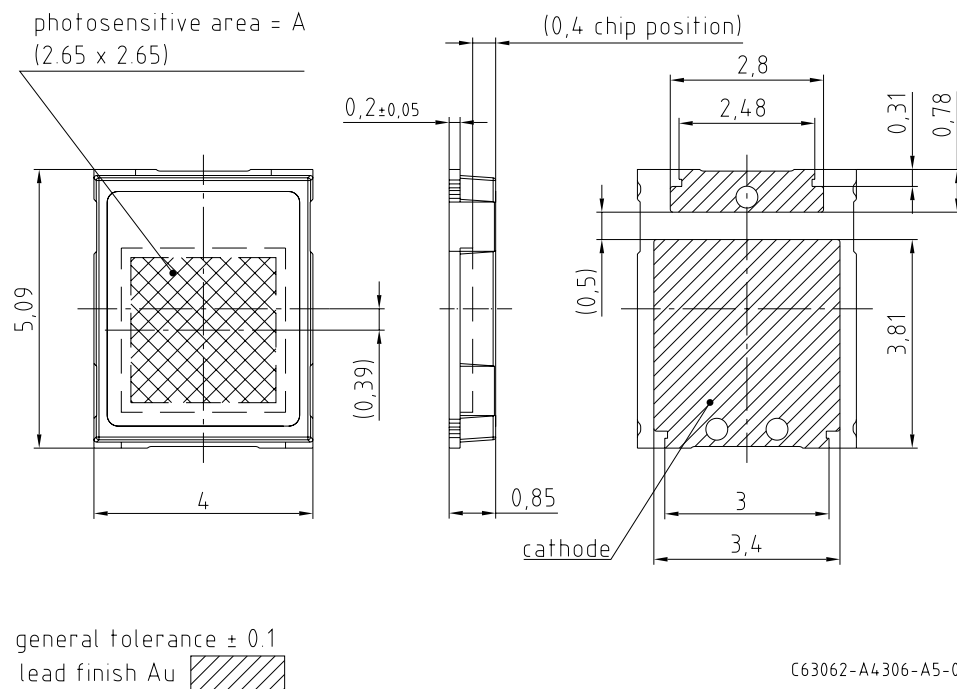

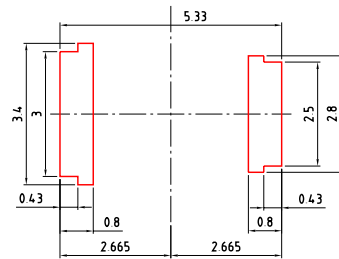
## Dimensional Drawing <sup>4)</sup>



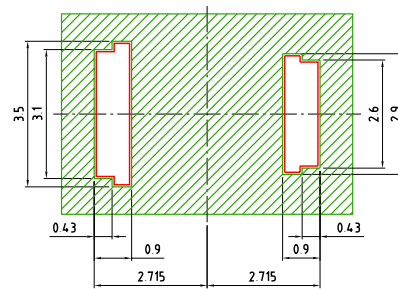

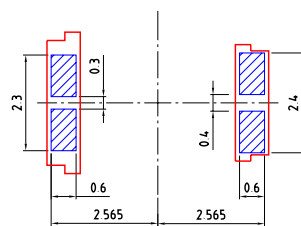
## Recommended Solder Pad <sup>4)</sup>

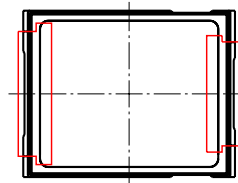


 solder resist

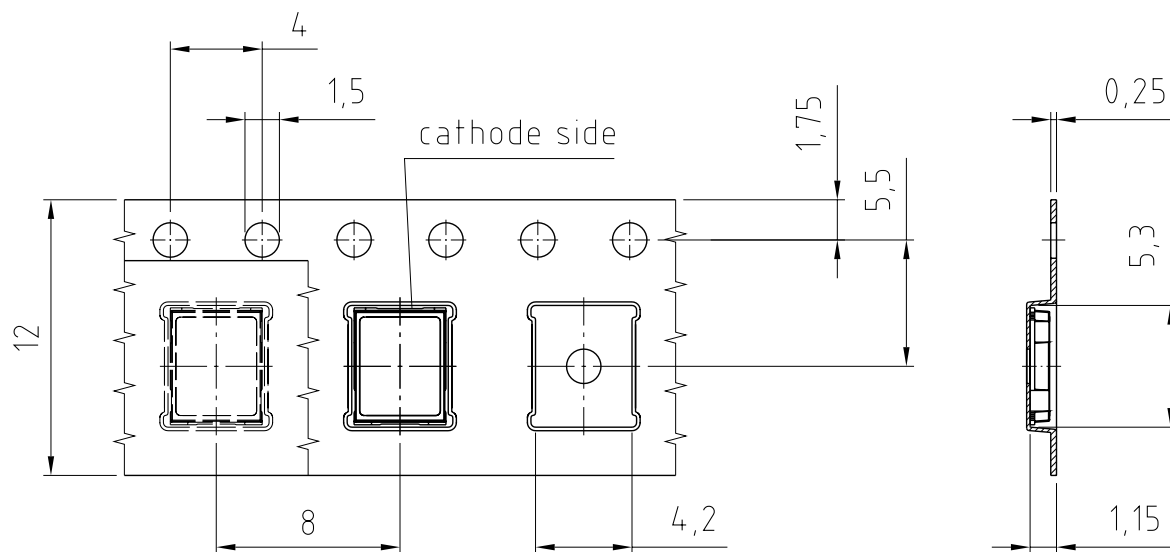

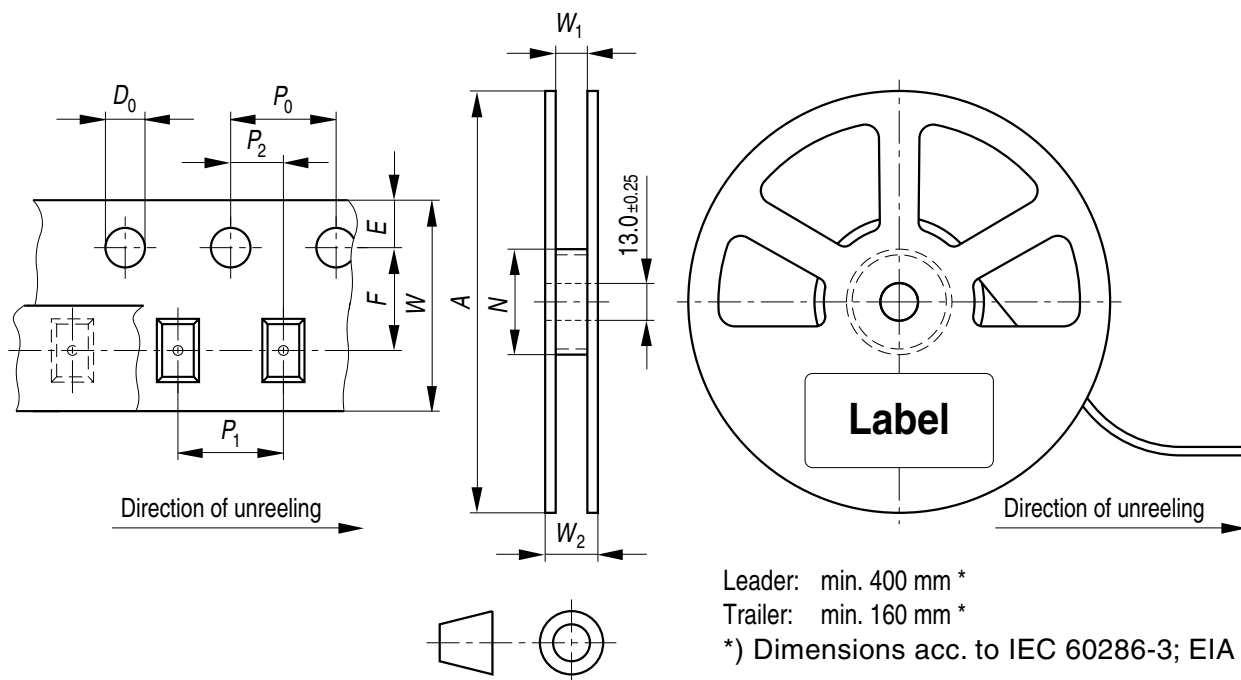

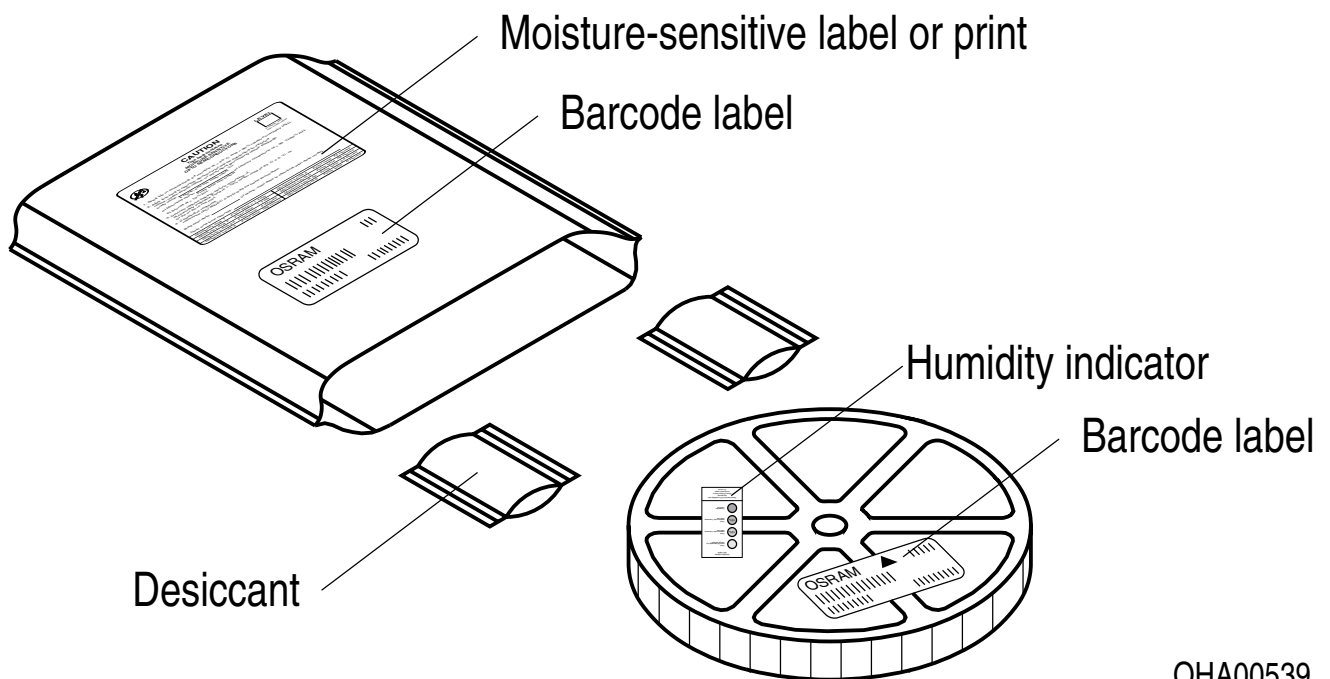

## Notes
