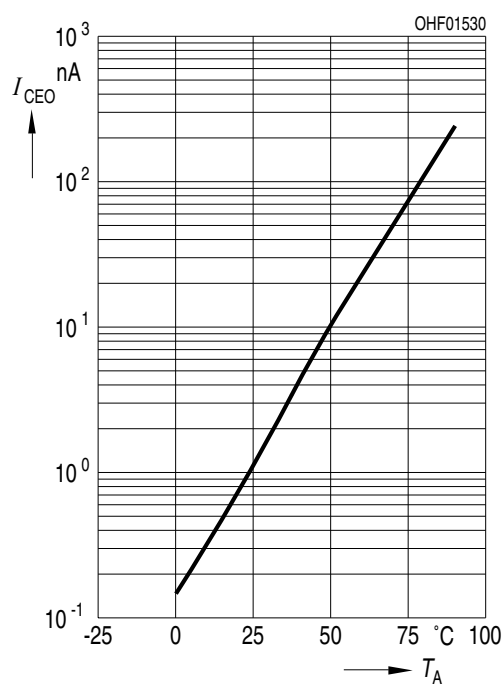

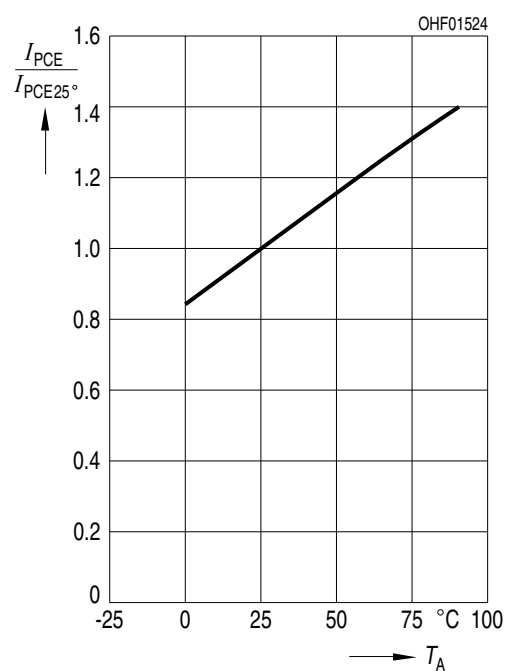

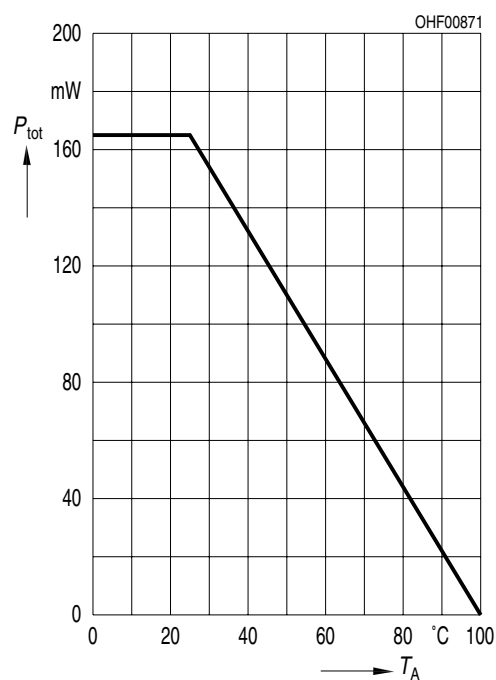

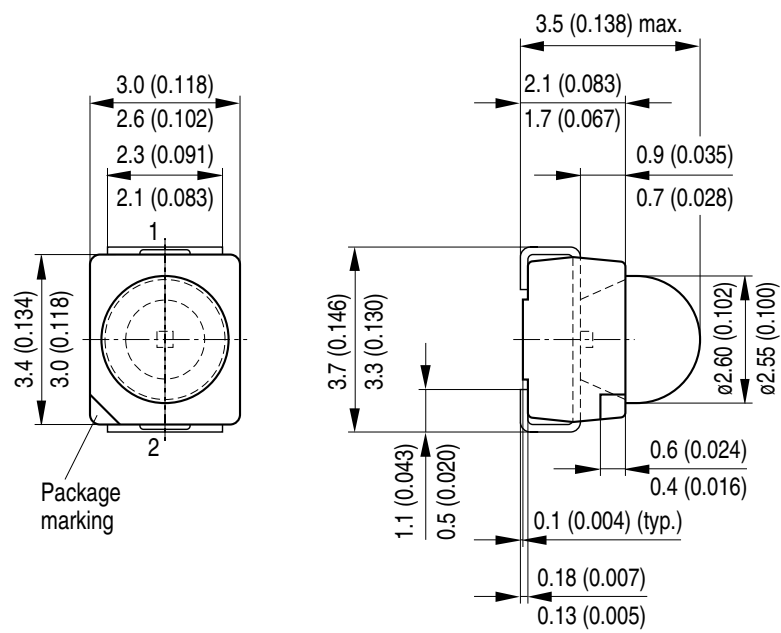


## Power Consumption

## Notes
