






#### Radiation Characteristics 8), 9)



#### Forward current <sup>8), 9)</sup>




#### Relative Radiant Intensity <sup>8), 9)</sup>






#### Max. Permissible Forward Current


#### Permissible Pulse Handling Capability






#### Recommended Solder Pad<sup>10</sup>





#### Tape and Reel <sup>11)</sup>

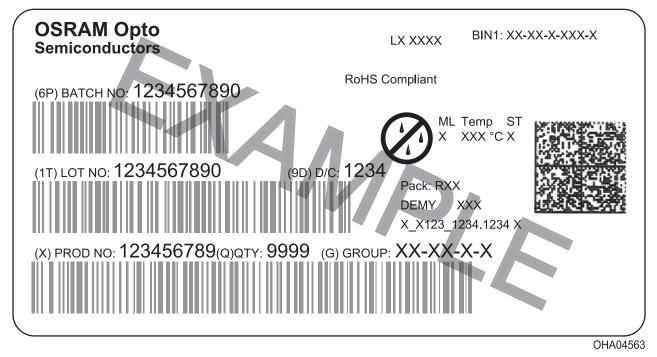


