






#### Radiation Characteristics 7), 8)




#### Forward current <sup>7), 8)</sup>



#### **Relative Radiant Intensity** <sup>7), 8)</sup>








#### Permissible Pulse Handling Capability

Component Location on Pad

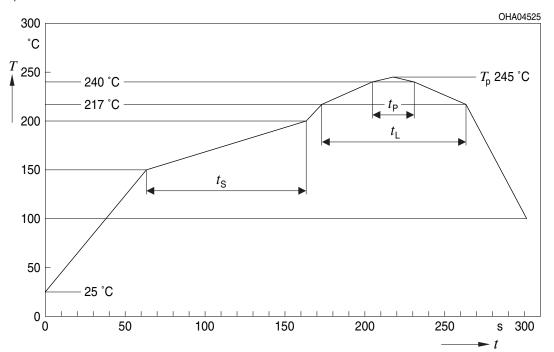





#### Tape and Reel <sup>10)</sup>



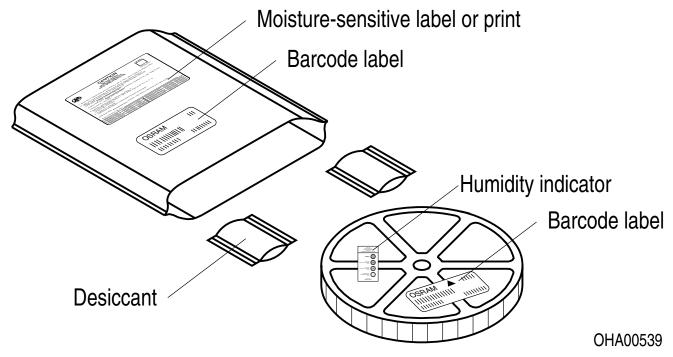
