






#### Radiation Characteristics 8), 9)



#### Forward current <sup>8), 9)</sup>




#### **Relative Radiant Intensity**<sup>8), 9)</sup>









Moisture-sensitive product is packed in a dry bag containing desiccant and a humidity card according JEDEC-STD-033.


