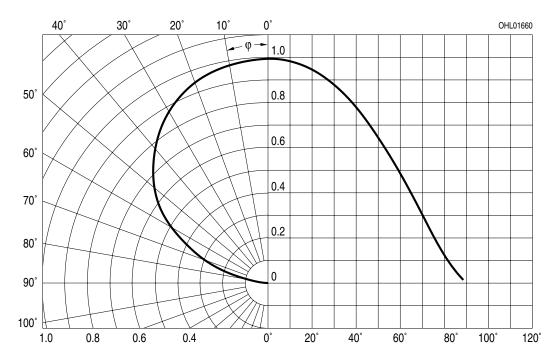

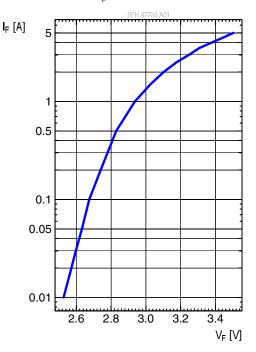

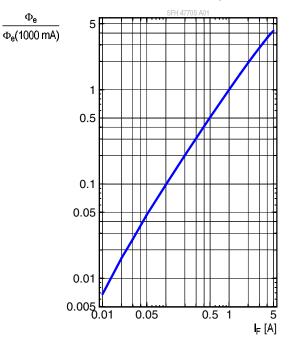

Relative Total Radiant Flux 7), 8)

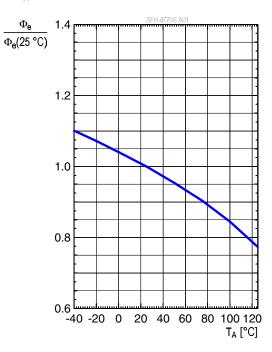

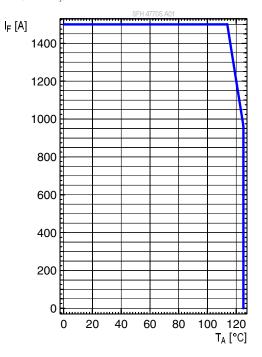
Relative Total Radiant Flux⁷⁾

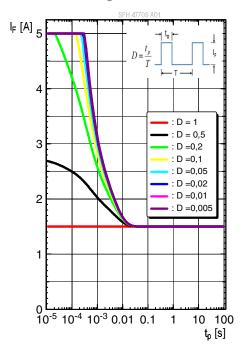
Max. Permissible Forward Current

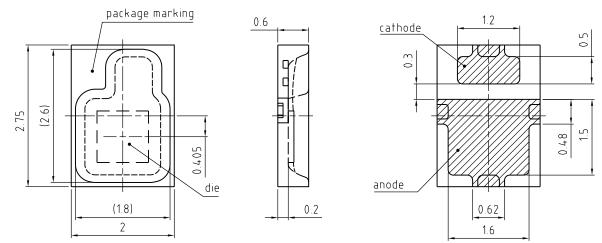
Permissible Pulse Handling Capability

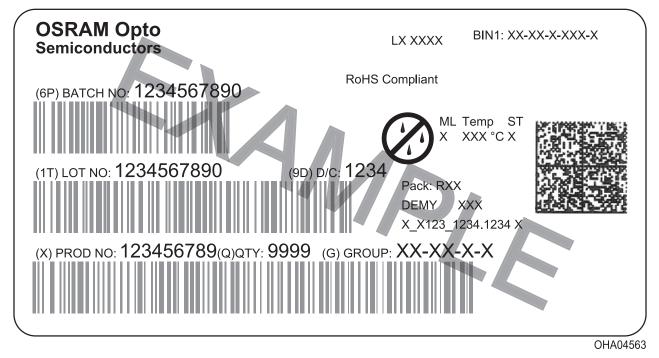

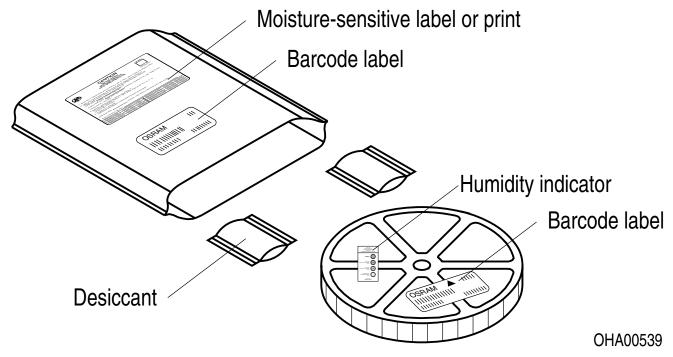
