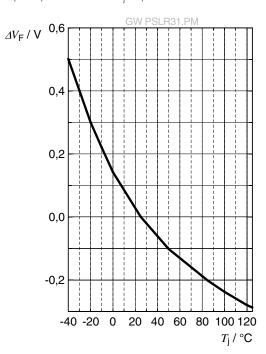
Chromaticity Coordinate Shift ⁶⁾

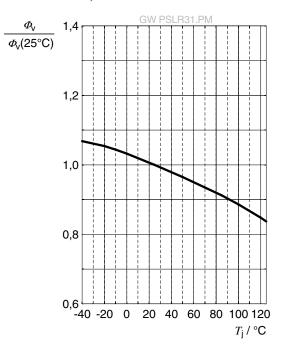

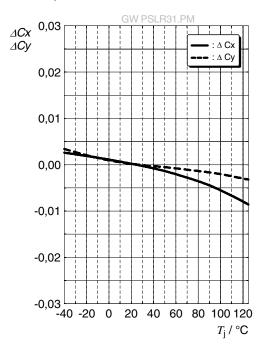
Relative Luminous Flux⁶⁾
