




Relative Spectral Emission⁴⁾













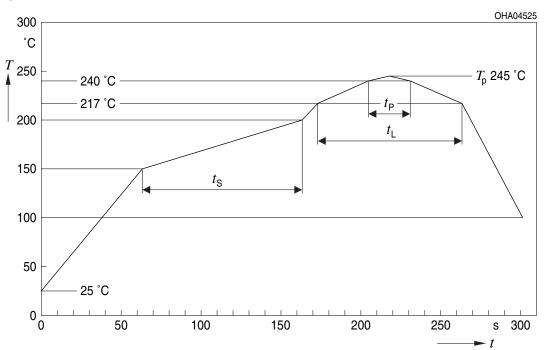




