




- 1) Input & Output terminal block connector






Output Load De-rating VS Surrounding Air Temperature




Fig. 1 De-rating for Vertical and Horizontal Mounting Orientation > 60°C de-rate power by 2.5% / °C



Output Load De-rating VS Input Voltage




 No output power de-rating across the entire input voltage range

Assembly & Installation

Mounting

- Mounting holes for power supply assembly onto the mounting surface.

 Power supply shall be mounted on minimum 2 mounting holes using M3 screw minimum 5 mm (0.20 inch) length.
- **(B)** The power supply shall be mounted on minimum 2 mounting holes using M3 screw only. The screw penetration into the chassis must be \leq 2 mm (0.07 inch).
- C Connector.
- This surface belongs to customer's end system or panel where the power supply is mounted.




• Use flexible cable (stranded or solid), AWG no. 20-16. Recommended torque at the connector shall be 5 Kgf.cm. The insulation stripping length should not exceed 0.275" or 7 mm

Installation of Mounting Accessories



- Only use M3 screw ≤ 2 mm (0.07 inch) through the base mounting holes. This is to keep a safe distance between the screw and internal components.
- Recommended mounting tightening torque: 4~8 Kgf.cm (3.47~6.94 lbf.in)

Safety Instructions

- To ensure sufficient convection cooling, always maintain a safety distance of >20 mm (0.78 inch) from all ventilated surfaces while the device is in operation.
- The device is not recommended to be placed on low thermal conductive surface, for example, plastics.



Start-up Time

The time required for the output voltage to reach 90% of its final steady state set value, after the input voltage is applied.

Rise Time


The time required for the output voltage to change from 10% to 90% of its final steady state set value.

Hold-up Time

Time between the collapse of the AC input voltage, and the output falling to 95% of its steady state set value.

Inrush Current


Inrush current is the peak, instantaneous, input current measured and, occurs when the input voltage is first applied. For AC input voltages, the maximum peak value of inrush current will occur during the first half cycle of the applied AC voltage. This peak value decreases exponentially during subsequent cycles of AC voltage.



Dynamic Response

The power supply output voltage will remains within $\pm 5\%$ of its steady state value, when subjected to a dynamic load from 0% to 100% of its rated current.



Overload & Overcurrent Protections (Auto-Recovery)

The power supply's Overload (OLP) and Over current (OCP) Protections will be activated when output current (Io) exceeds its specification as defined on Page 3 under "Protections. In such occurrence, the output voltage (Vo) will start to droop and once the power supply has reached its maximum power limit, the protection is activated and the power supply will go into "Hiccup mode" (Auto-Recovery). The power supply will recover once the fault condition of the OLP and OCP is removed and Io is back within the specifications.




It is not recommended to prolong the duration of I_0 when it is less than OLP/OCP point, but greater than 100%, since it may cause damage to the PSU.

Short Circuit Protection (Auto-Recovery)

The power supply's output OLP/OCP function also provides protection against short circuits. When a short circuit is applied, the output current will operate in "Hiccup mode", as shown in the illustration in the OLP/OCP section on this page. The power supply will return to normal operation after the short circuit is removed

Overvoltage Protection (Auto-Recovery)

The power supply's overvoltage circuit will be activated when its internal feedback circuit fails. The output voltage shall not exceed its specifications defined on Page 3 under "Protections".



Over Temperature Protection (Auto-Recovery)

As described in load de-rating section, the power supply also has Over Temperature Protection (OTP). In the event of a higher operating temperature at 100% load, the power supply will run into OTP when the operating temperature is beyond what is recommended in the de-rating graph. When activated, the output voltage will go into bouncing mode until the temperature drops to its normal operating temperature as recommended in the de-rating graph.
