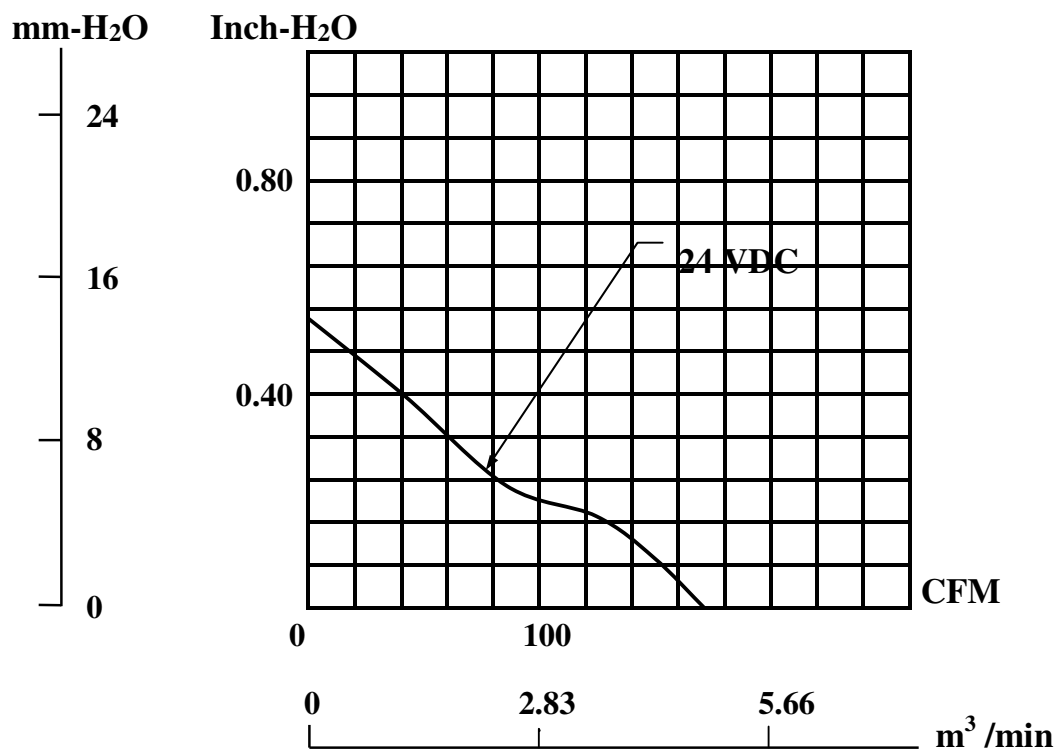

PRESSURE**

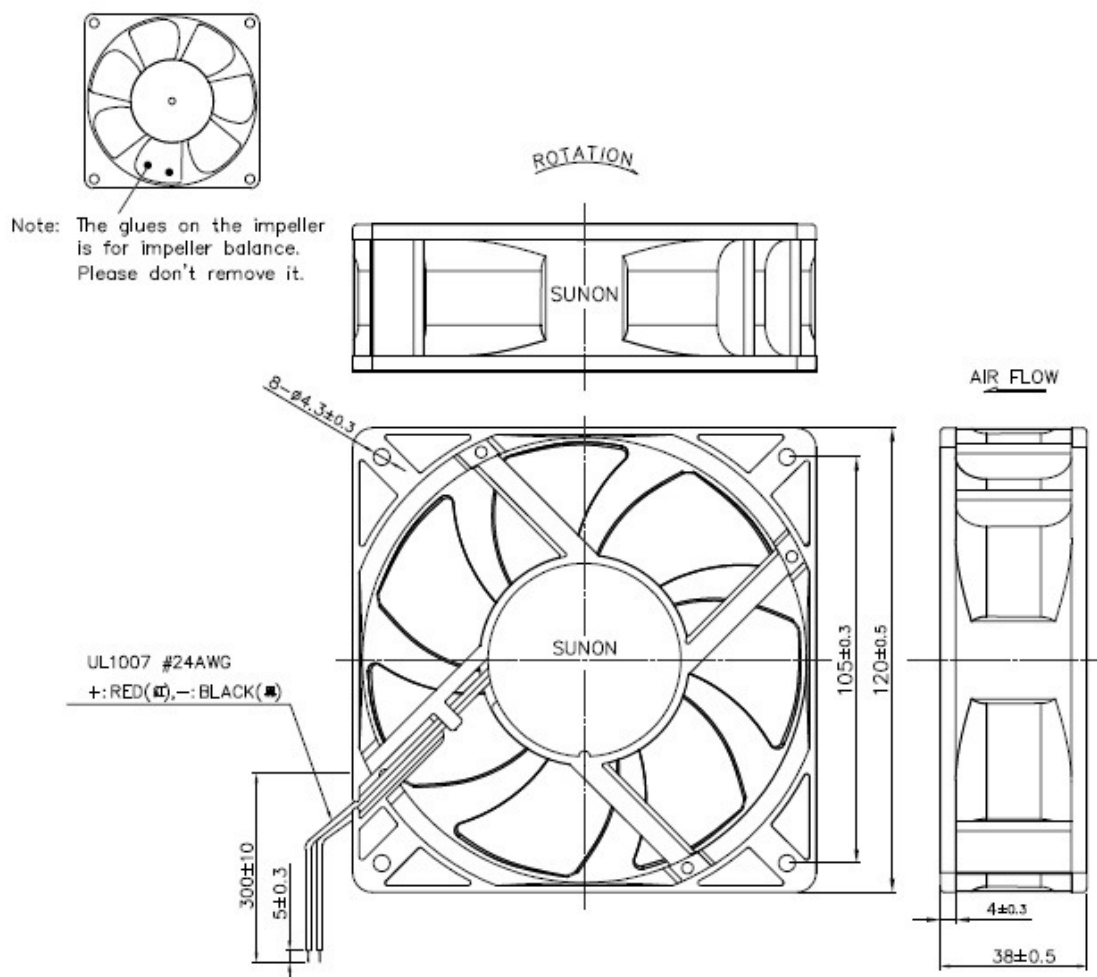
