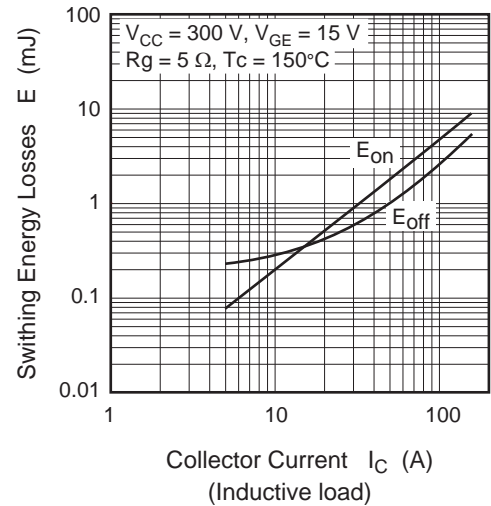

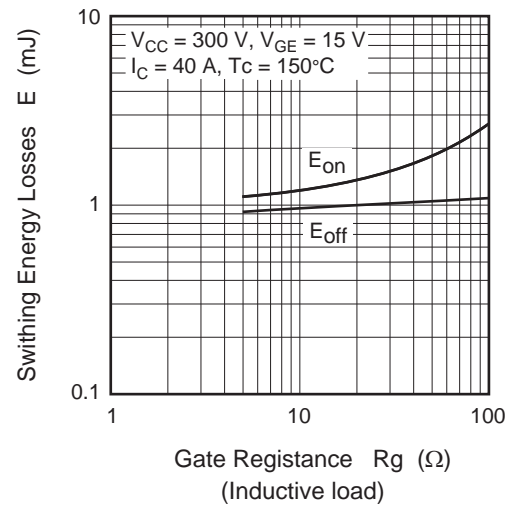
Switching Characteristics (Typical) (2)



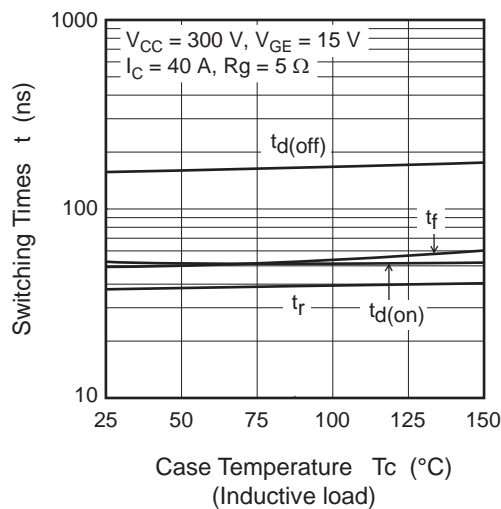

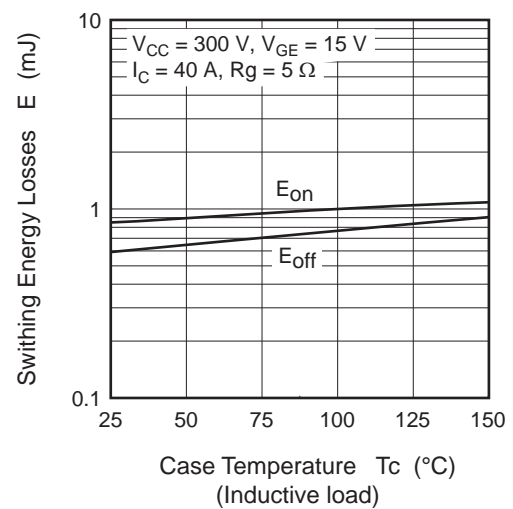

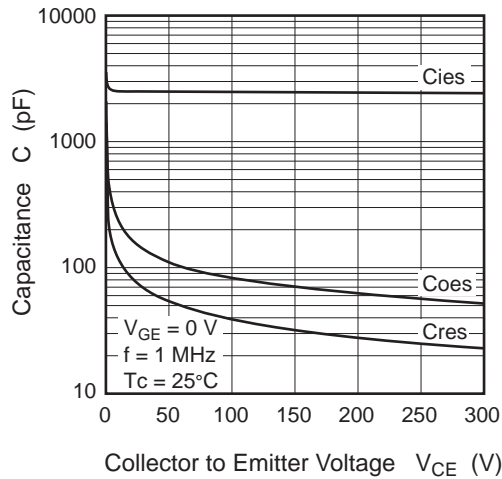

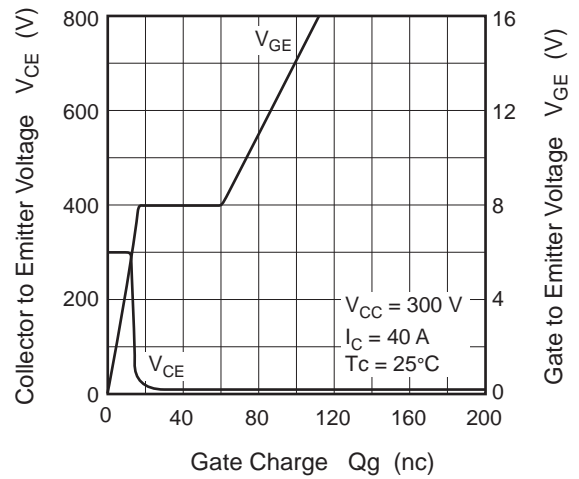

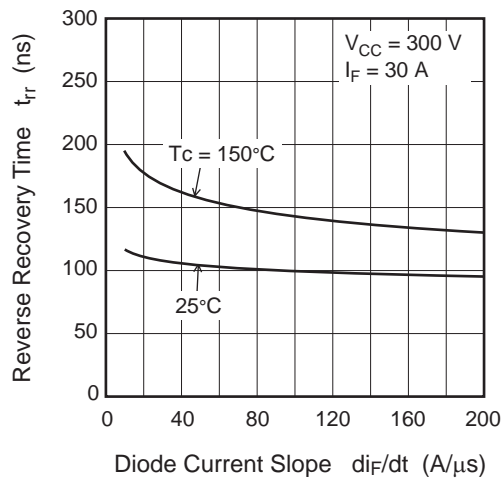
Typical Capacitance vs.  
Collector to Emitter Voltage



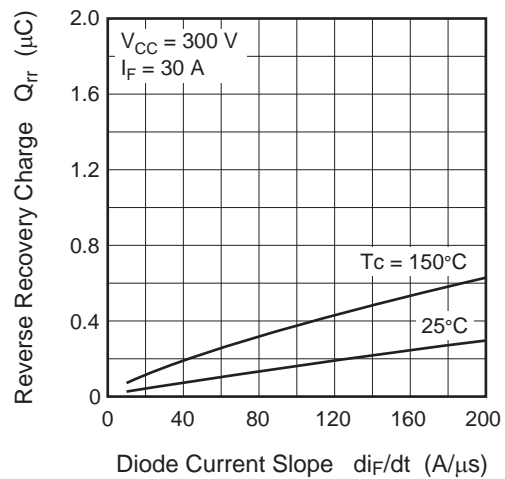
Dynamic Input Characteristics (Typical)



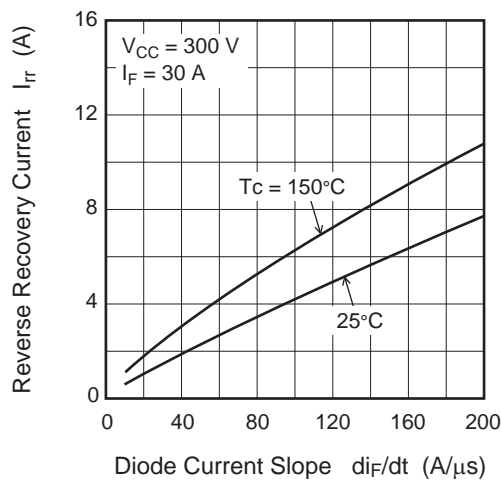
Reverse Recovery Time vs.  
Diode Current Slope (Typical)



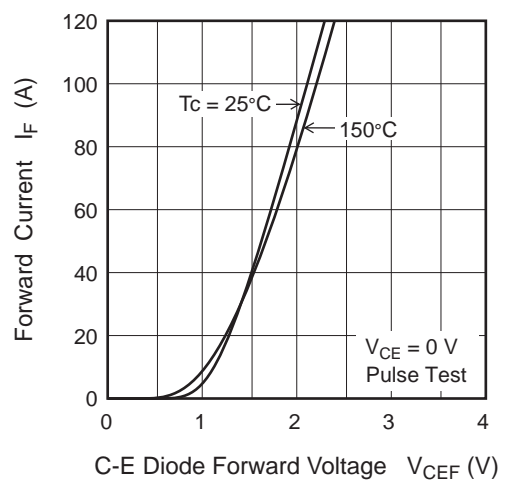
Reverse Recovery Charge vs.  
Diode Current Slope (Typical)

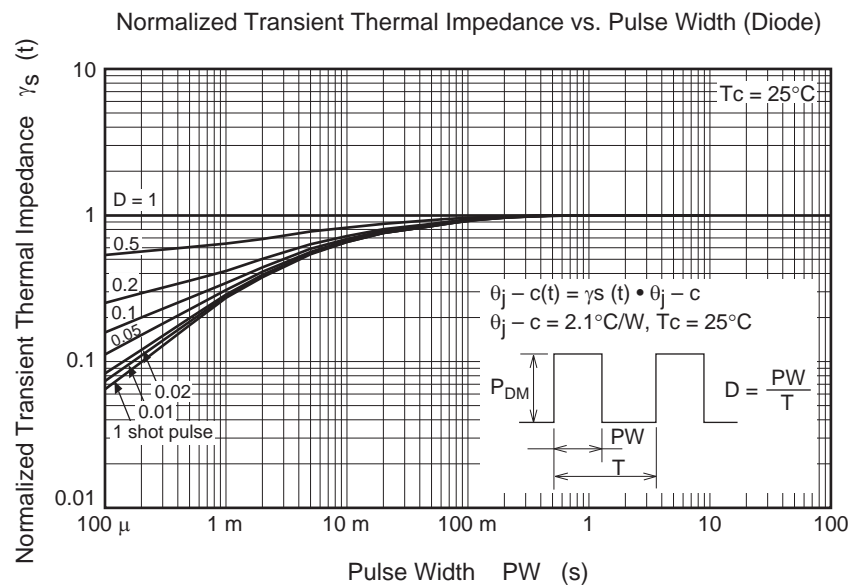
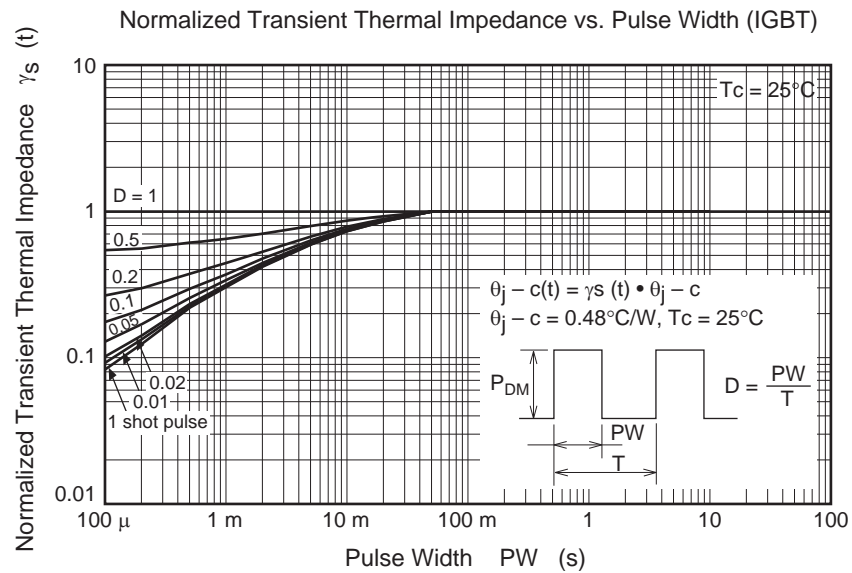


Reverse Recovery Current vs.  
Diode Current Slope (Typical)

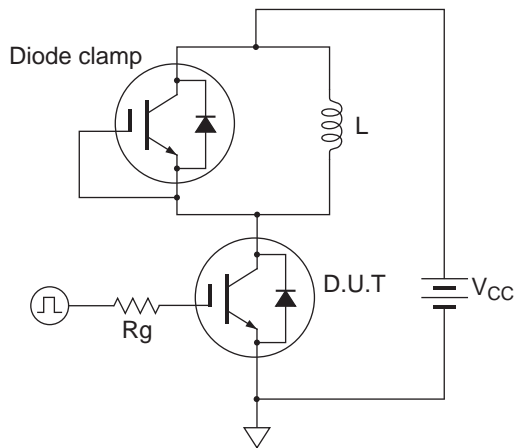


Forward Current vs. Forward Voltage (Typical)

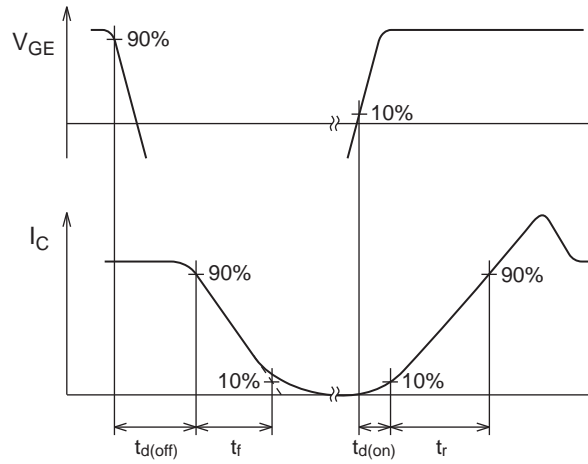




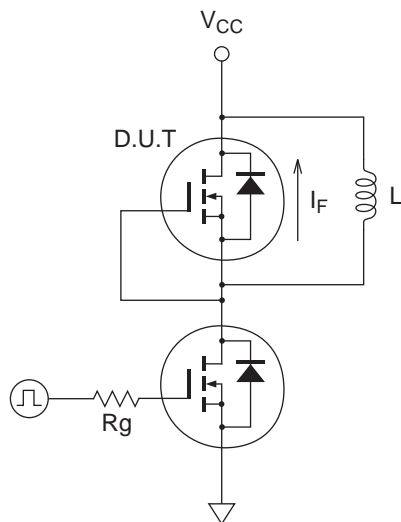
Switching Time Test Circuit



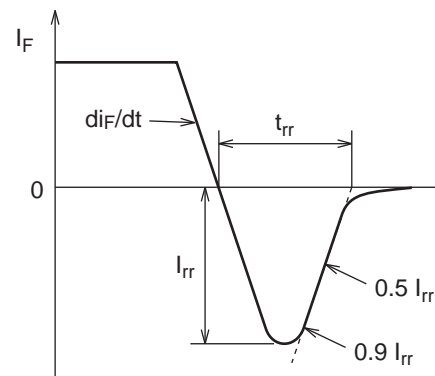
Waveform



Diode Reverse Recovery Time Test Circuit

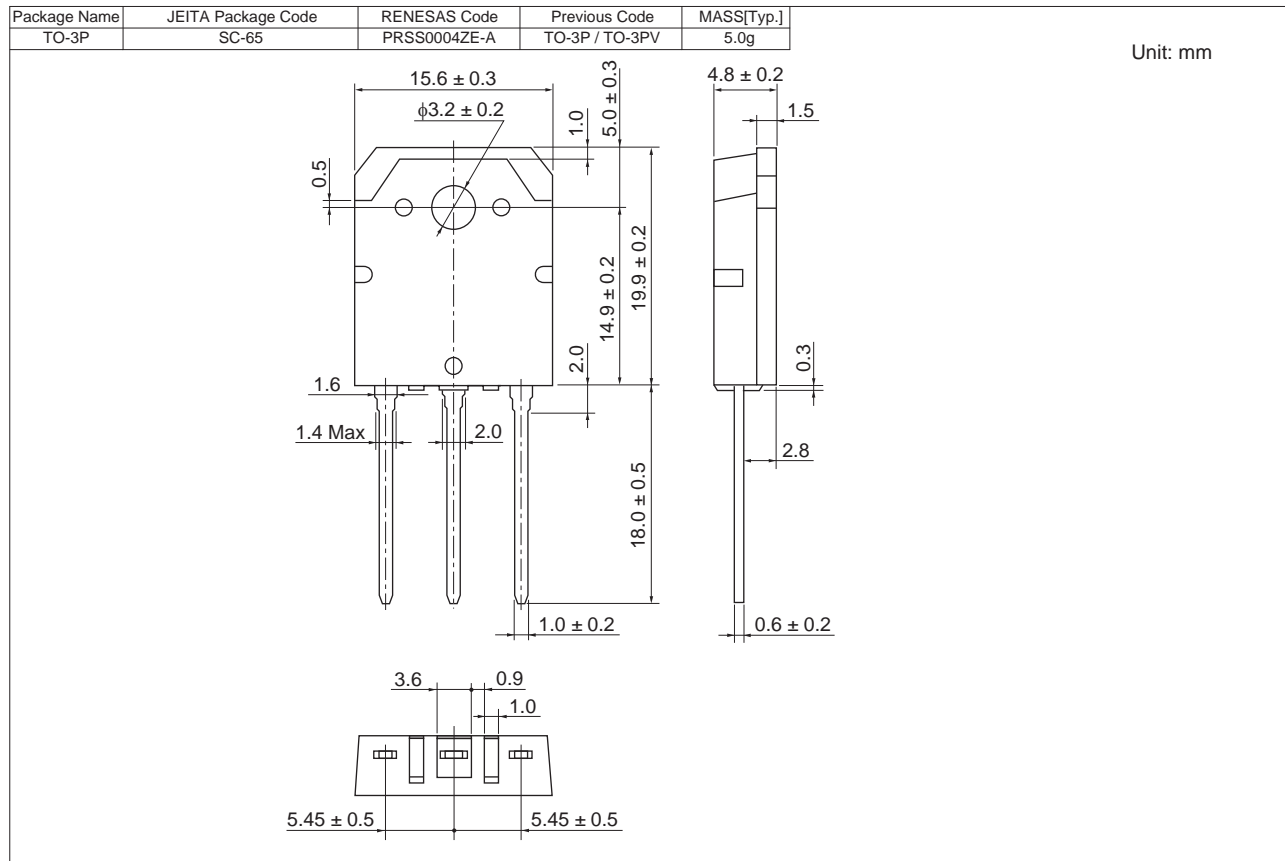
