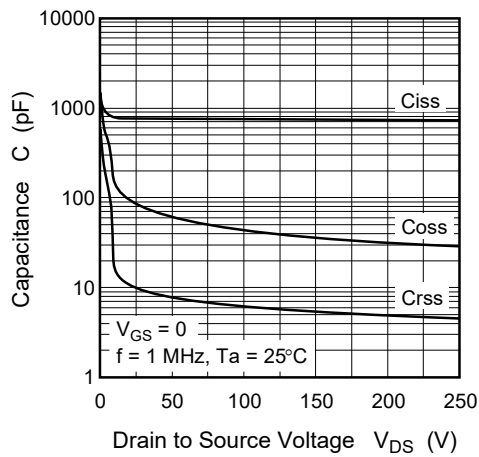

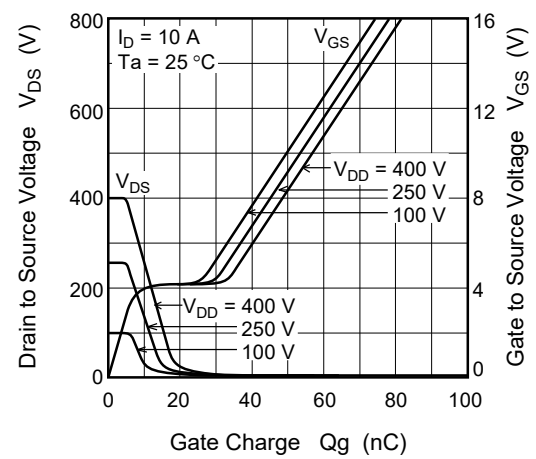

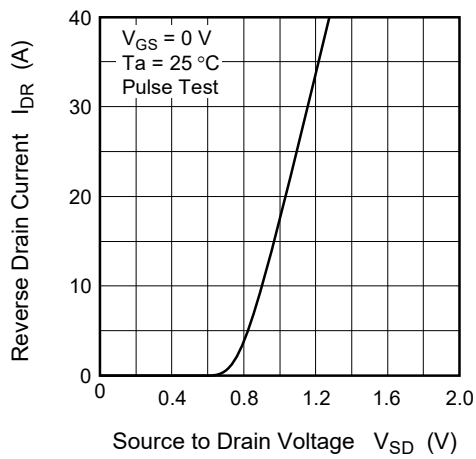
Typical Capacitance vs.
Drain to Source Voltage (Typical)



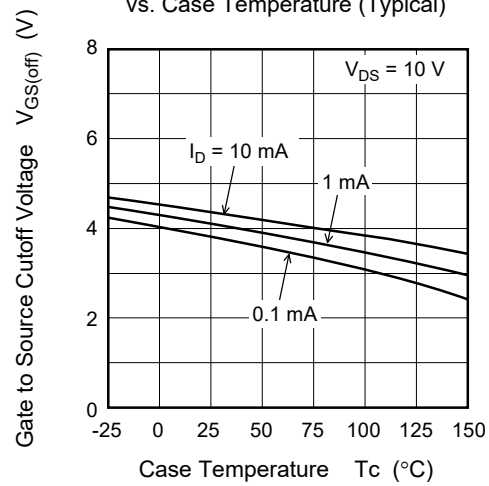
Dynamic Input Characteristics (Typical)

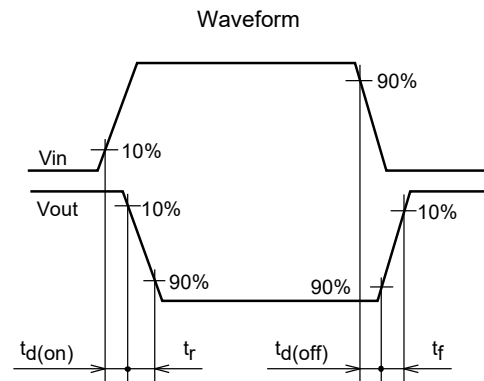
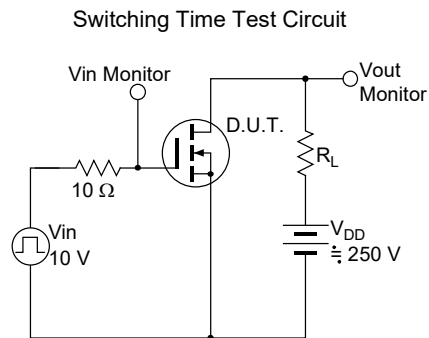
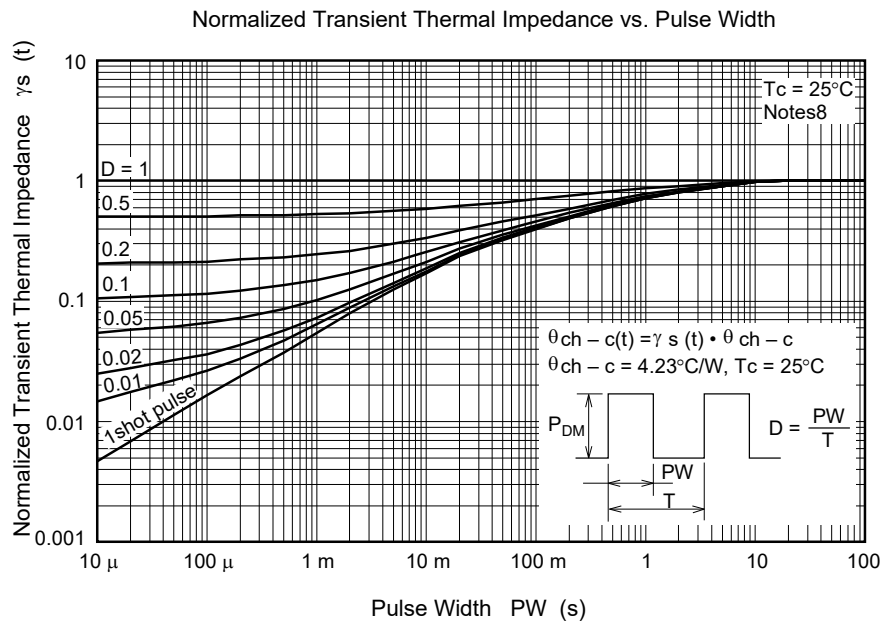


Reverse Drain Current vs.

vs. Case Temperature (Typical)



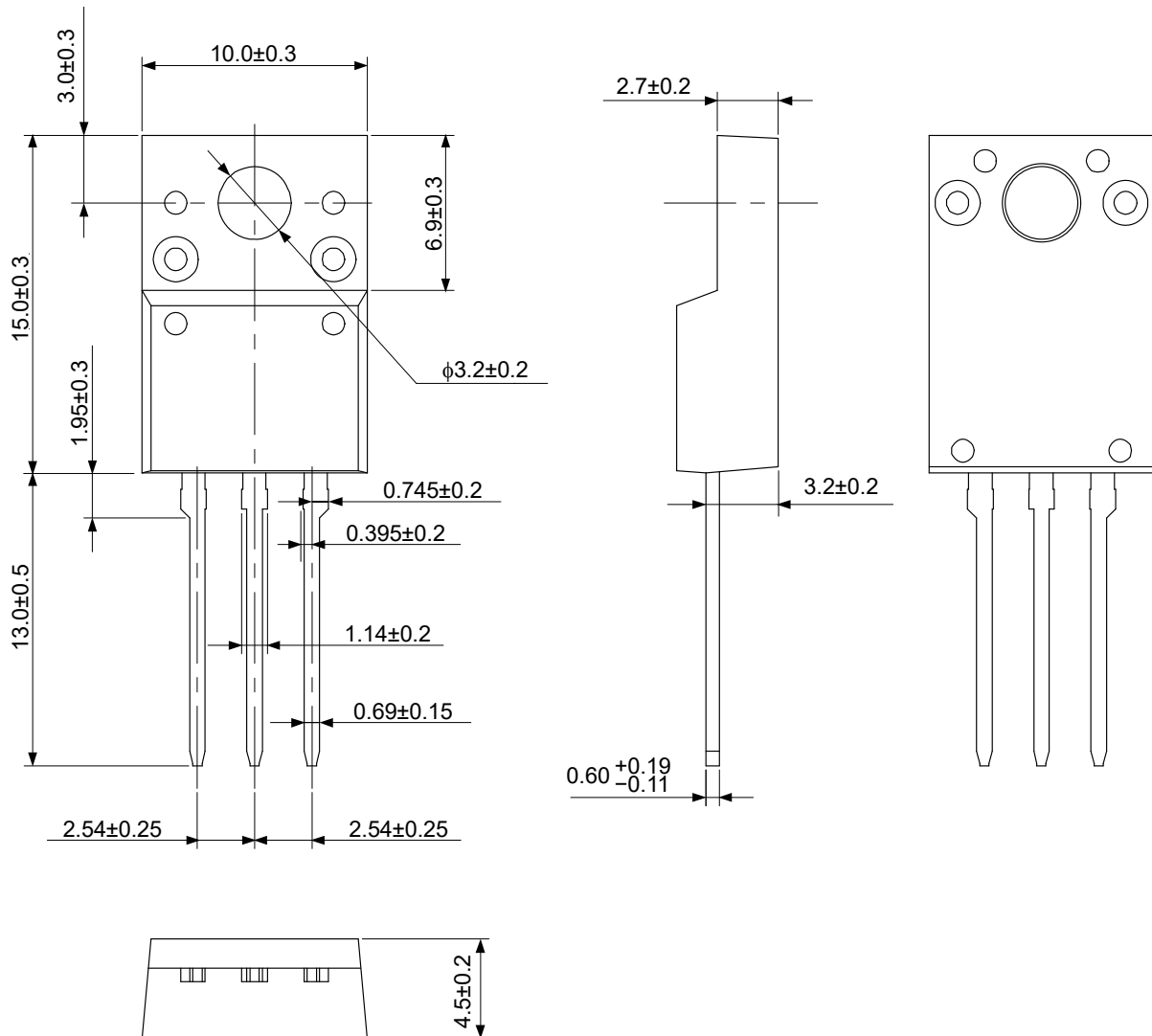
