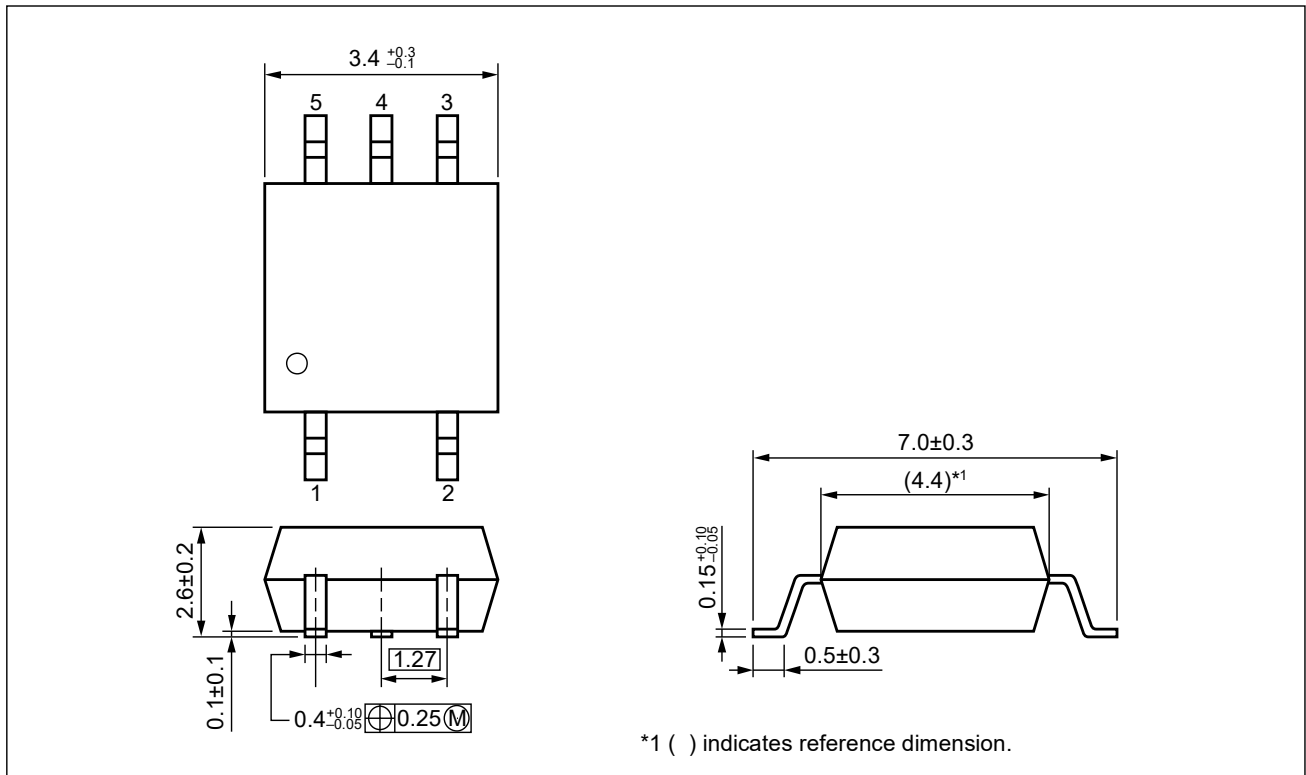

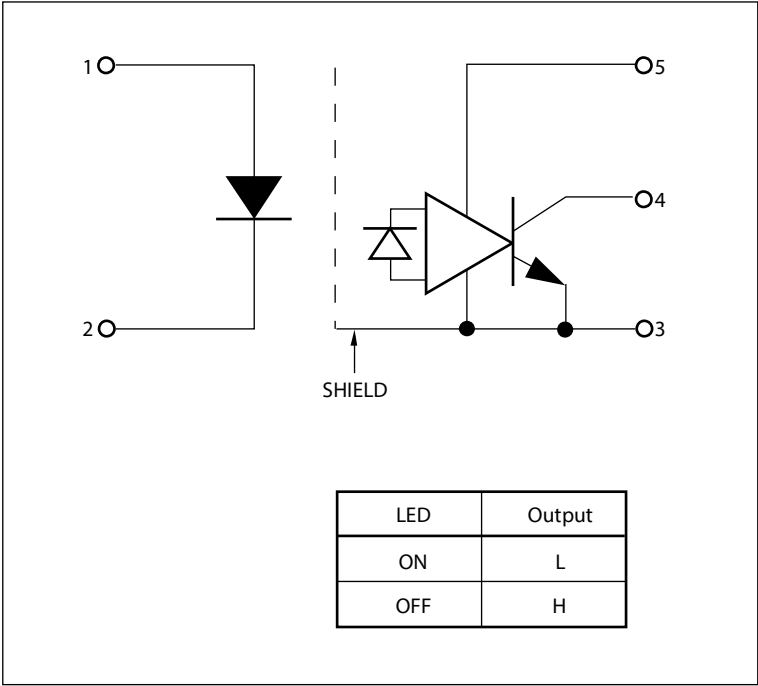

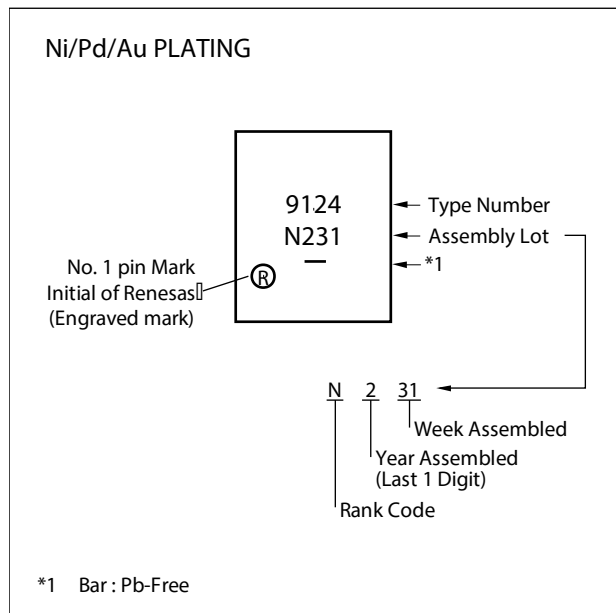

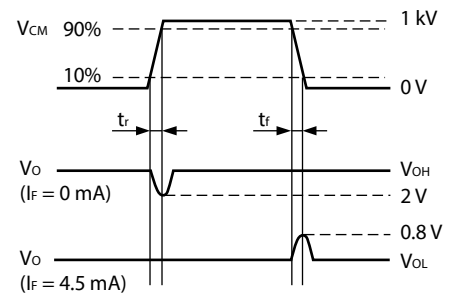
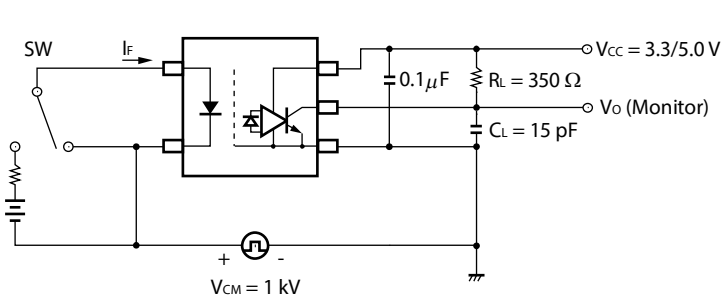
*2. Test circuit for propagation delay time

*3. Test circuit for common mode transient immunity



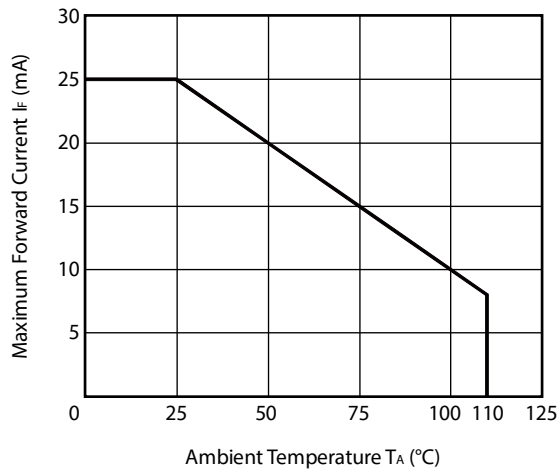

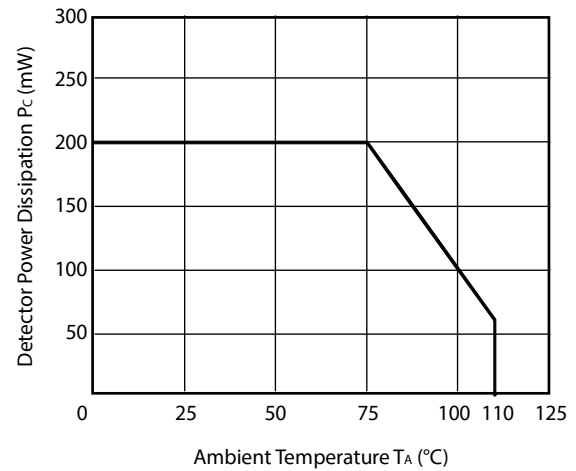
1. This product is weak for static electricity by designed with high-speed integrated circuit so protect against static electricity when handling.
2. By-pass capacitor of more than $0.1 \mu\text{F}$ is used between V_{CC} and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
3. Avoid storage at a high temperature and high humidity.
4. Do not use adhesives or coating materials including halogens to fix this device.

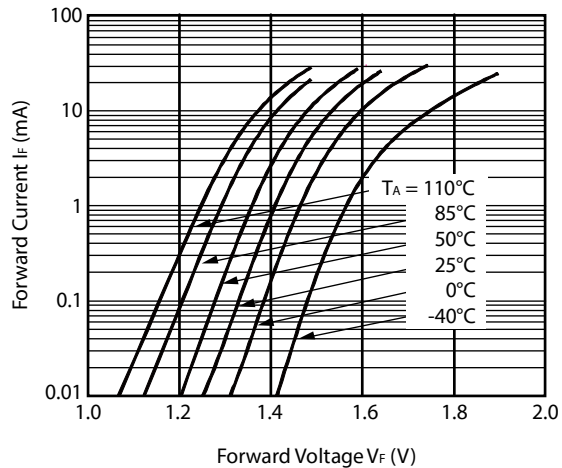
MAXIMUM FORWARD CURRENT
vs. AMBIENT TEMPERATURE



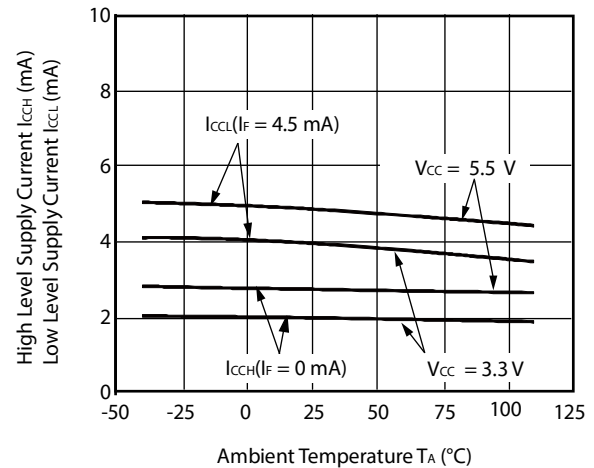
DETECTOR POWER DISSIPATION
vs. AMBIENT TEMPERATURE



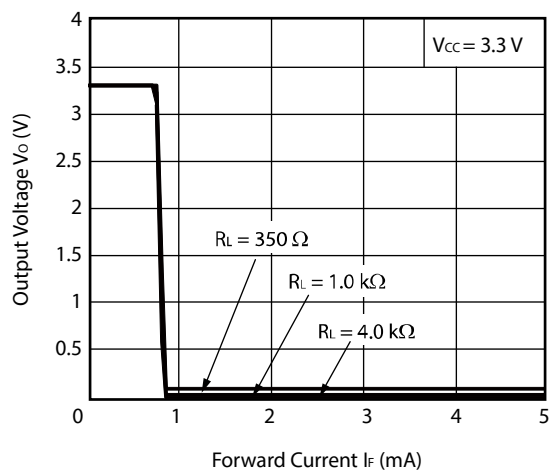
FORWARD CURRENT vs.
FORWARD VOLTAGE



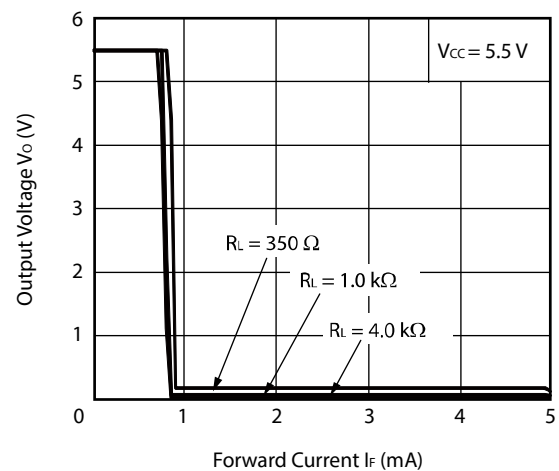
SUPPLY CURRENT vs.

FORWARD CURRENT

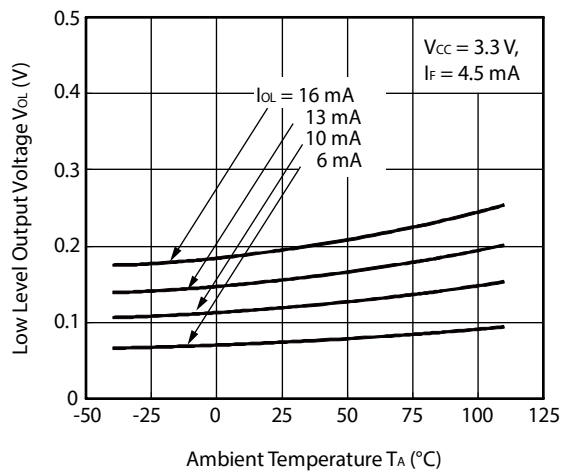


OUTPUT VOLTAGE vs.
FORWARD CURRENT

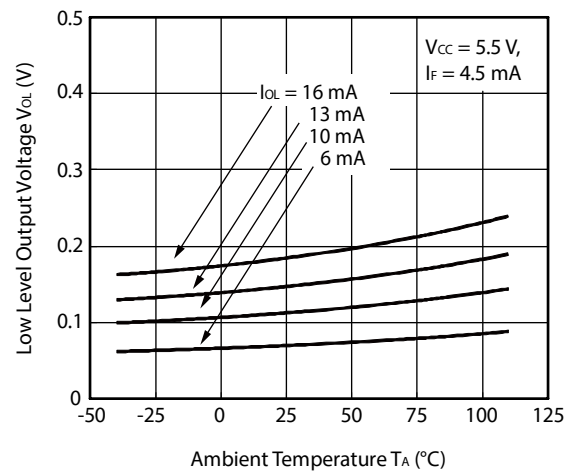

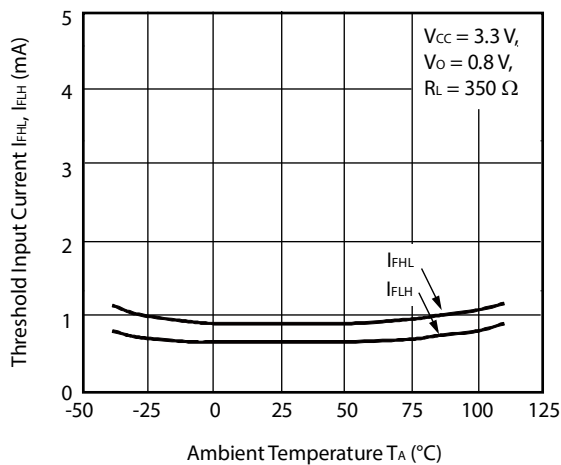
LOW LEVEL OUTPUT VOLTAGE vs.
AMBIENT TEMPERATURE



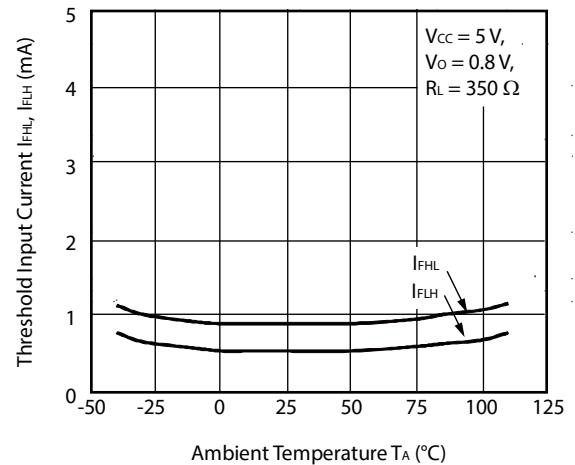
LOW LEVEL OUTPUT VOLTAGE vs.
AMBIENT TEMPERATURE



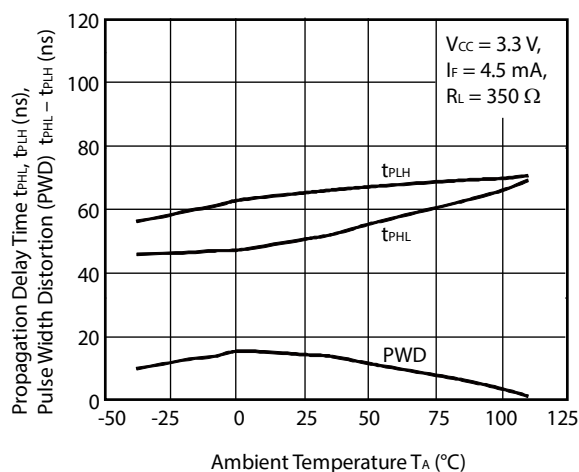
THRESHOLD INPUT CURRENT vs.
AMBIENT TEMPERATURE



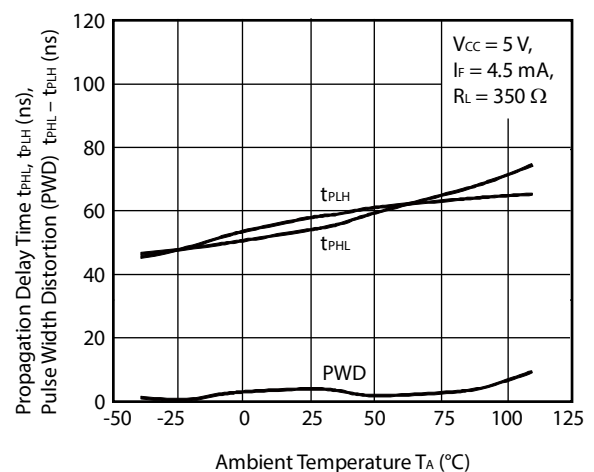

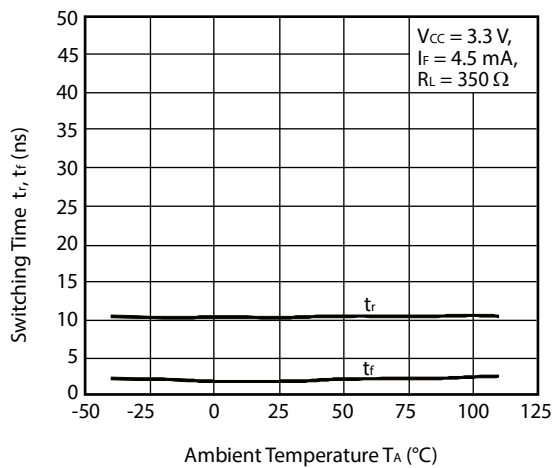
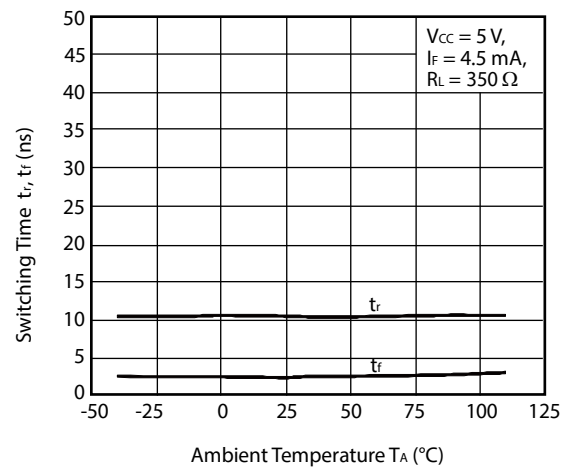
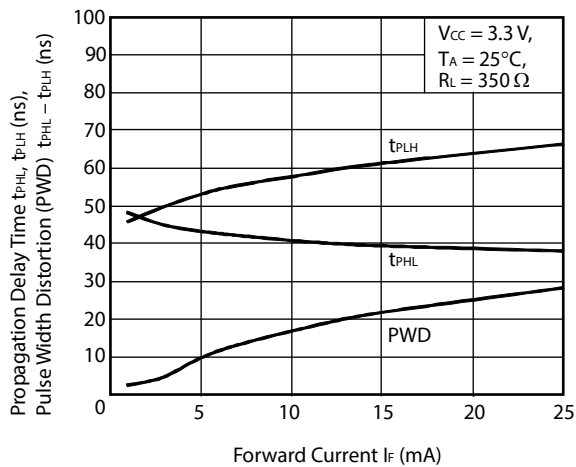
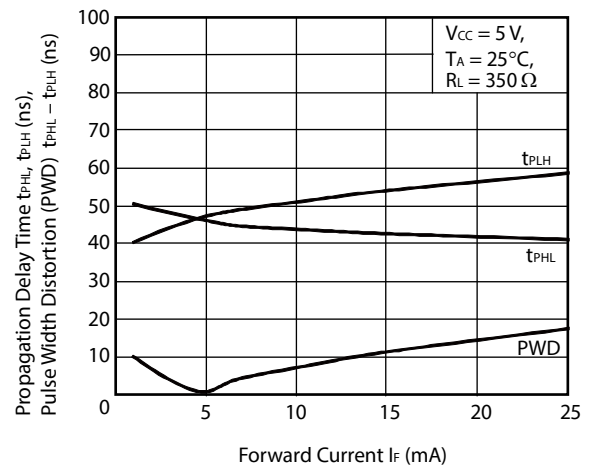
PROPAGATION DELAY TIME,

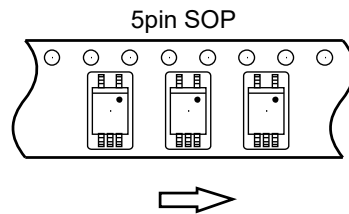

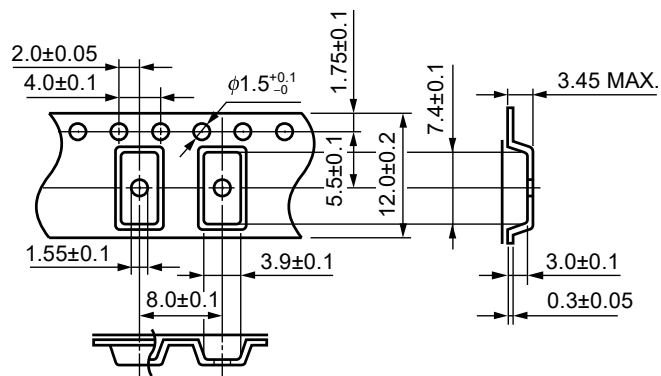

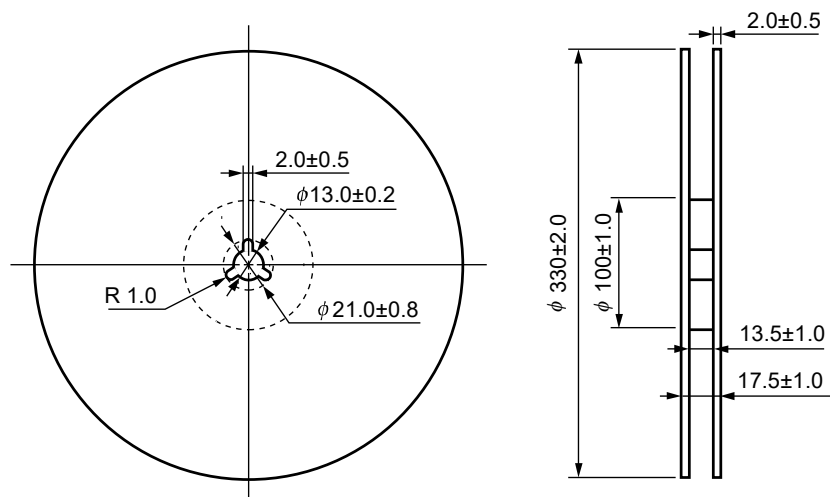

Outline and Dimensions (Tape)

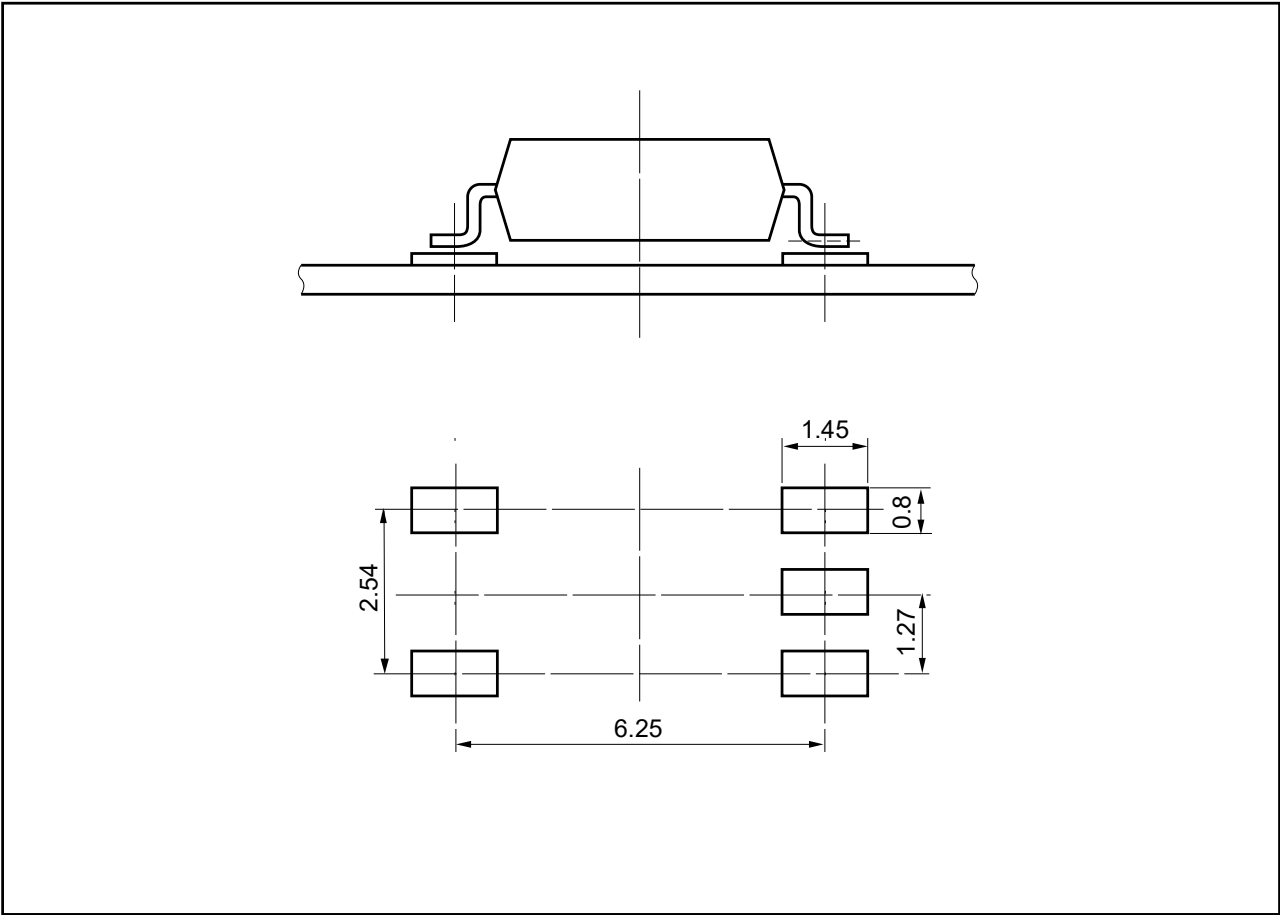


Outline and Dimensions (Reel)

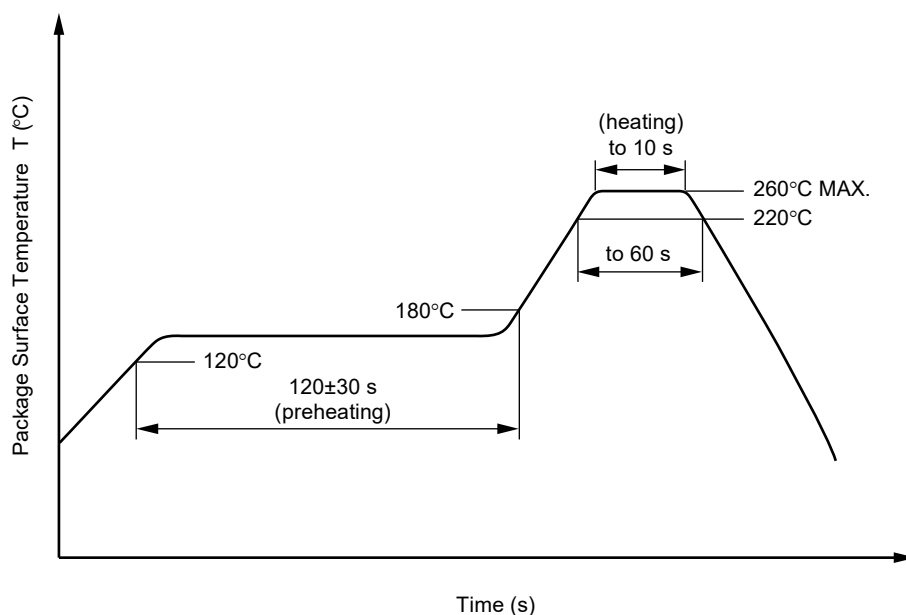

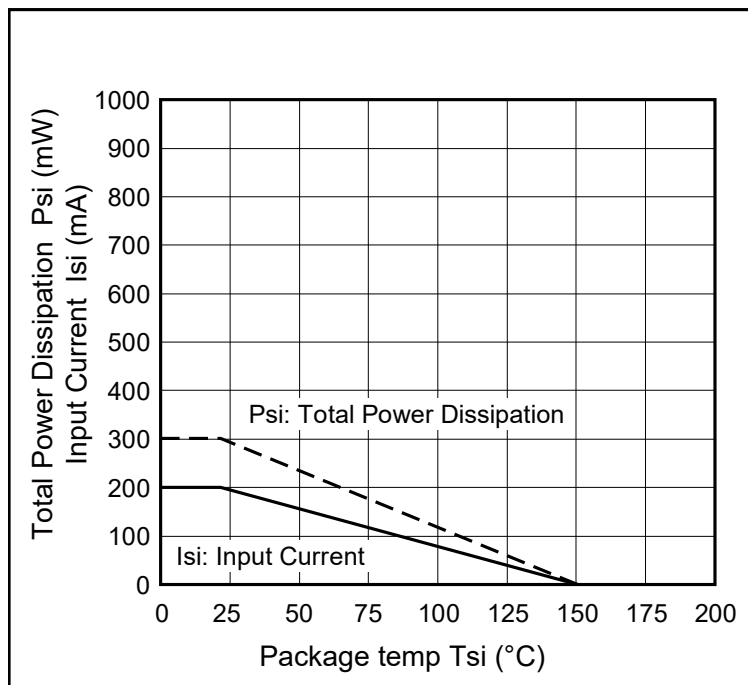
2. Cautions regarding noise

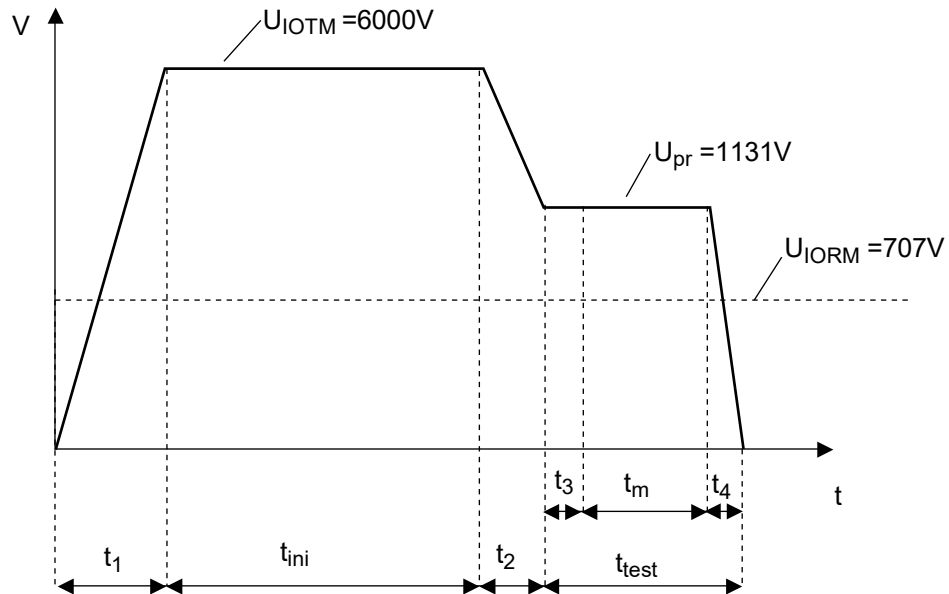

Dependence of maximum safety ratings with package temperature

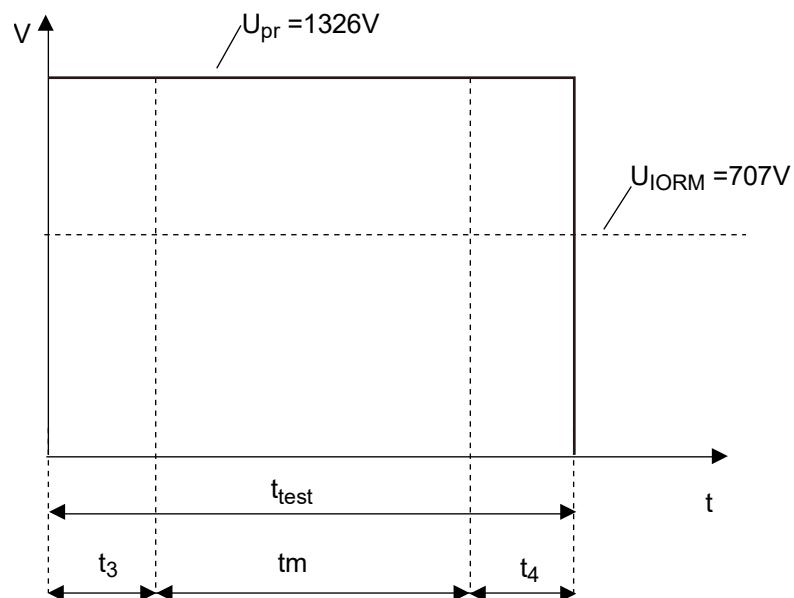
