


Figure 1 Package components of the R0E521174CDB00




Figure 2 Usage of the R0E521174CDB00

4. Usage (See Figure 2)

(1) For debugging

Mount the socket for 20-pin SDIP (PM-6-10P x2) on the foot pattern of the user system.

After connecting the R0E521000EPB00 or R0E521000CPE00 and R0E521174CDB00, connect the R0E521174CDB00 to the socket for 20-pin SDIP (PM-6-10P x2).

(2) For on-board evaluation

Mount an R8C/18, 19, 1A and 1B Groups MCU on the socket for 20-pin SDIP (PM-6-10P x2) on the user system

- (3) Attach the R0E521174CDB00 to the socket for 20-pin SDIP (PM-6-10P x2).




Figure 3 Connection procedure of the R0E521174CDB00




Figure 4 External dimensions and a sample foot pattern of the R0E521174CDB00
