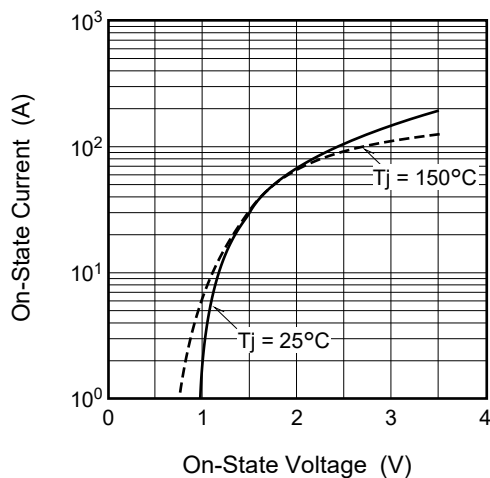

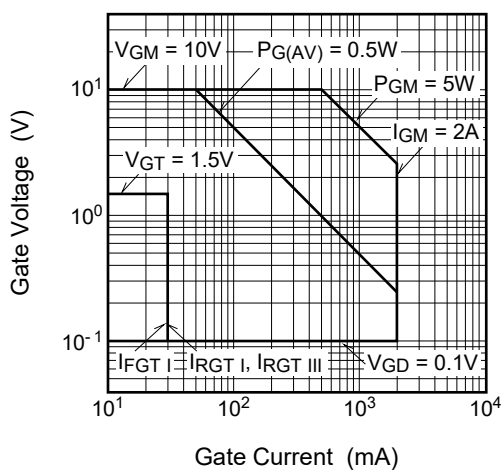
Maximum On-State Characteristics



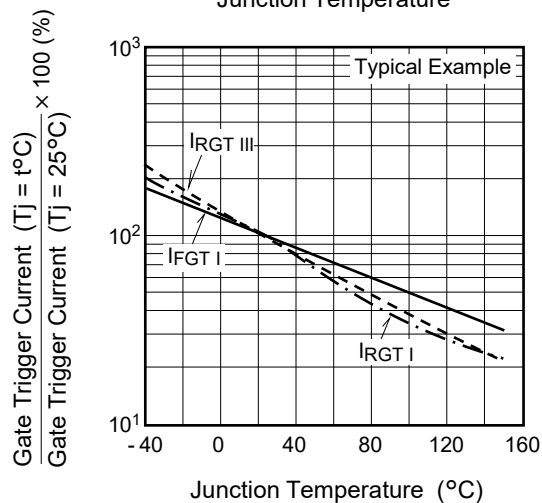
Rated Surge On-State Current



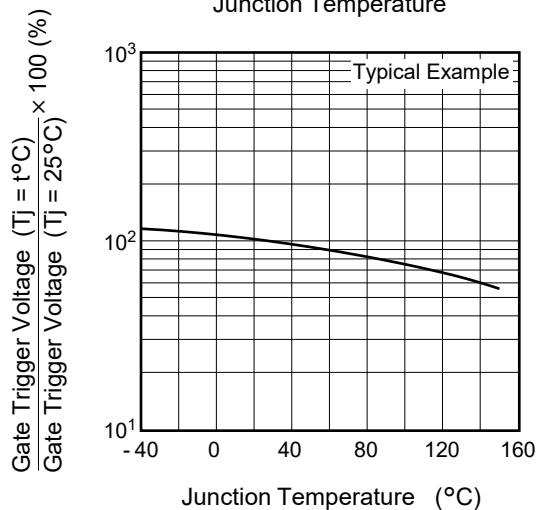

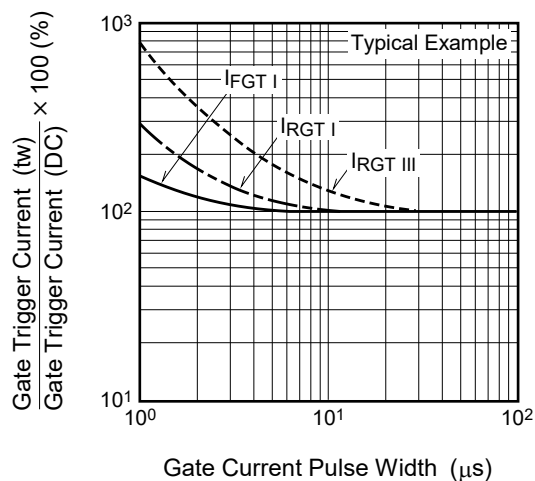
Gate Trigger Current vs. Junction Temperature

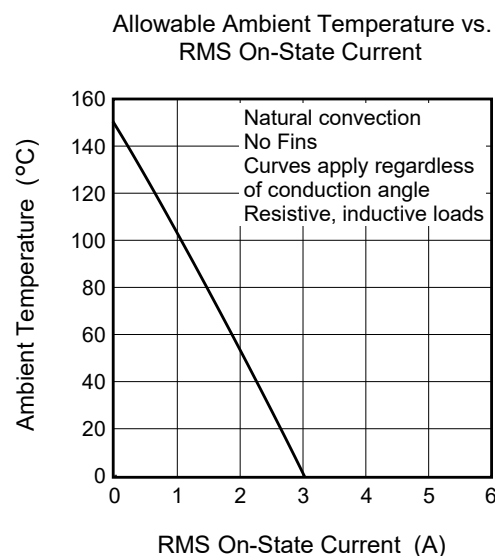
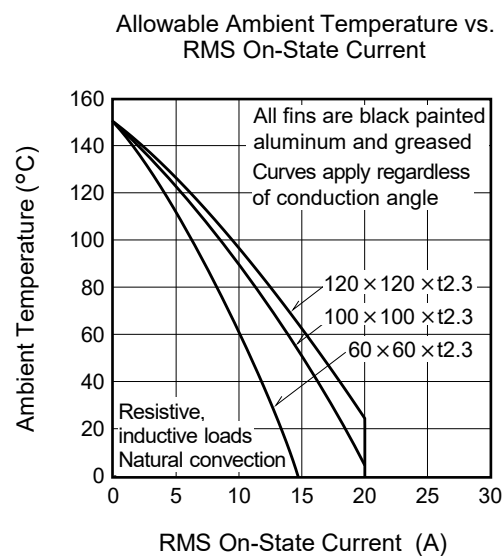
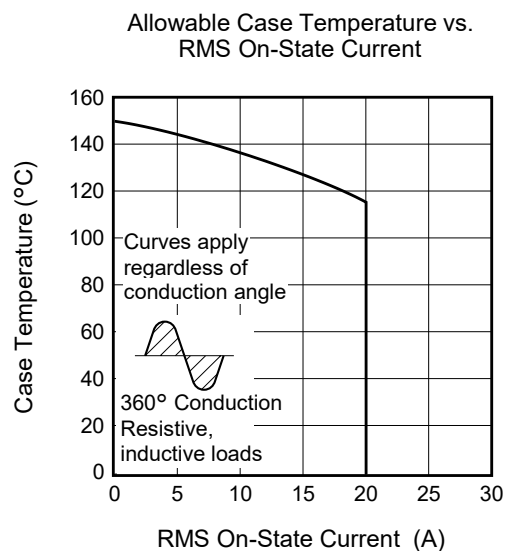
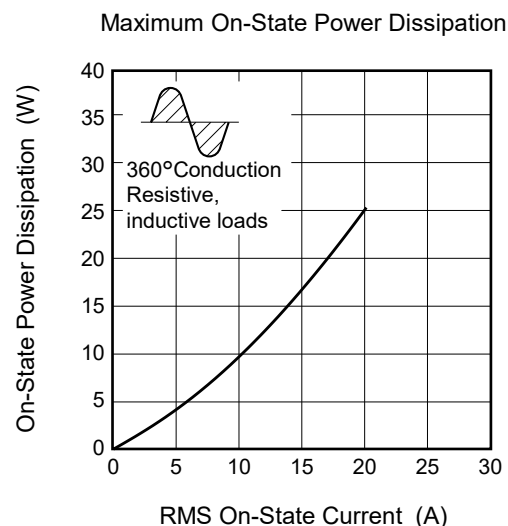
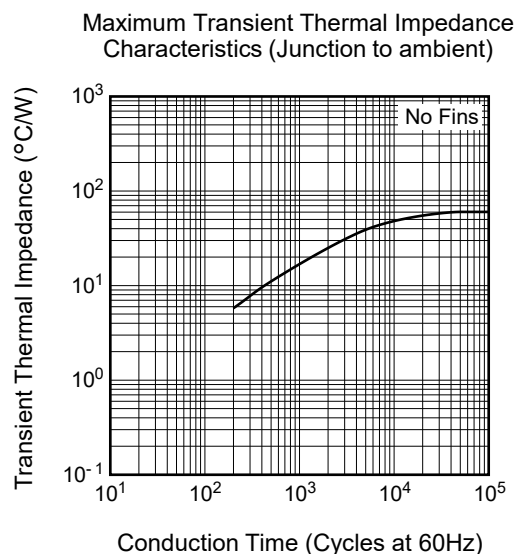
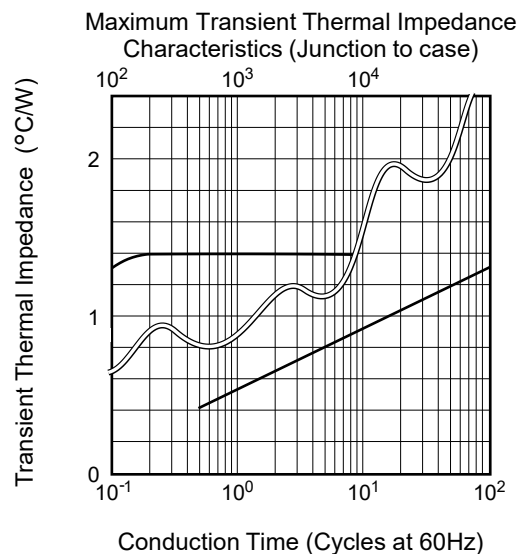


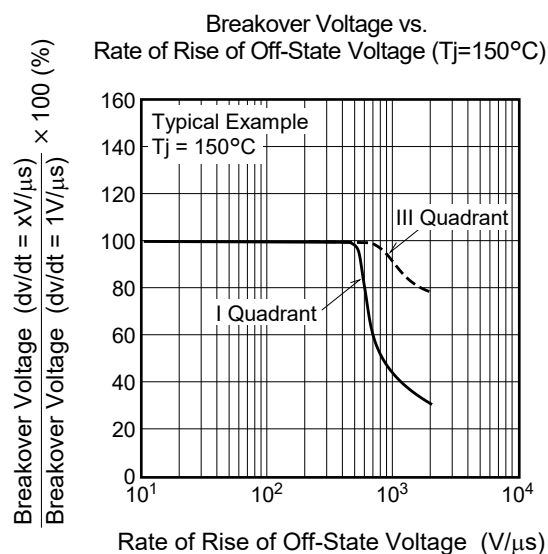
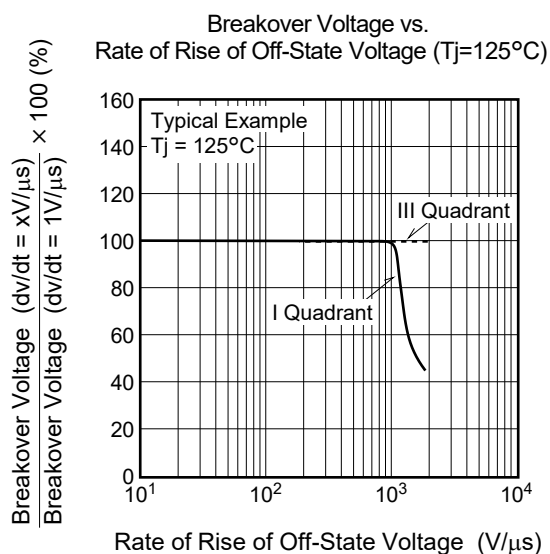
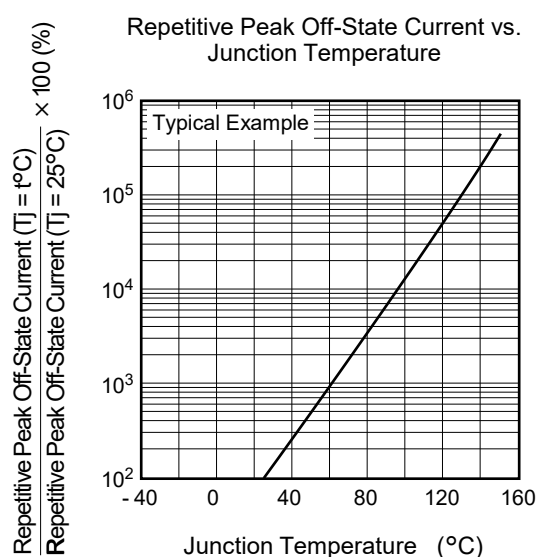
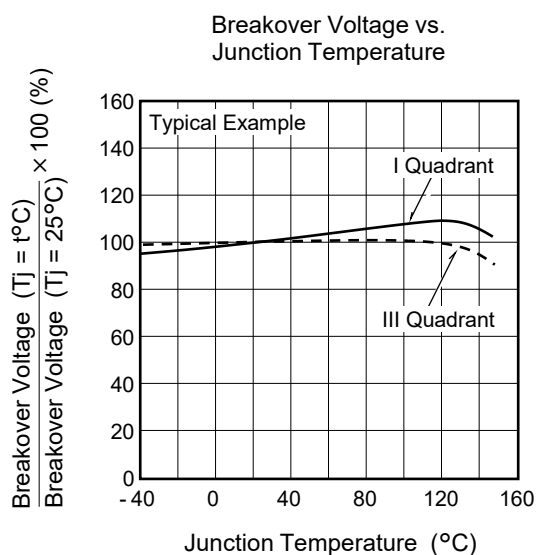
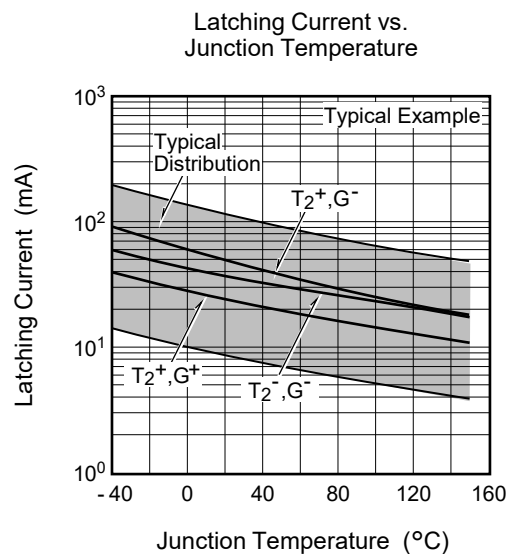
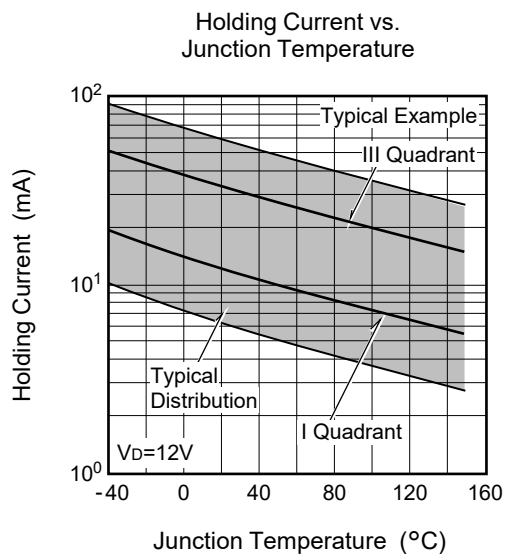
Gate Trigger Voltage vs. Junction Temperature

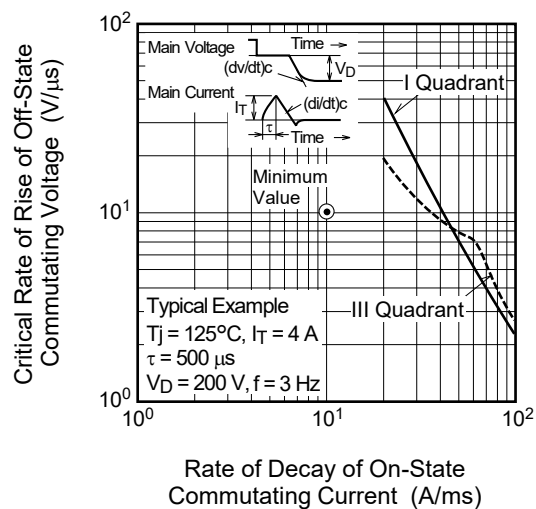
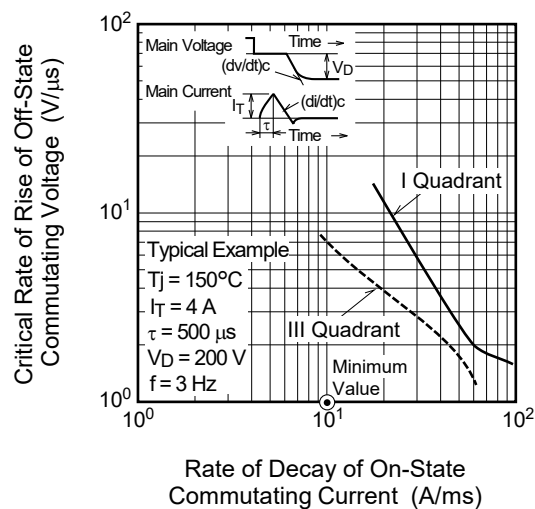


Gate Trigger Current vs. Gate Current Pulse Width

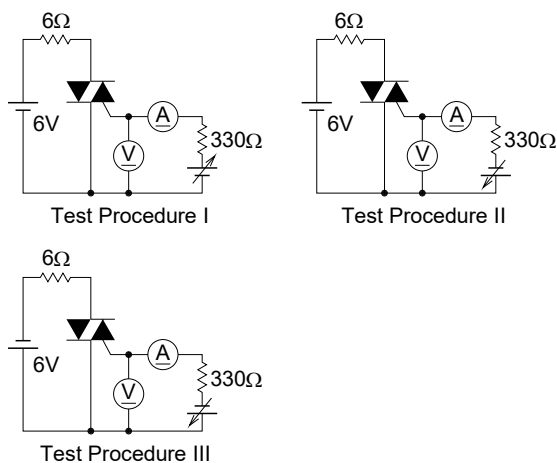




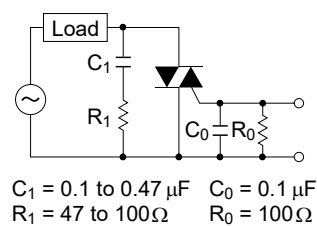


Commutation Characteristics ($T_j=125^\circ\text{C}$)Commutation Characteristics ($T_j=150^\circ\text{C}$)

Gate Trigger Characteristics Test Circuits

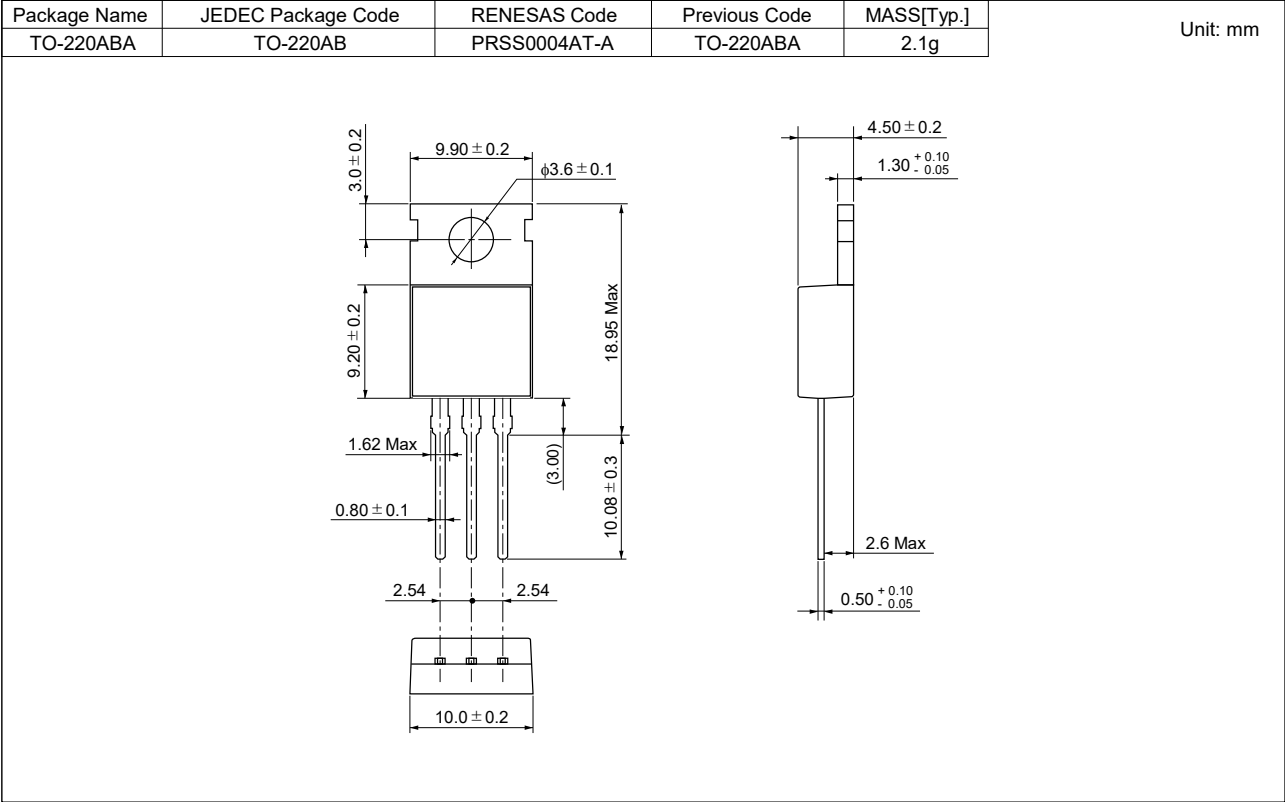


Recommended peripheral components for Triac

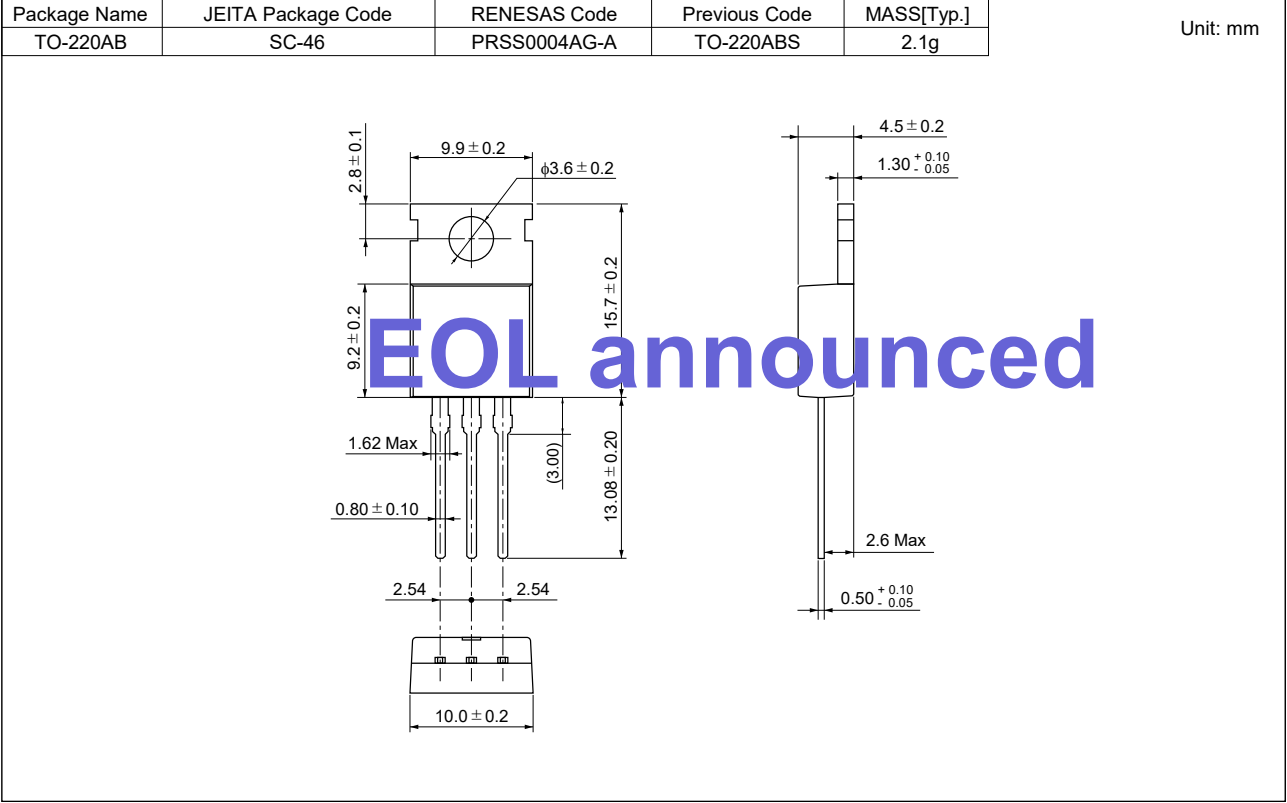
