The PS2815-1 and PS2815-4 are optically coupled isolators containing GaAs light emitting diodes and an NPN silicon phototransistor in a plastic SSOP for high density applications.


The package is a Shrink SOP (Small Outline Package) type for high density mounting applications.






# FORWARD CURRENT vs. FORWARD VOLTAGE




# COLLECTOR TO EMITTER DARK CURRENT vs. AMBIENT TEMPERATURE




# TRANSISTOR POWER DISSIPATION vs. AMBIENT TEMPERATURE



# COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE




# COLLECTOR CURRENT vs. COLLECTOR SATURATION VOLTAGE




# NORMALIZED CURRENT TRANSFER RATIO vs. AMBIENT TEMPERATURE



# SWITCHING TIME vs. LOAD RESISTANCE




#### FREQUENCY RESPONSE



# CURRENT TRANSFER RATIO vs. FORWARD CURRENT















2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between collector-emitters at startup, the output transistor may enter the on state, even if the voltage is within the absolute maximum ratings.

Measurement conditions of current transfer ratios (CTR), which differ according to photocoupler Check the setting values before use, since the forward current conditions at CTR measurement differ according to product.

When using products other than at the specified forward current, the characteristics curves may differ from the standard curves due to CTR value variations or the like. Therefore, check the characteristics under the actual operating conditions and thoroughly take variations or the like into consideration before use.






