### **DESCRIPTION**

The PS9817A-1 and PS9817A-2 are active-low type high-speed photocouplers that use an AlGaAs light-emitting diode on the input side and a photodetector IC that includes a photodiode and a signal processor on the same chip on the output side.

The PS9817A-1 and PS9817A-2 are designed specifically for high common mode transient immunity (CMR) and low pulse width distortion. The PS9817A-2 is suitable for high density applications.



#### 4. Test circuit for common mode transient immunity




### **USAGE CAUTIONS**

- 1. This product is weak for static electricity by designed with high-speed integrated circuit so protect against static electricity when handling.
- 2. By-pass capacitor of 0.1  $\mu$ F is used between V<sub>CC</sub> and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
- 3. Avoid storage at a high temperature and high humidity.
- 4. Avoid cleaning with Freon based or halogen-based (chlorinated etc.) solvents.
- 5. Do not use fixing agents or coatings containing halogen-based substances.


# TYPICAL CHARACTERISTICS (T<sub>A</sub> = 25 °C unless otherwise specified)




MAXIMUM FORWARD CURRENT




FORWARD CURRENT vs. FORWARD VOLTAGE




SUPPLY CURRENT vs. AMBIENT TEMPERATURE



OUTPUT VOLTAGE vs. FORWARD CURRENT




LOW LEVEL OUTPUT VOLTAGE vs. AMBIENT TEMPERATURE




# THRESHOLD INPUT CURRENT vs. AMBIENT TEMPERATURE




# PULSE WIDTH DISTORTION vs. AMBIENT TEMPERATURE



# PROPAGATION DELAY TIME vs. AMBIENT TEMPERATURE




# PROPAGATION DELAY TIME vs. FORWARD CURRENT






