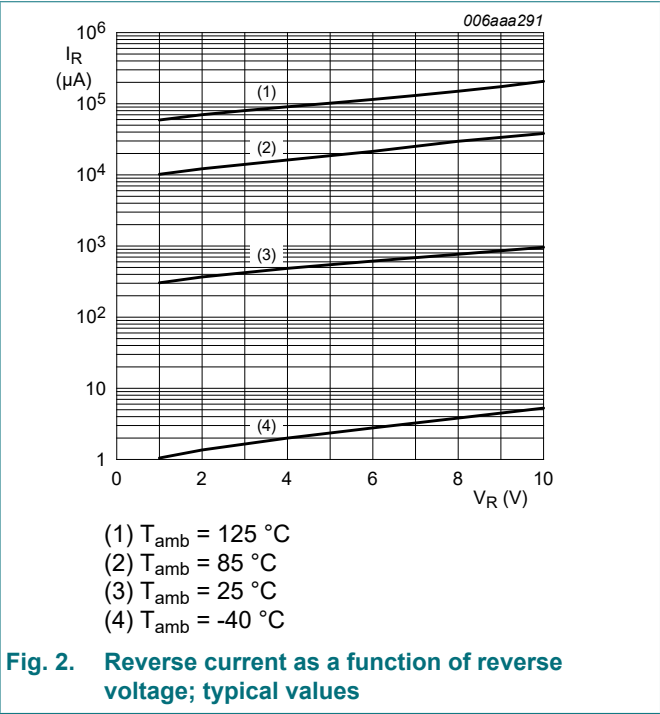

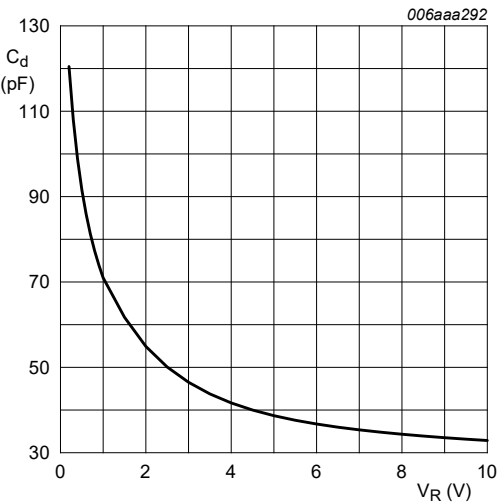

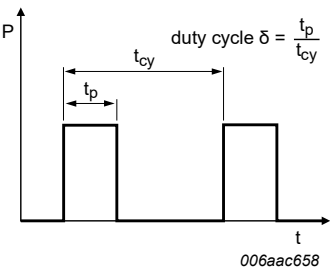


Fig. 4. Duty cycle definition

$I_{F(AV)} = I_M \times \delta$ with I_M defined as peak current

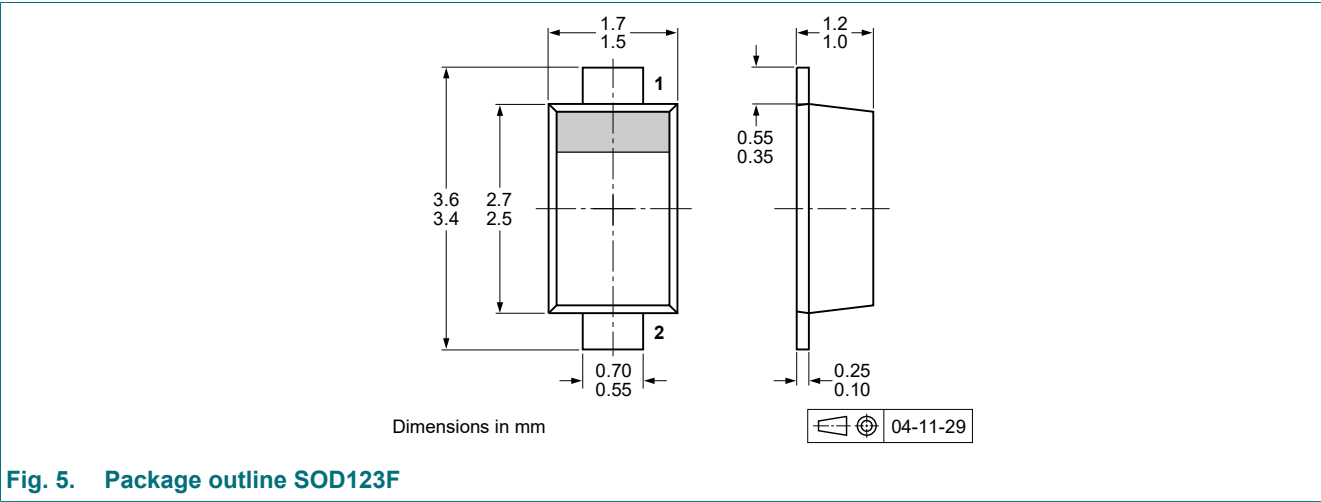
$I_{RMS} = I_{F(AV)}$ at DC

$I_{RMS} = I_M \times \sqrt{\delta}$ with I_{RMS} defined as RMS current

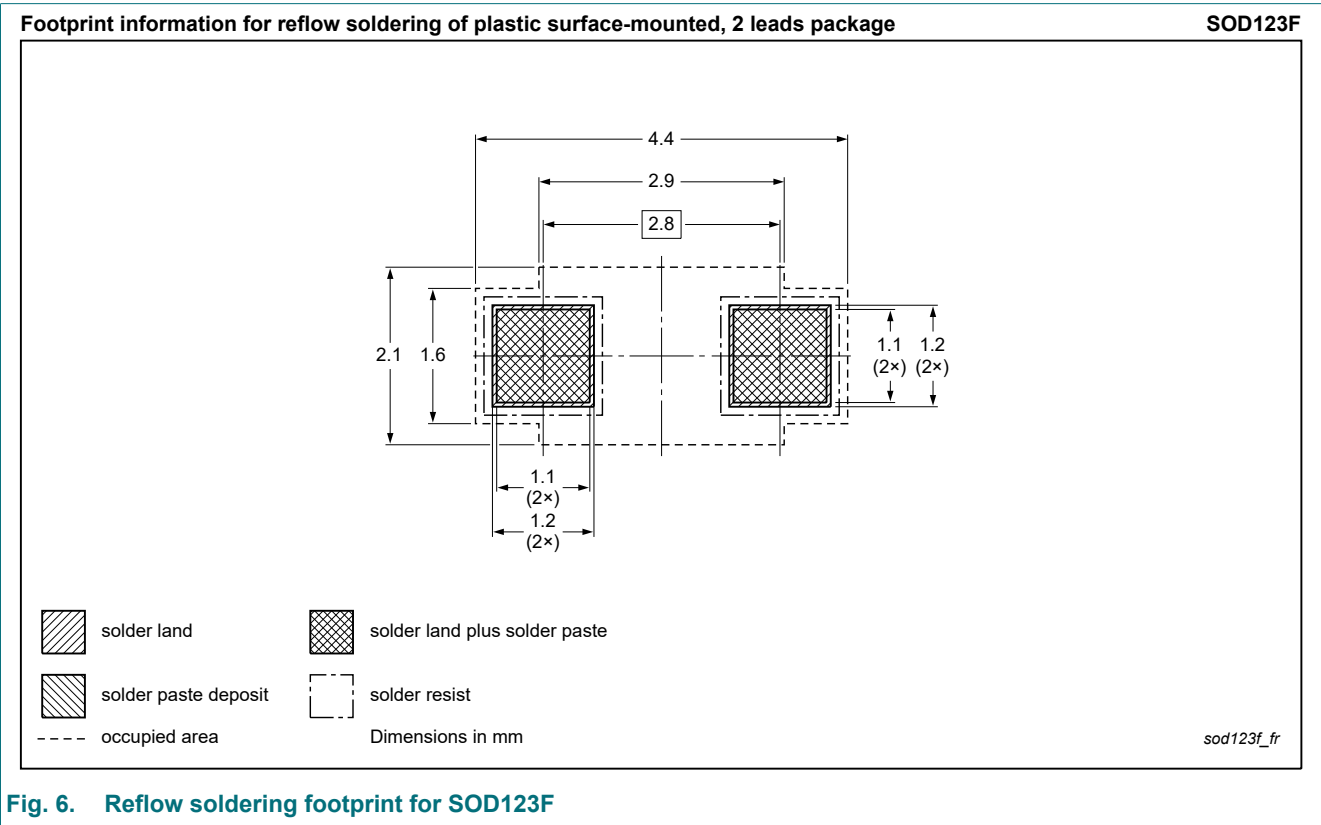
