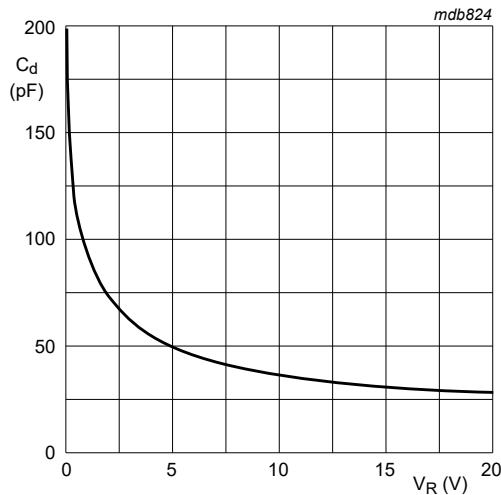

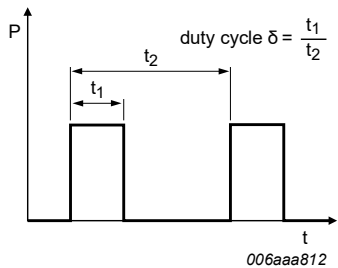
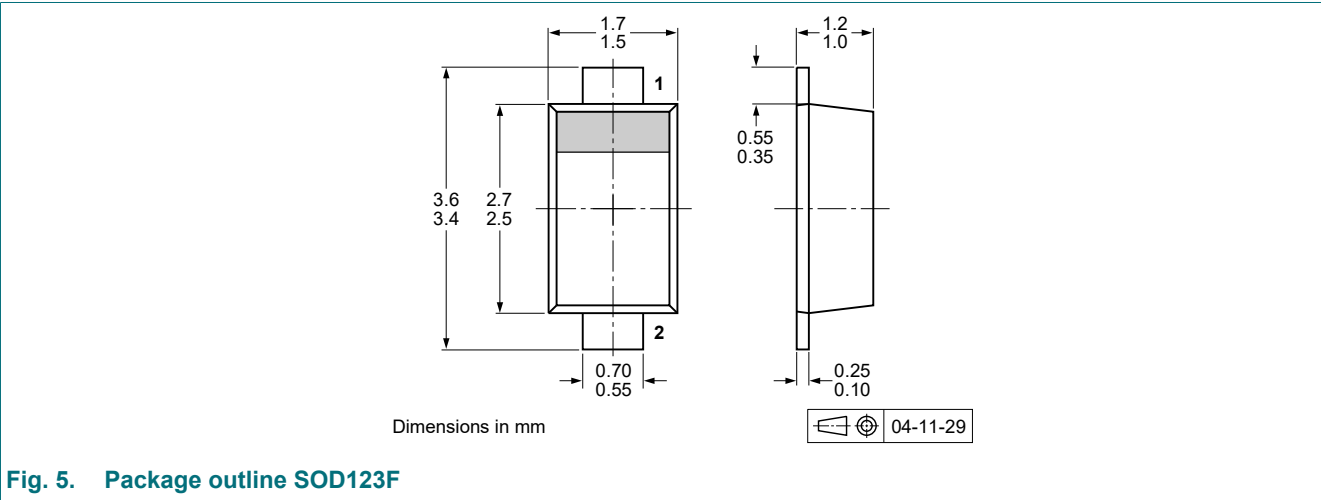


Fig. 4. Duty cycle definition

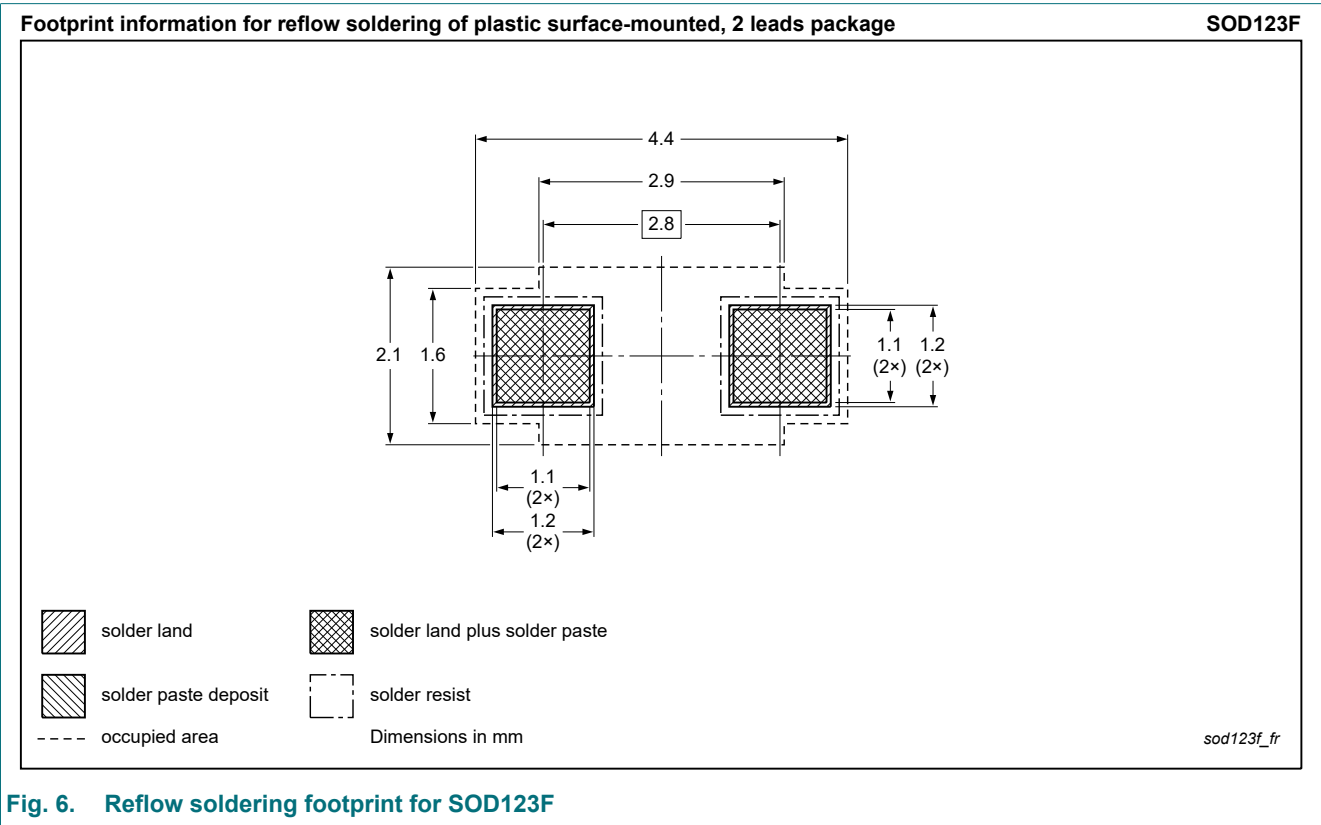
