









Fig. 5. Forward current as a function of forward voltage; typical values

Fig. 6. Reverse current as a function of reverse voltage; typical values






Fig. 7. Diode capacitance as a function of reverse voltage; typical values
















Fig. 18. Reflow soldering footprint for DFN1608D-2 (SOD1608)
