Wiring diagram

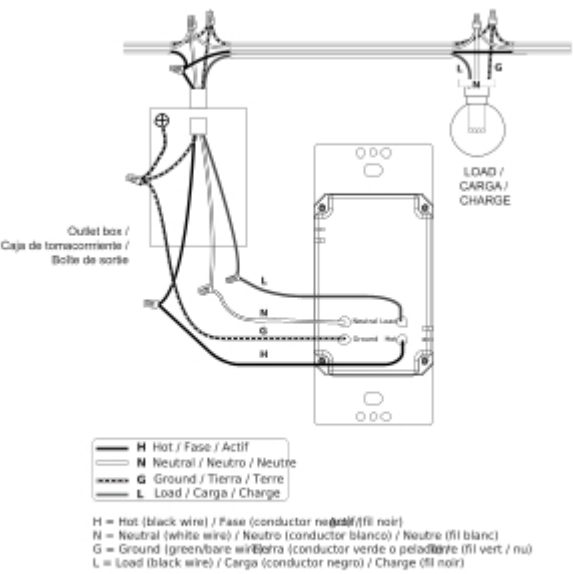
