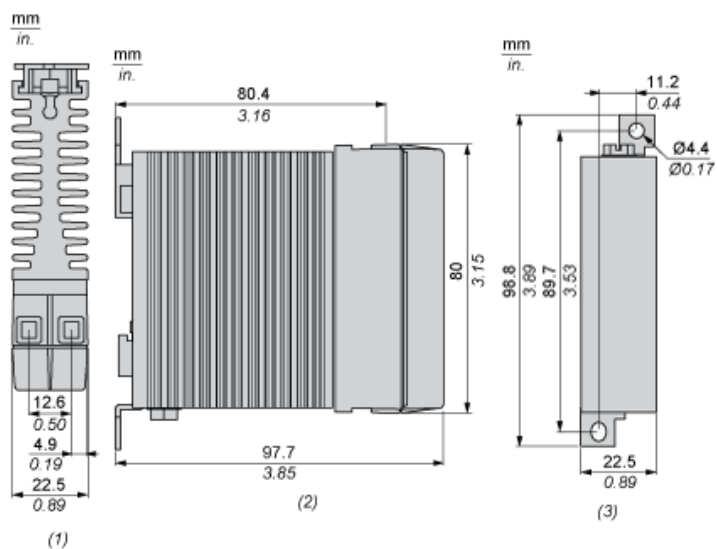

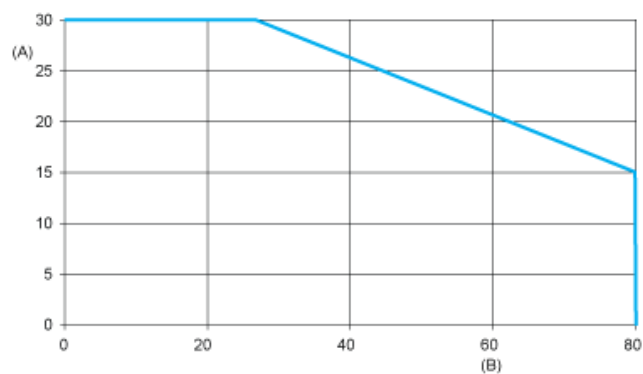


- (1) Top view
