#### **General Information**

The Bourns® CRG2512 Series is a metal strip current sense resistor with a rating of 1 or 2 watts in a standard 2512 chip format. This product has very low inductance, low noise, excellent reliability and a wide resistance range, making it suitable for different applications in power supply circuits including current sensing and current limiting.








### Recommended Solder Pad Layout




