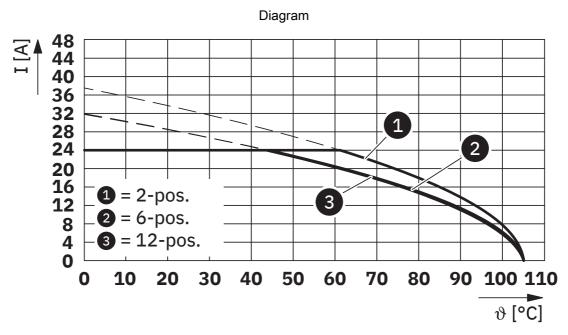

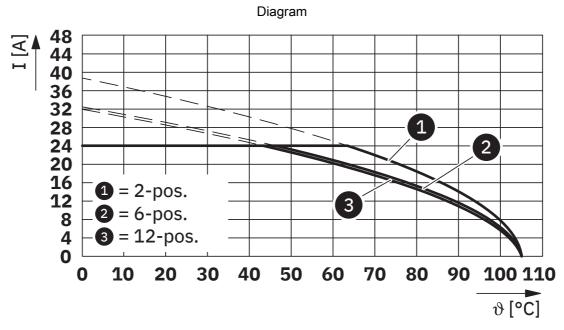

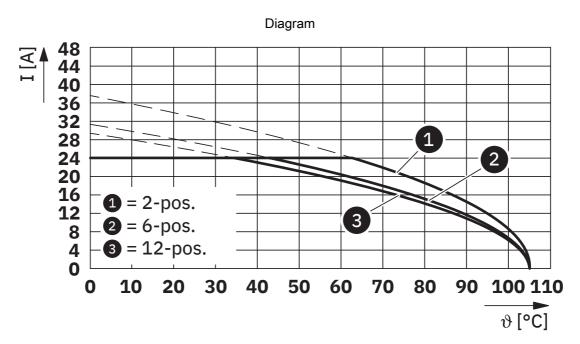


Type: SPC 4/...-ST-6,35 with PCV 4/...-G-6,35 P... THR
