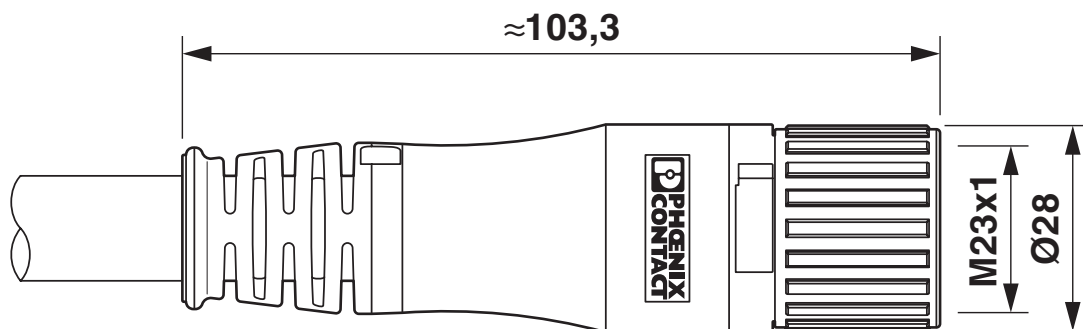

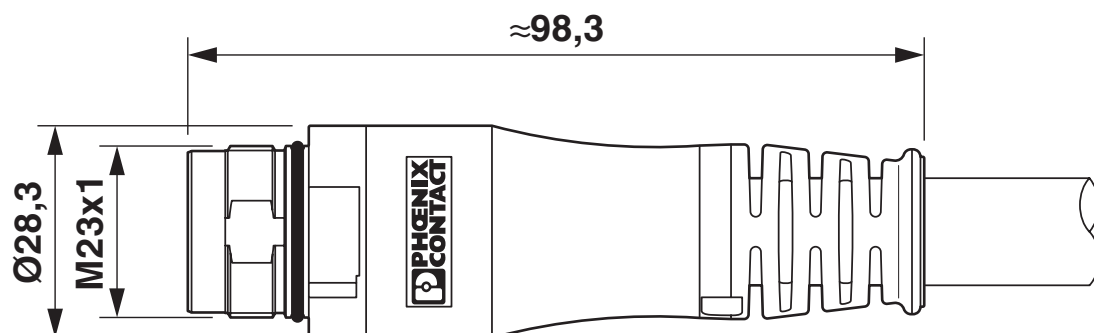

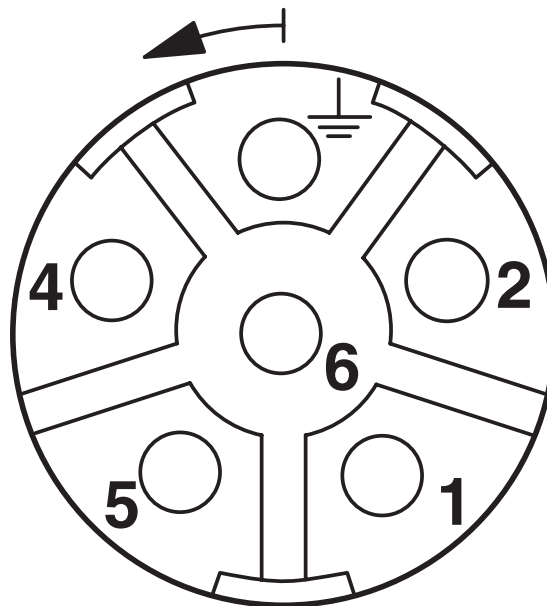
Pin side

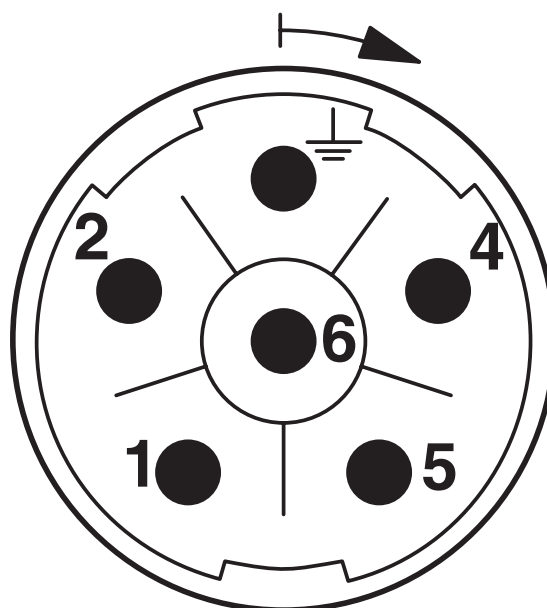

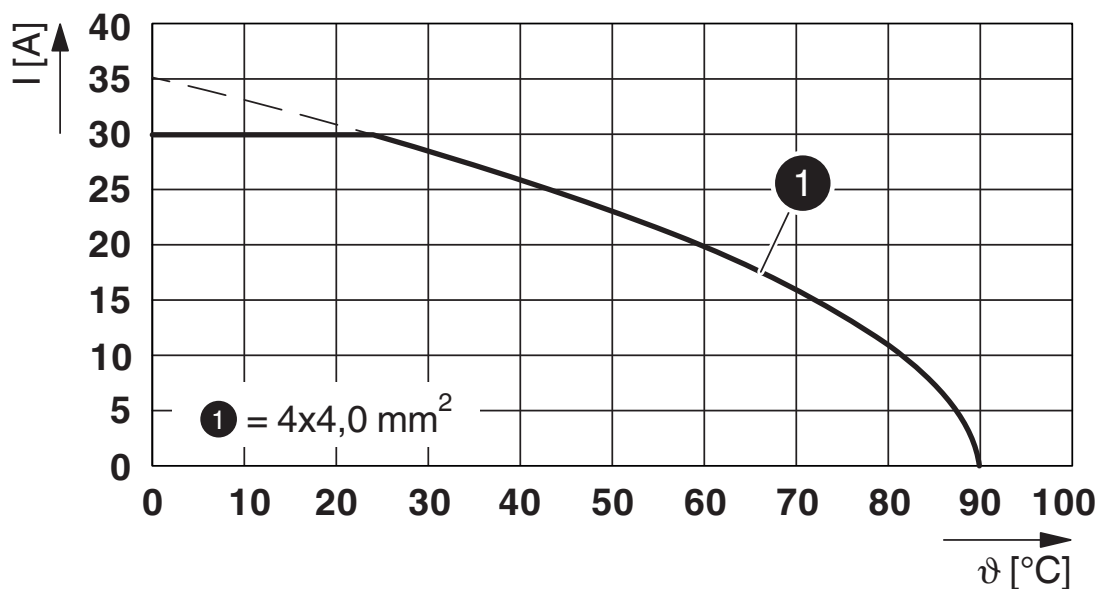

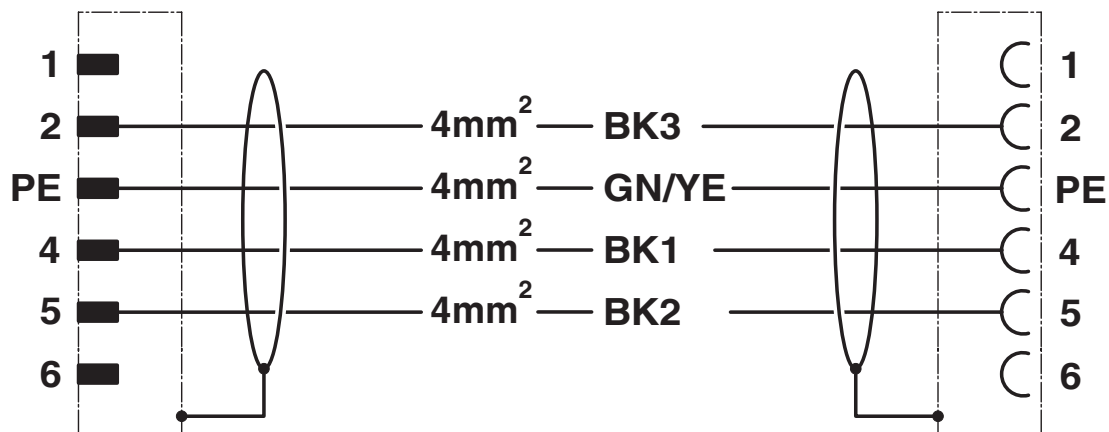
