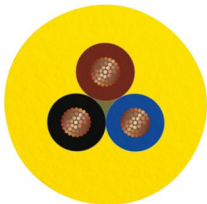

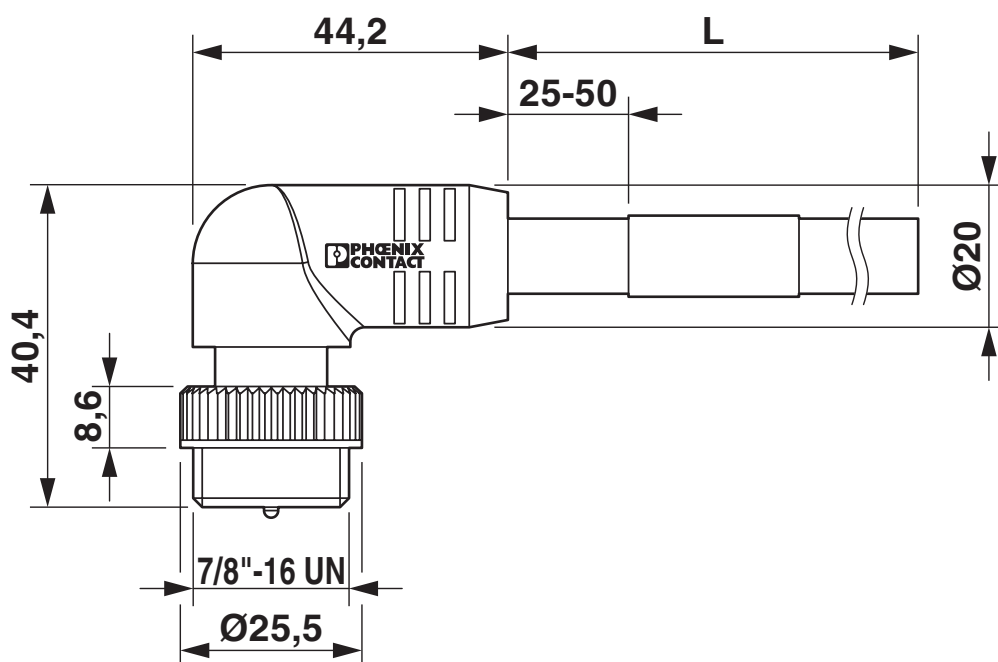

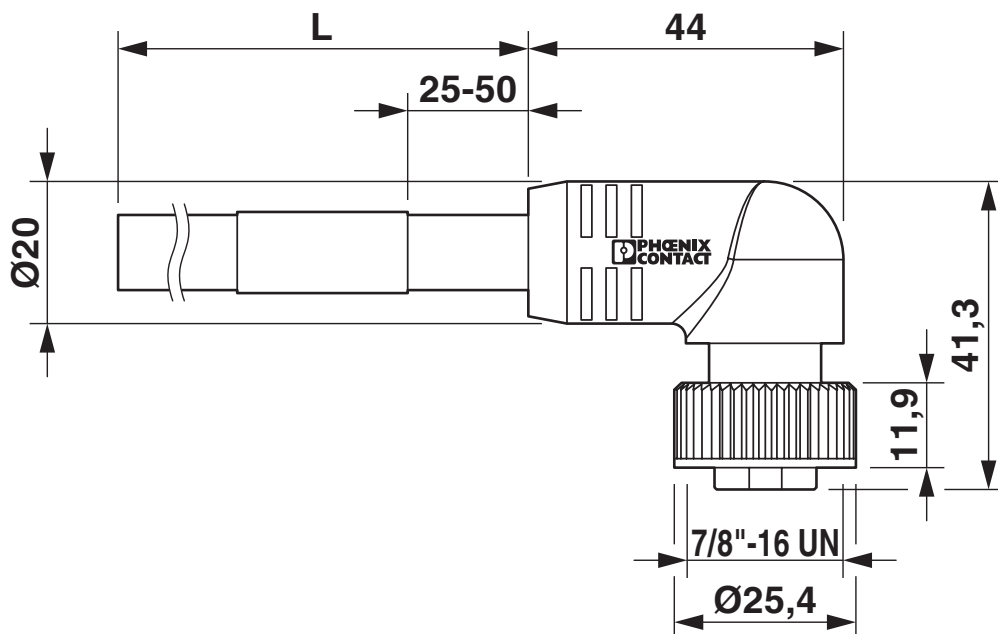

7/8"-16UNF socket, angled

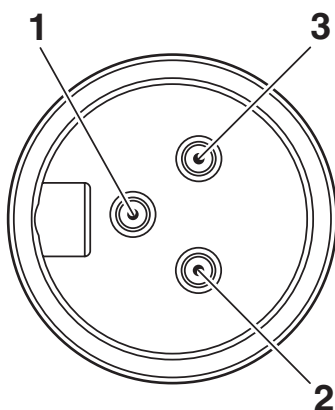

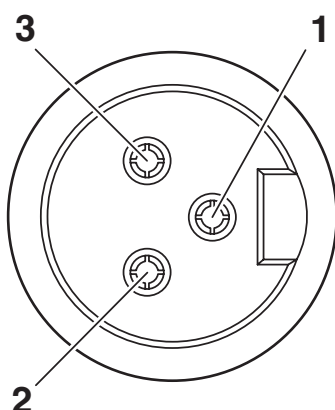


Schematic diagram



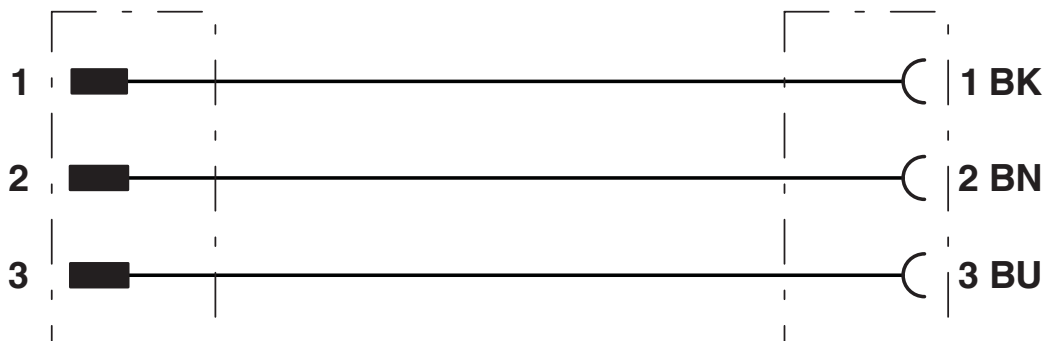
Pin assignment, plug, 7/8"-16UNF, 3-pos., view of male side
