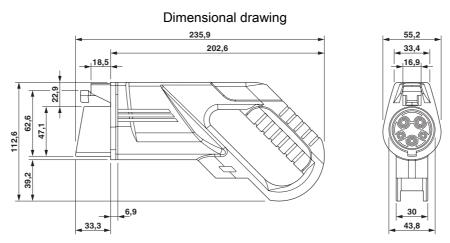

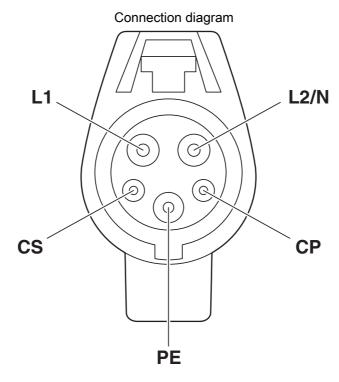

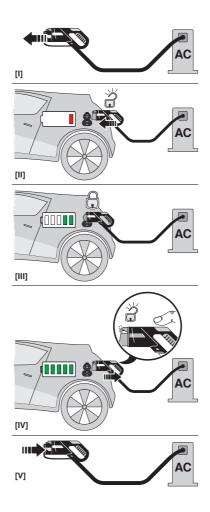
Pin assignment of the Vehicle Connector
