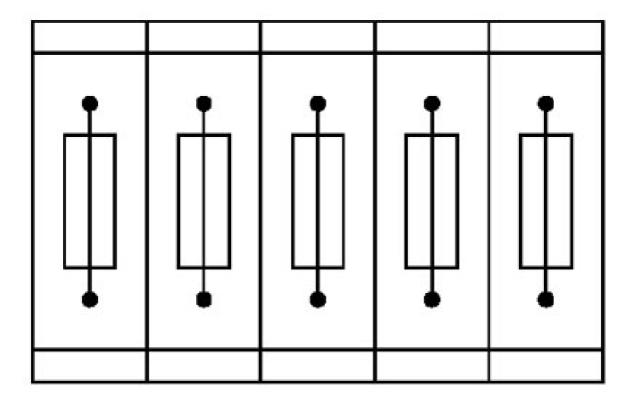

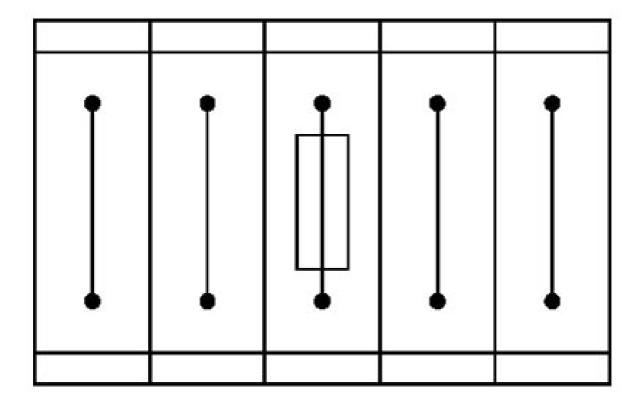
Fuse terminal blocks in interconnected arrangement, block consisting of 5 fuse terminal blocks

### Application drawing




Fuse terminal block in single arrangement, block consisting of one fuse terminal block and 4 feed-through terminal blocks
