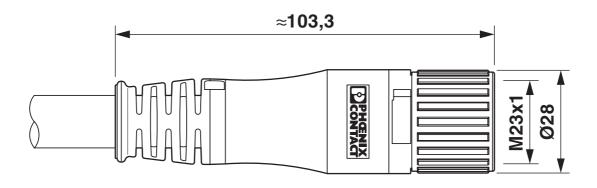




Pin side



Schematic diagram




Pin assignment of pin


