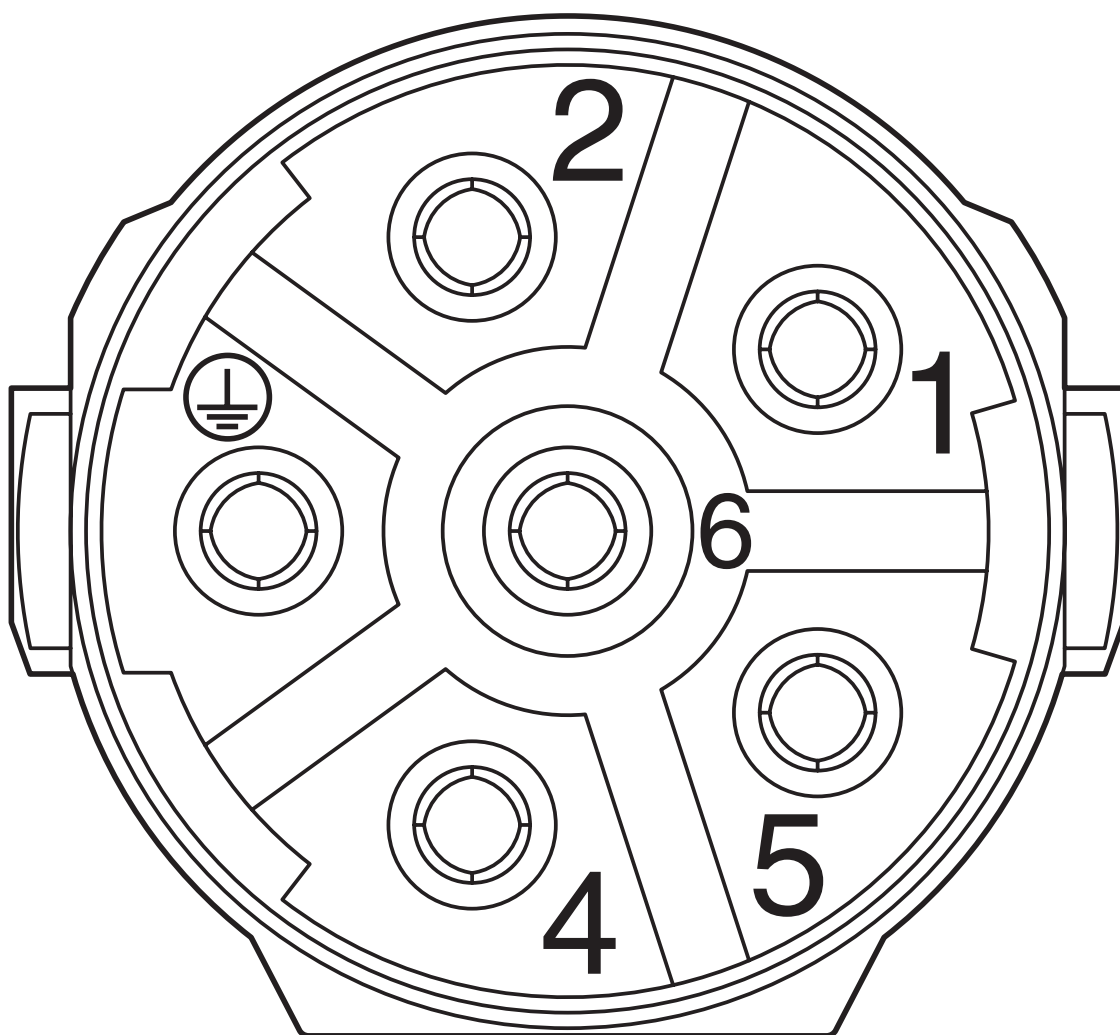

Schematic diagram



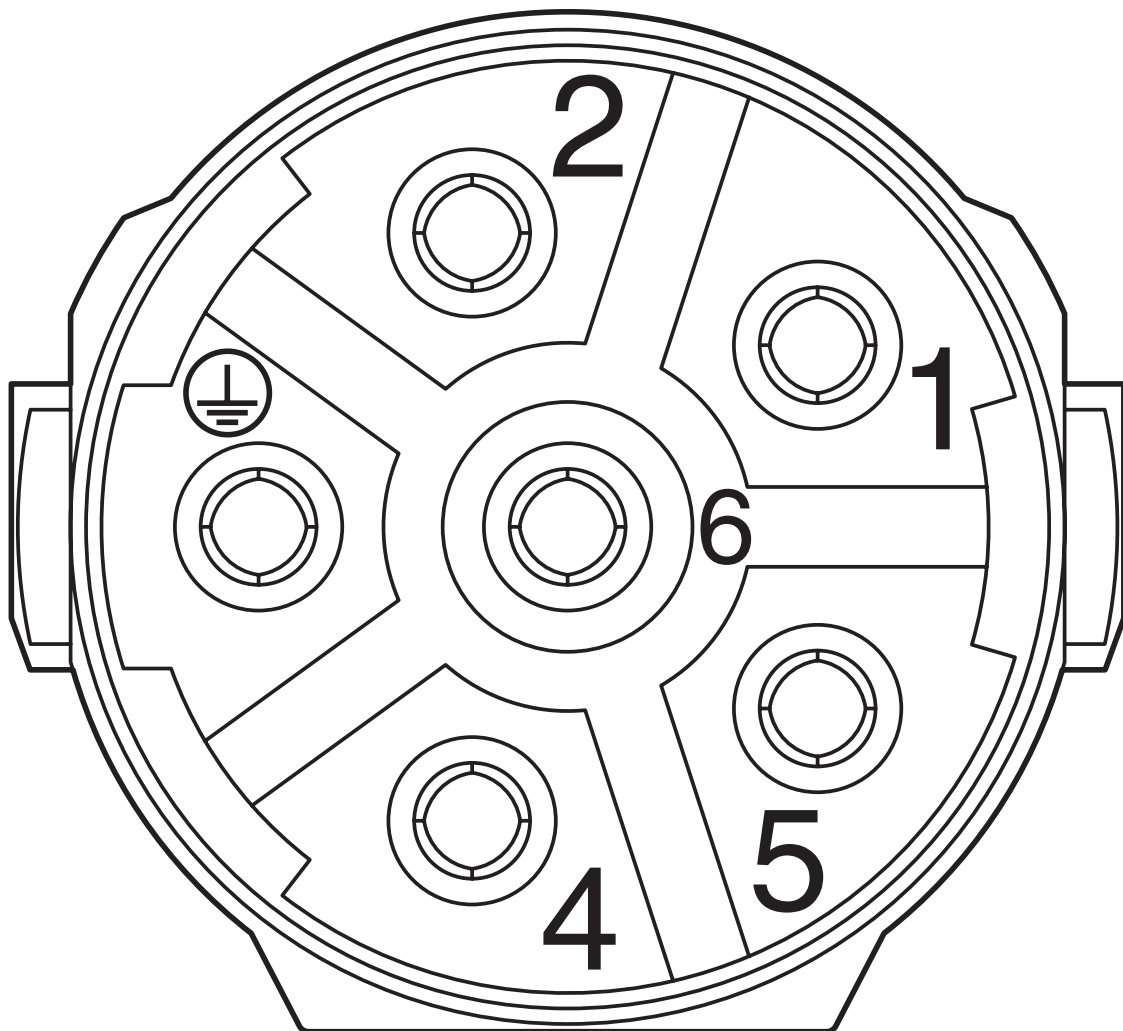

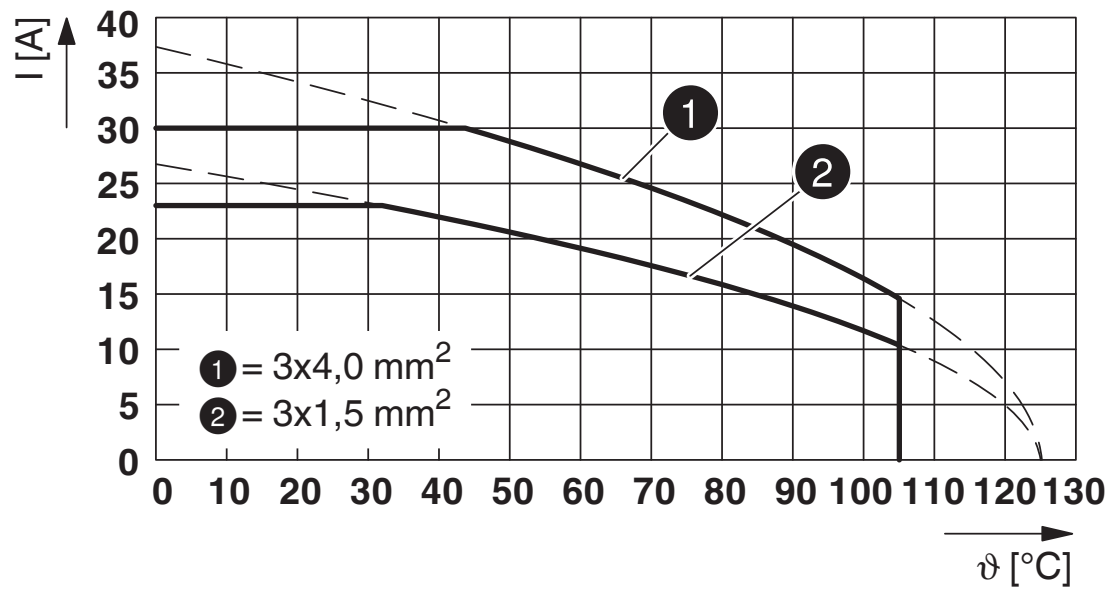
