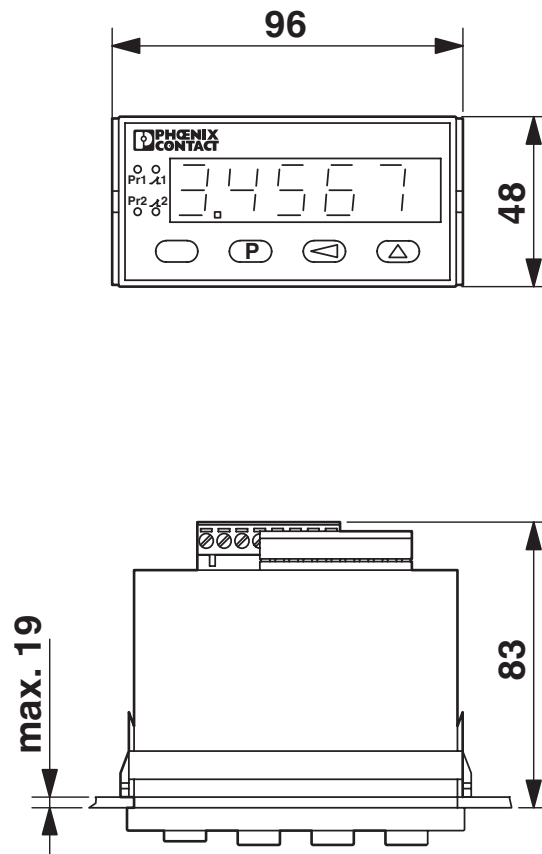

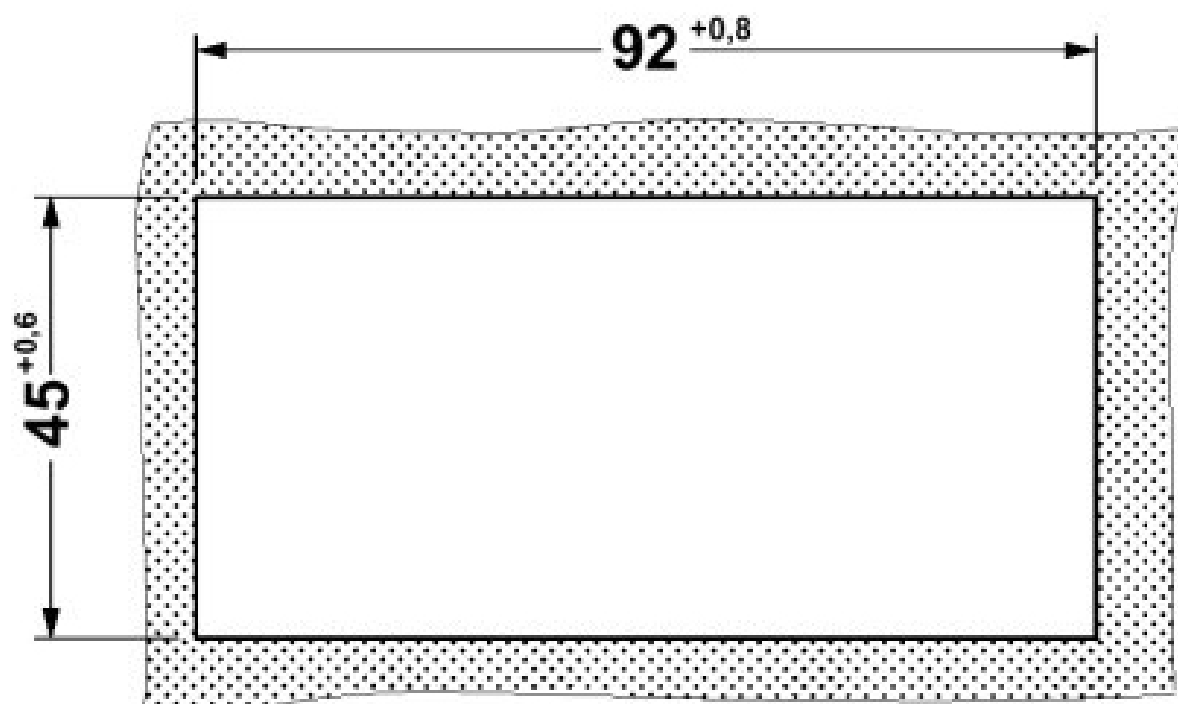

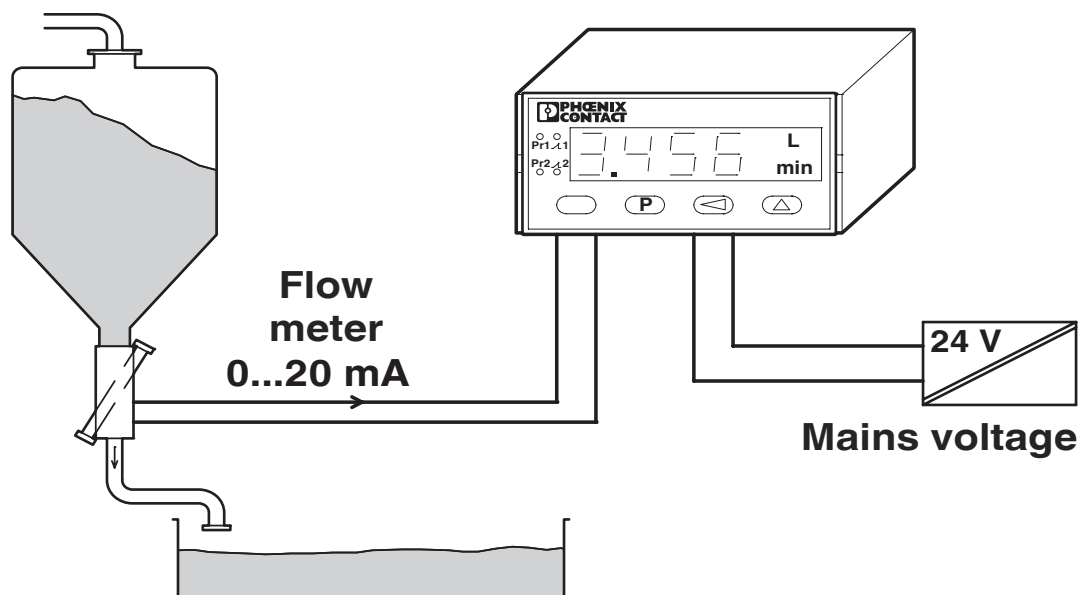

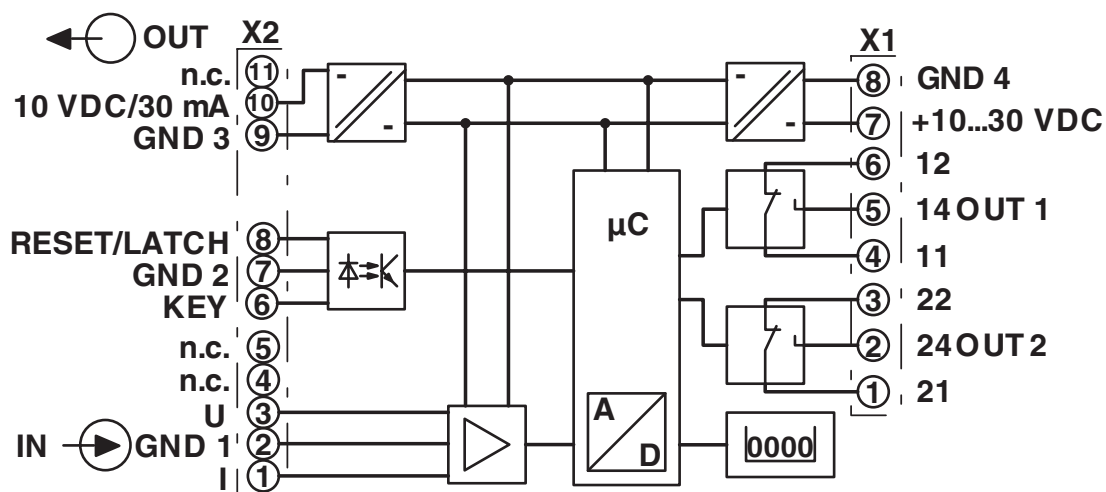


Application drawing
