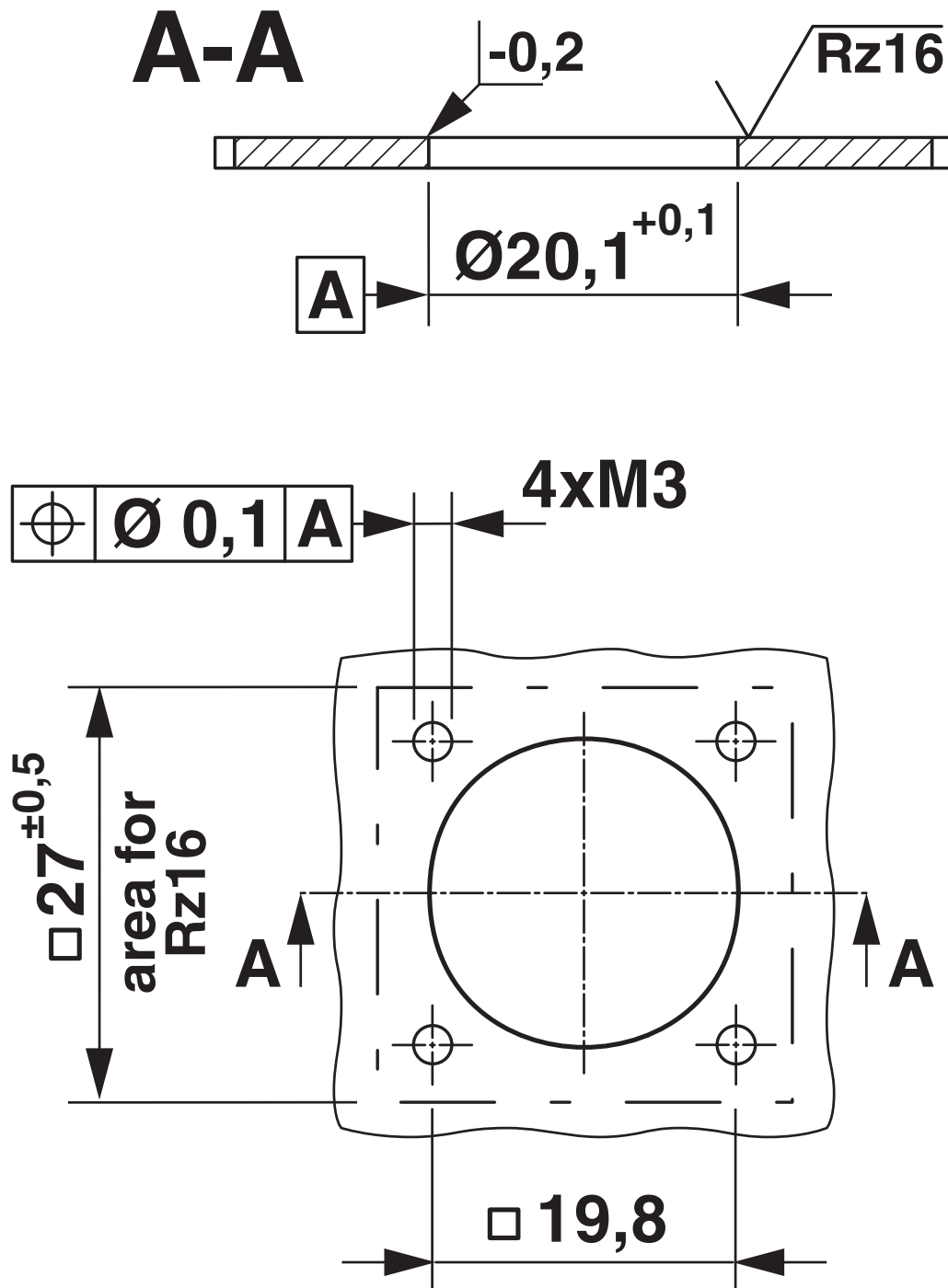

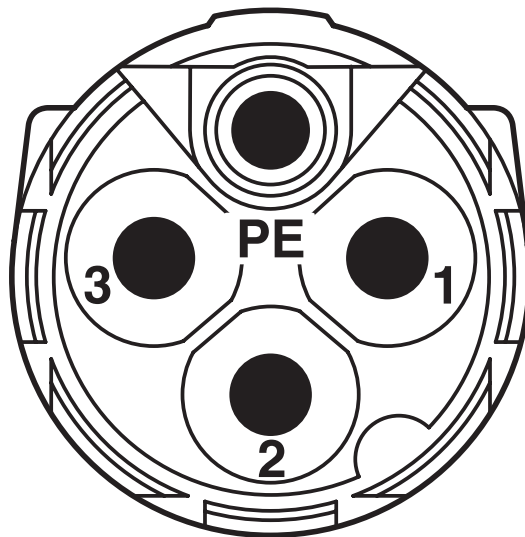
Installation dimensions

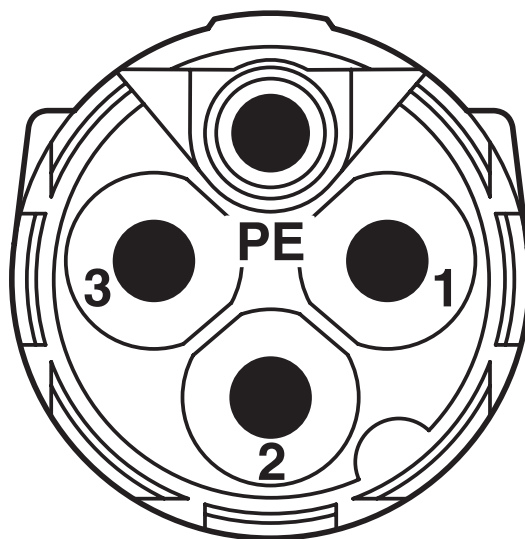

Schematic diagram



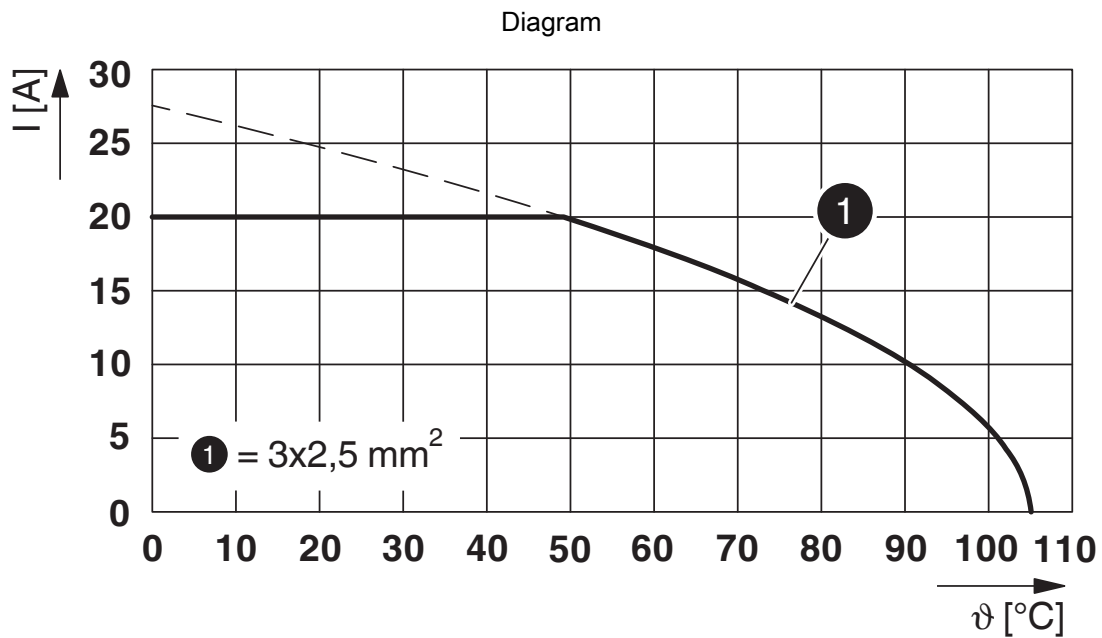
