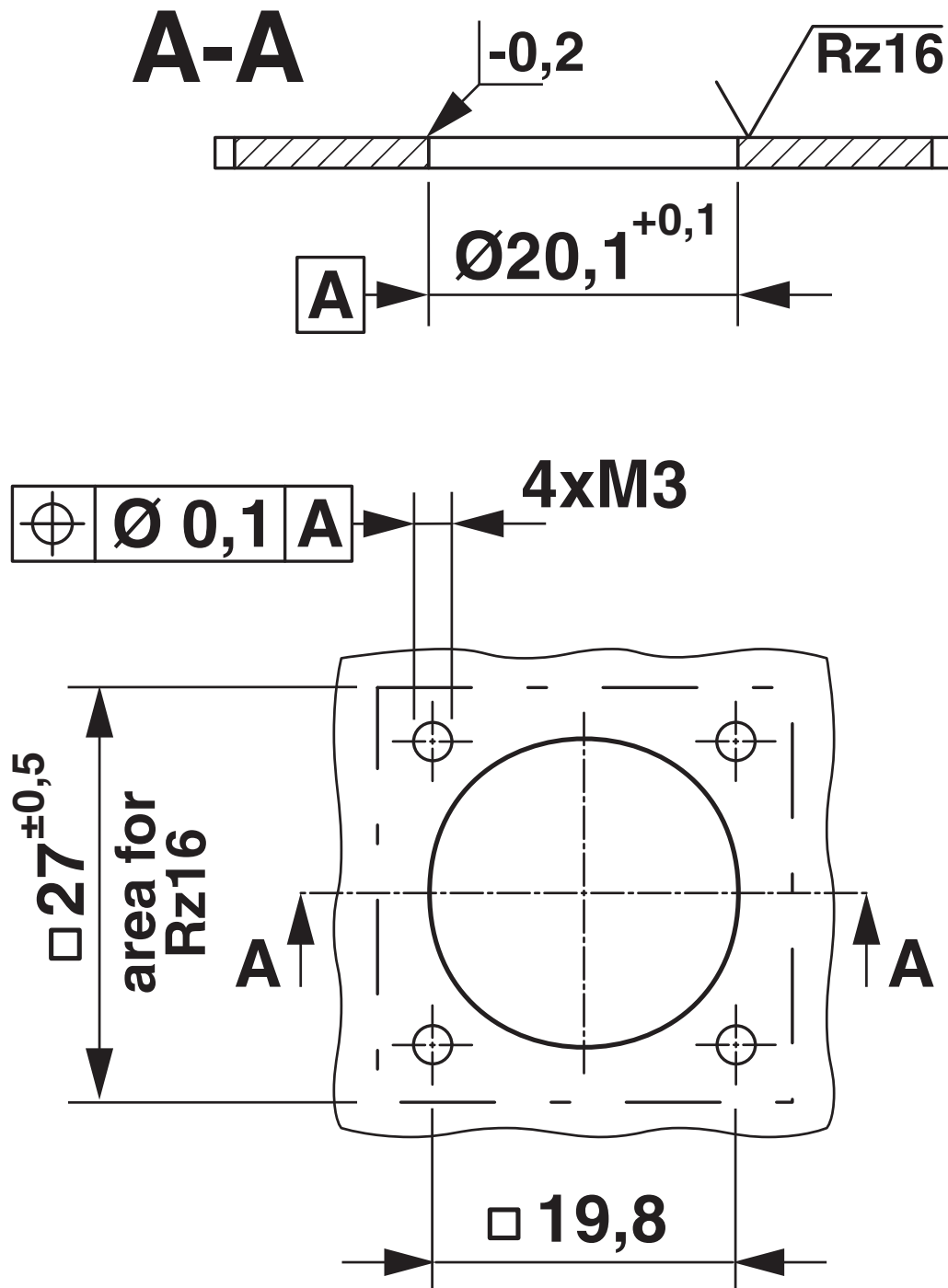

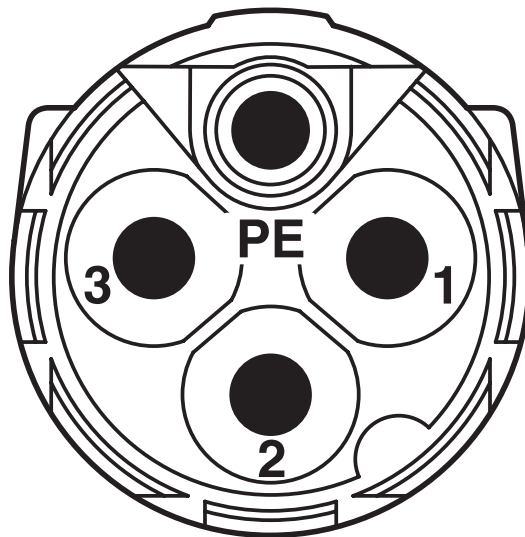

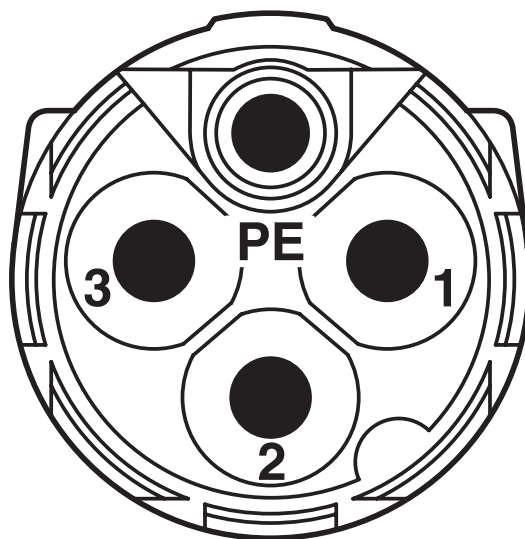

Schematic diagram



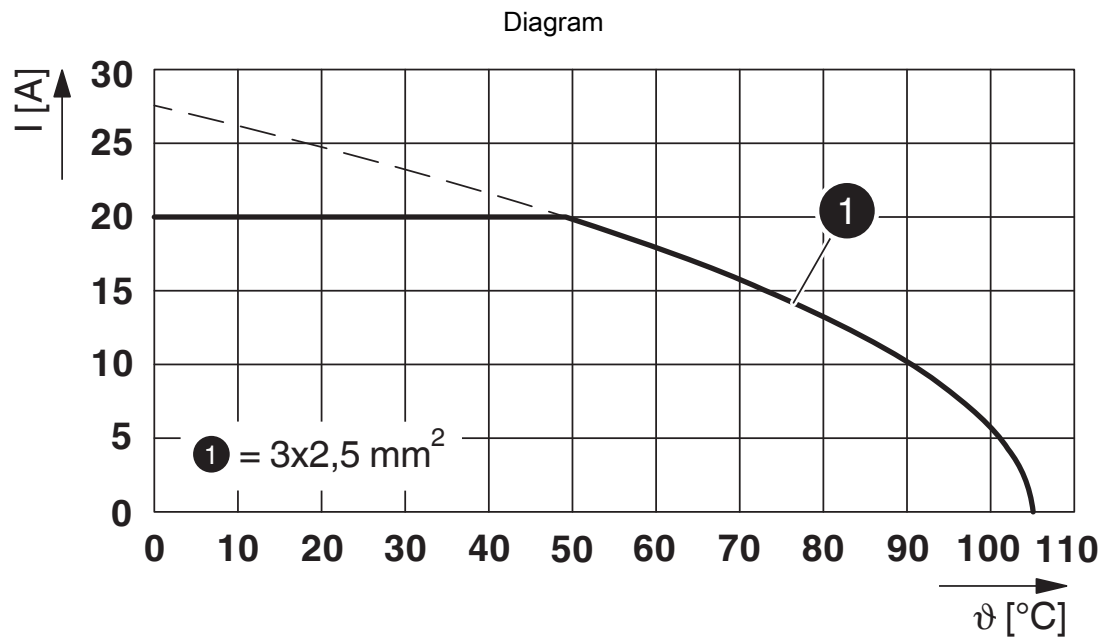
