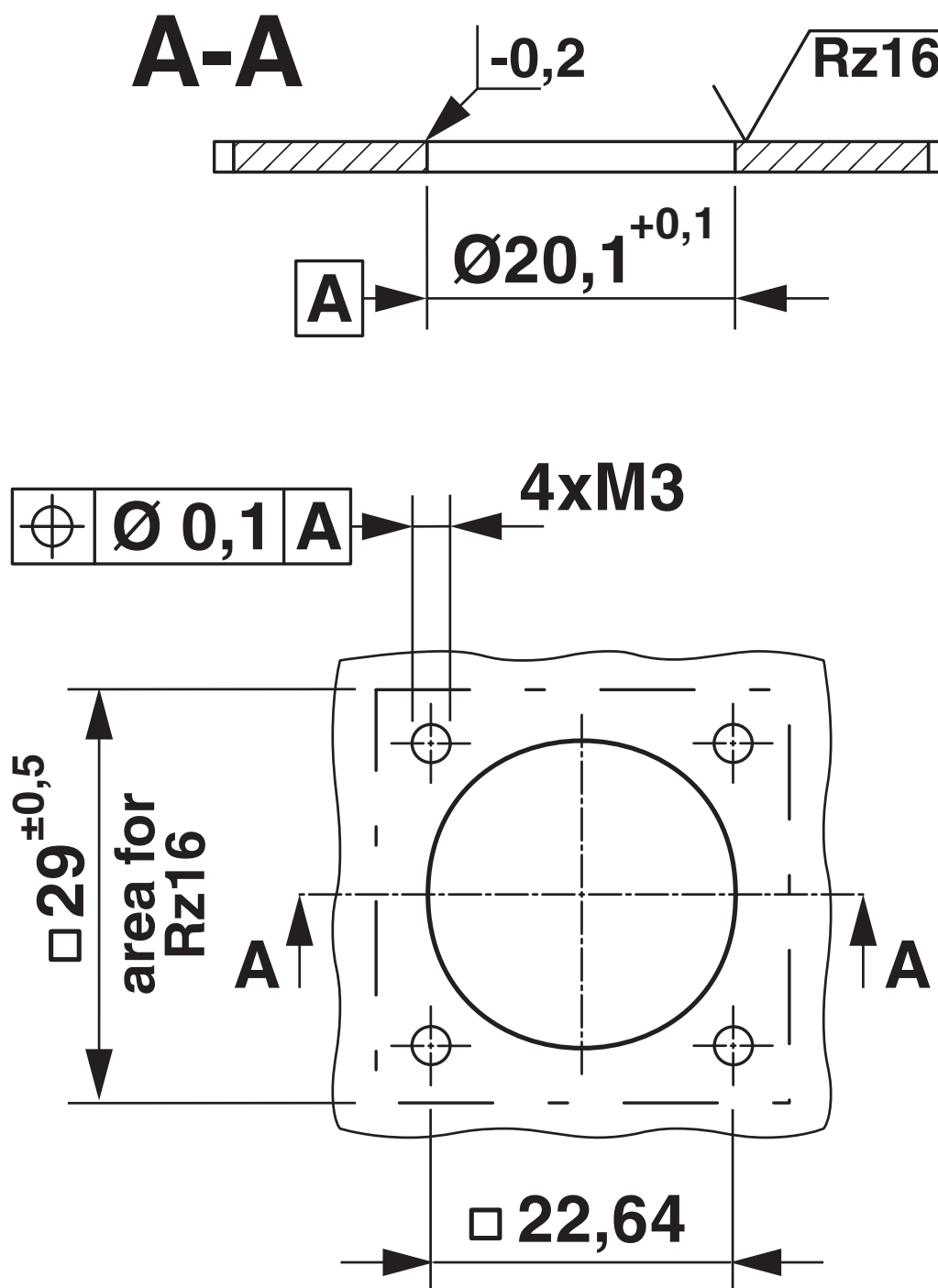

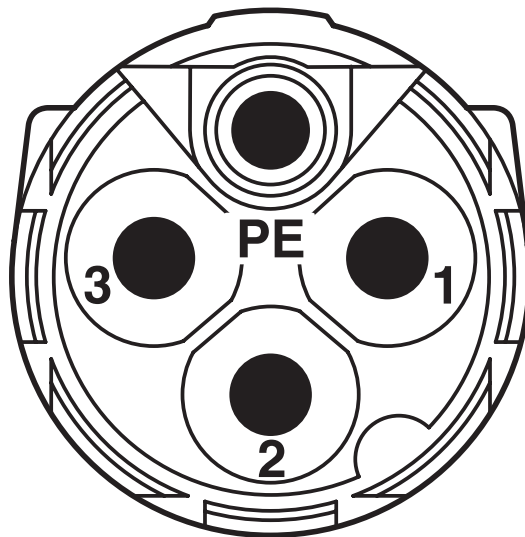

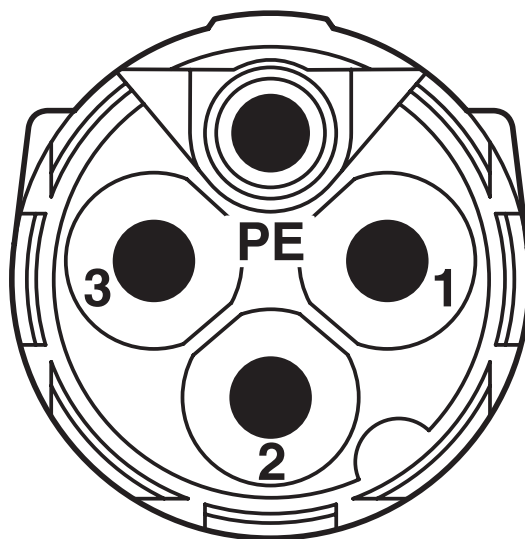

Schematic diagram

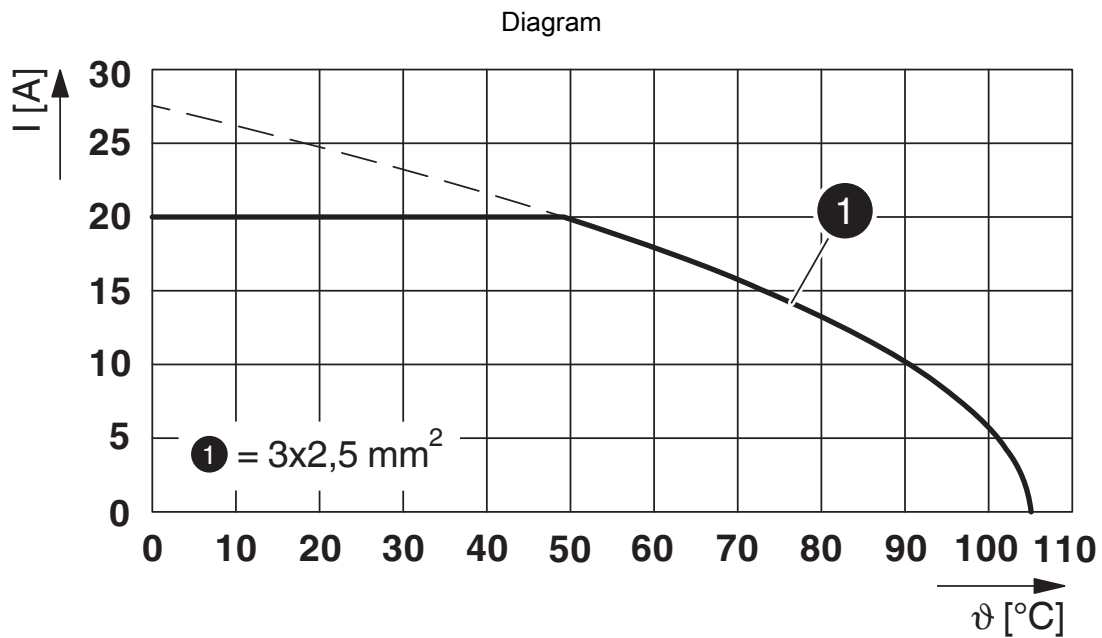
