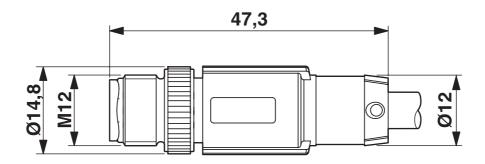






M12 x 1 socket, straight, shielded



Pin assignment M12 male connector, 4-pos., D-coded, male side




Pin assignment M12 socket, 4-pos., D-coded, female side
