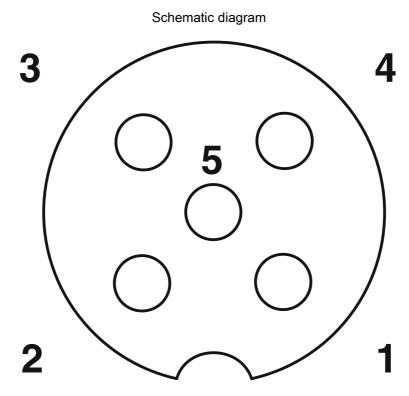



Pin assignment M12 socket, 5-pos., A-coded, socket side view



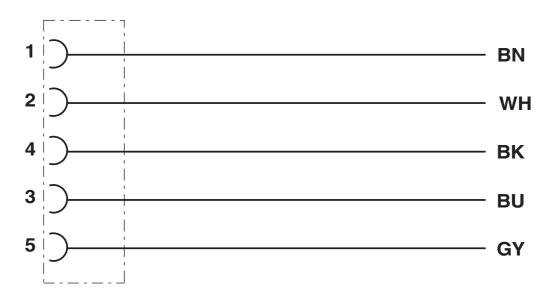
I = current strength, T = ambient temperature
