That is why the terminal blocks must be supported during conductor connection (held with one hand, support on the housing).

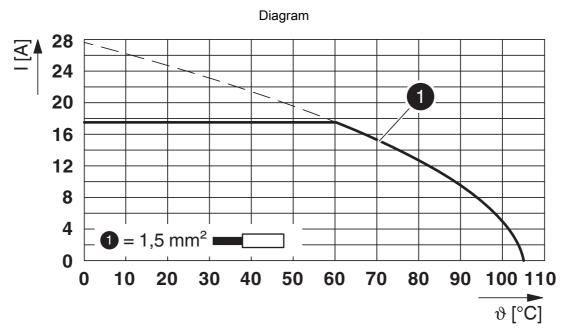
