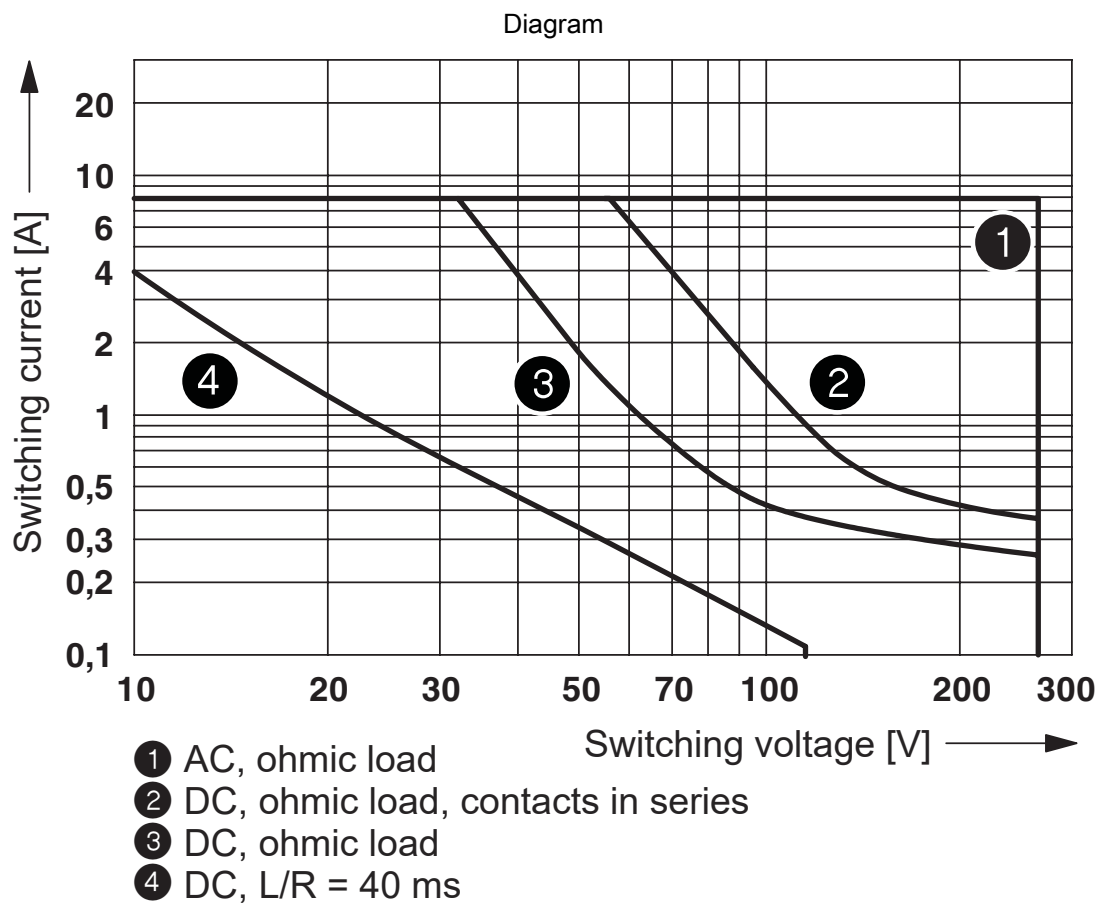

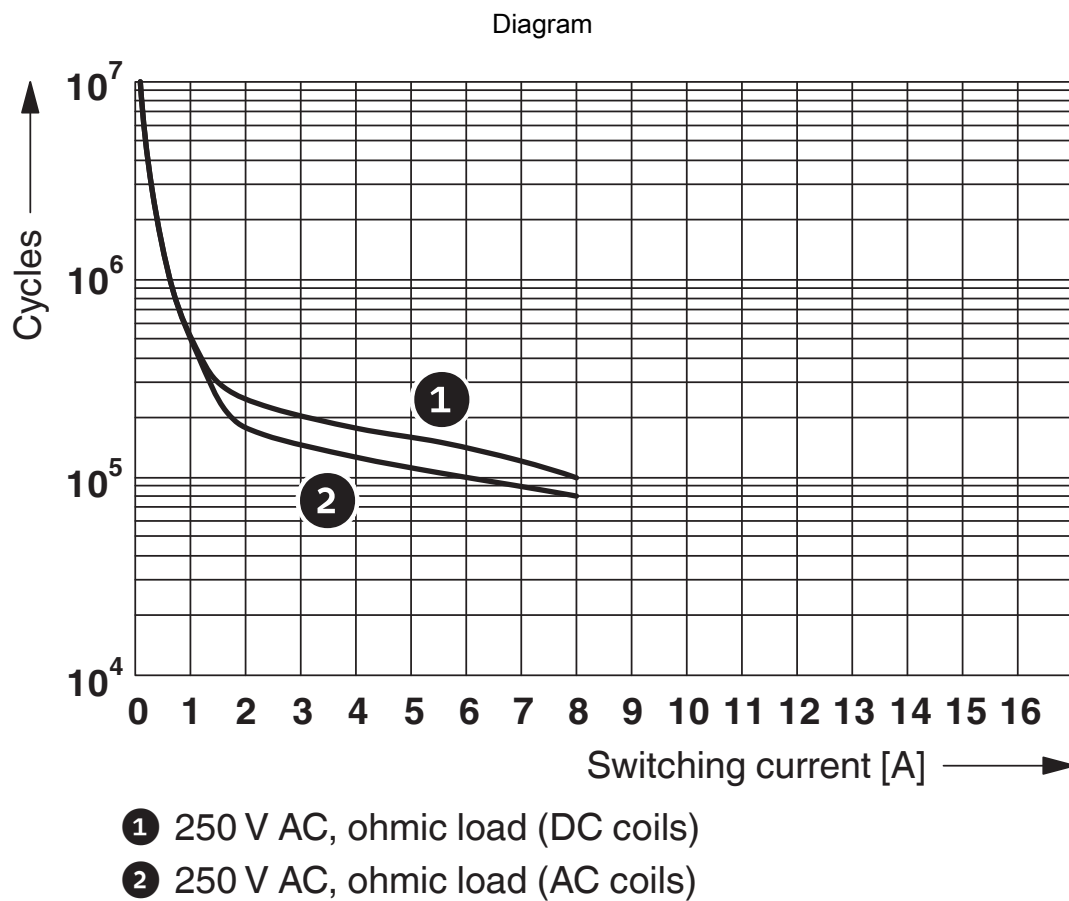

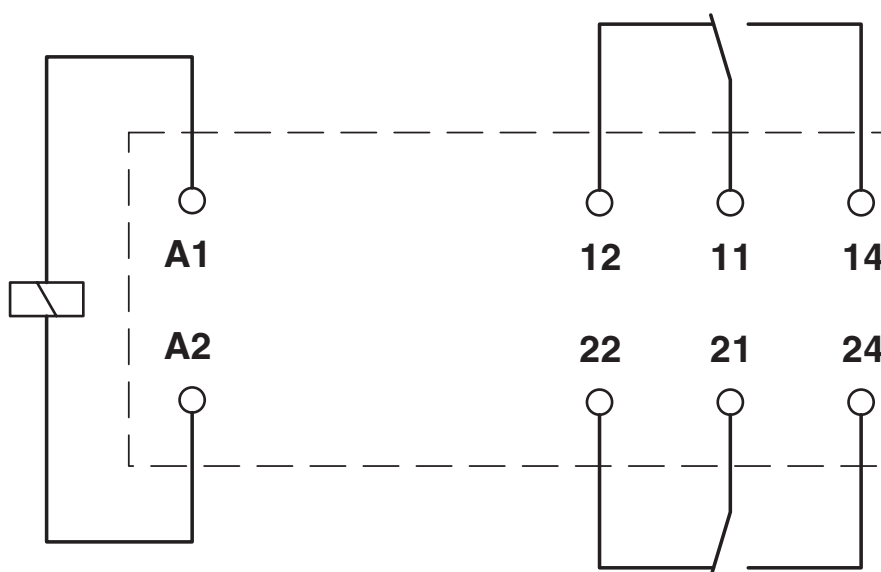

Circuit diagram



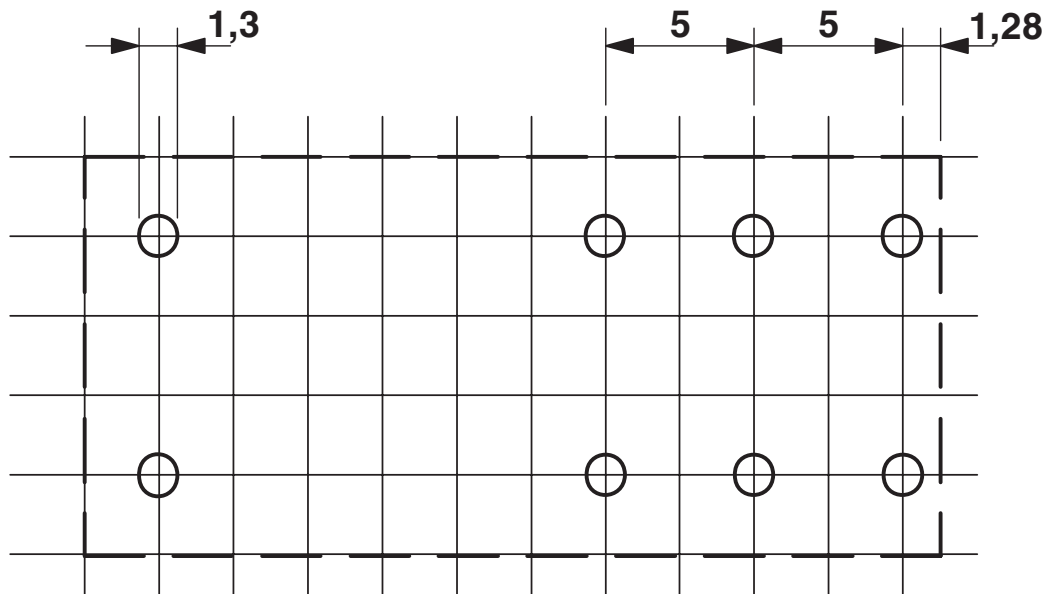
