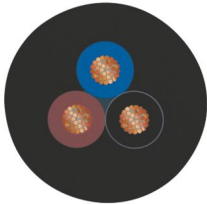

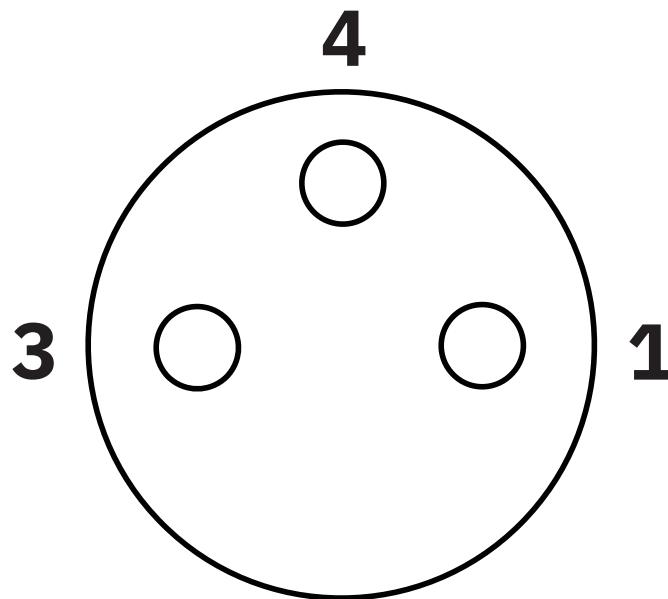

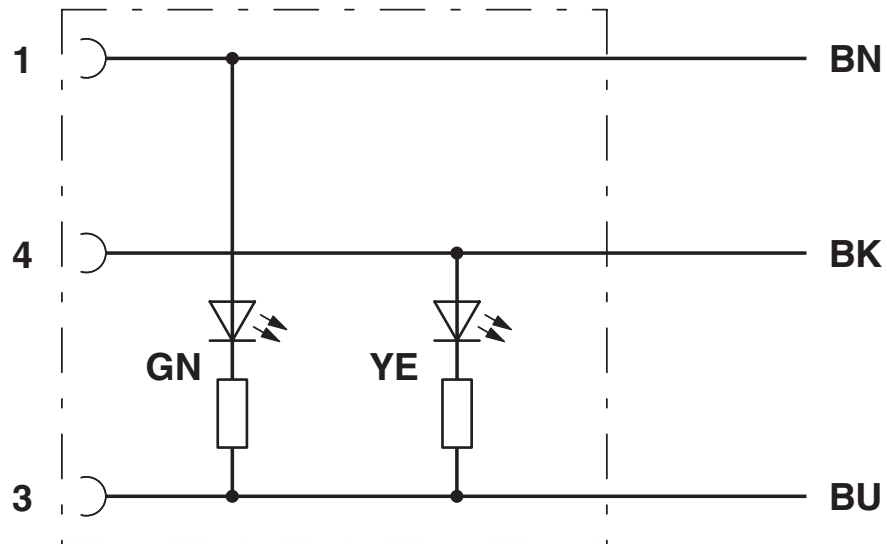
Socket M8 x 1, angled, with LED
