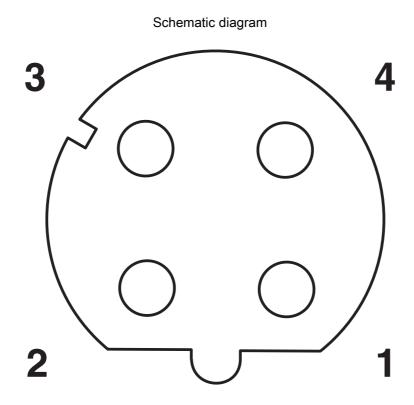



Pin assignment M12 socket, 4-pos., D-coded, female side




I = current strength, T = ambient temperature
