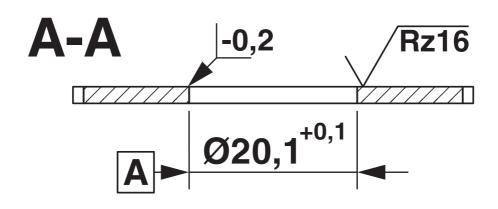





Installation dimensions



Schematic diagram


