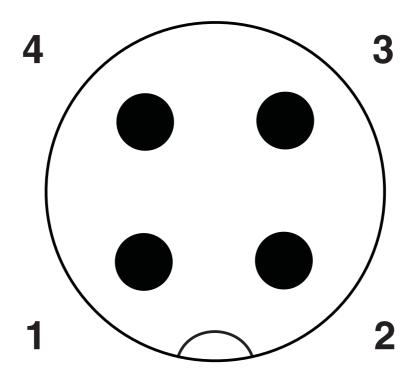

Schematic diagram

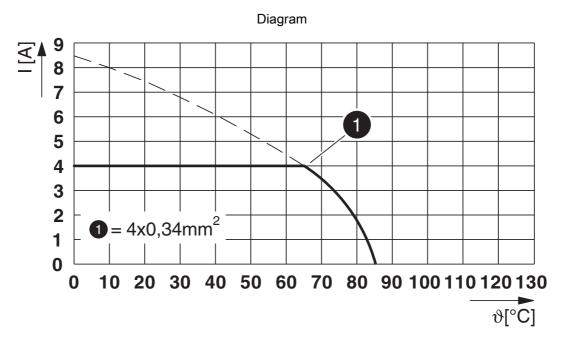


Pin assignment of M12 male connector, 4-pos., A-coded, view of connector side




