

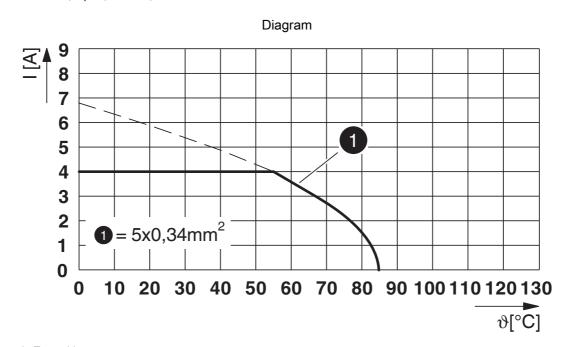

Pin assignment M12 socket, 5-pos., B-coded, female side




I = current strength, T = ambient temperature
