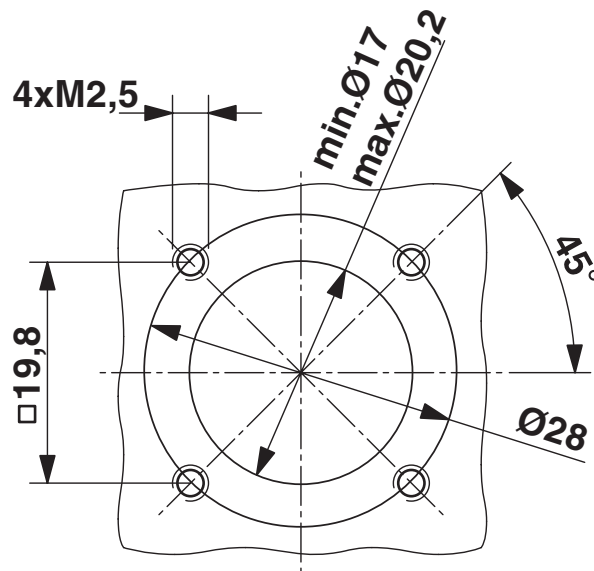

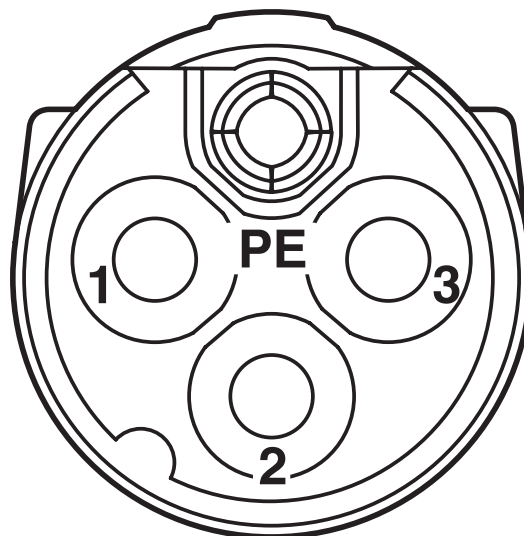

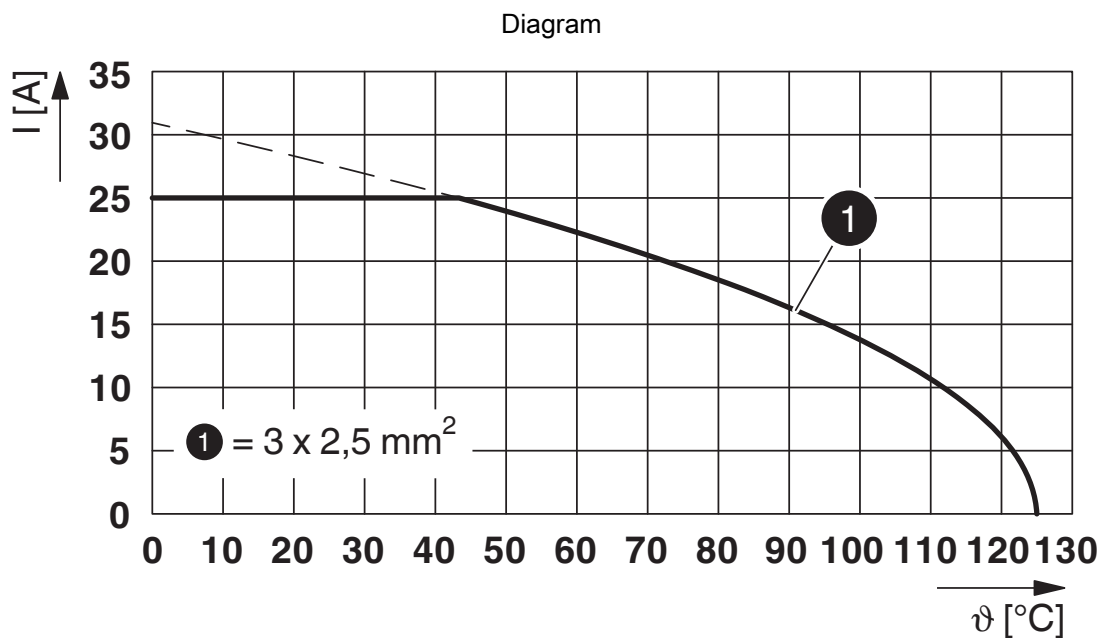


Housing bore holes
