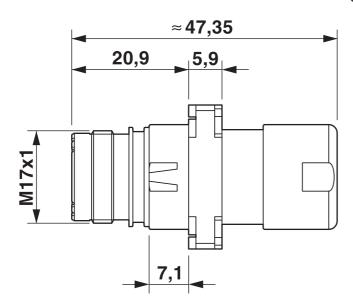


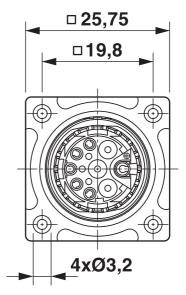

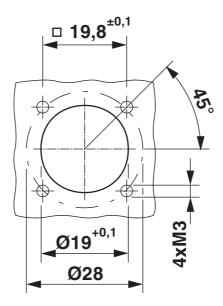

Schematic diagram



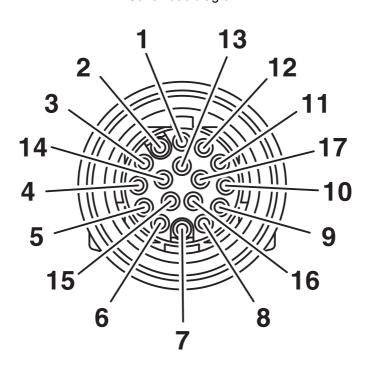
Installation dimensions



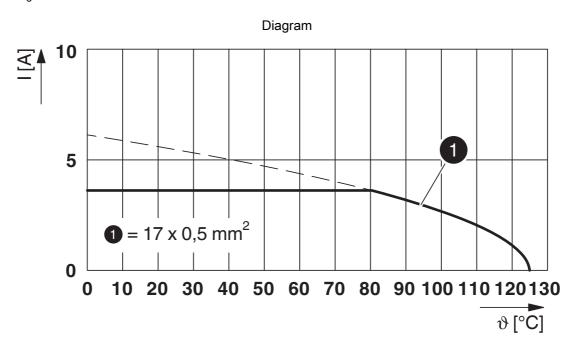
