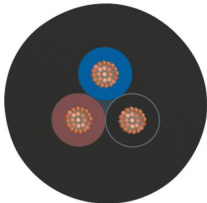

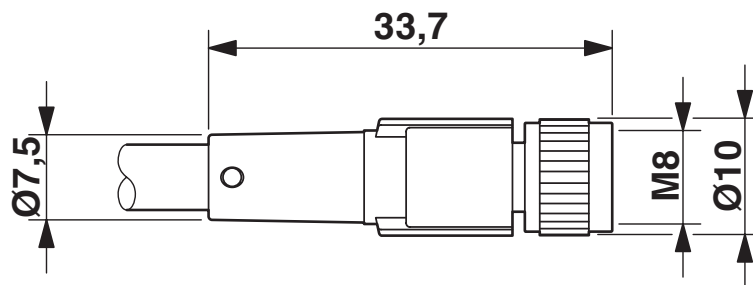

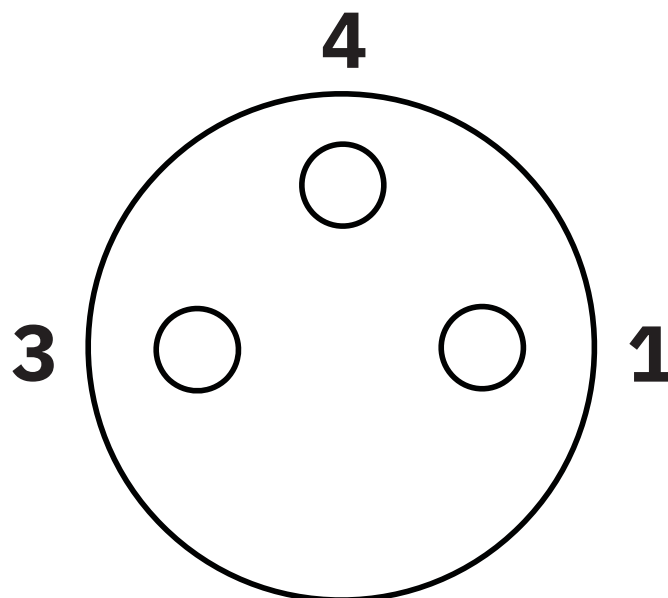

Pin assignment M8 socket, 3-pos., view female side

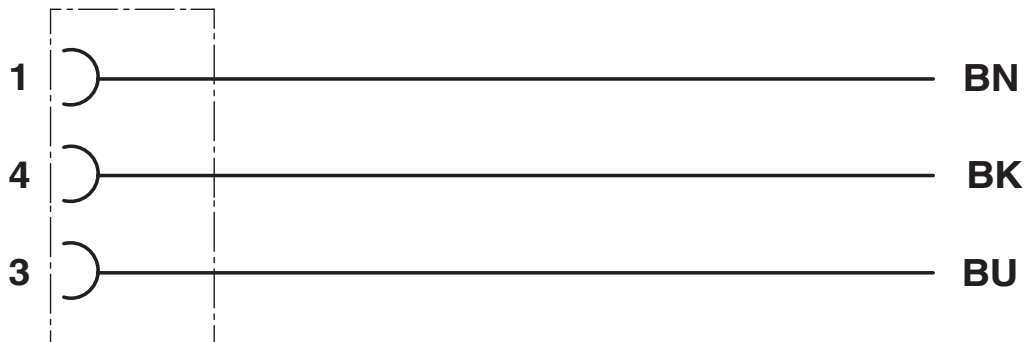
